Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. 7. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. 1. All Provisions of Drugs and Cosmetics Act, 1940 and Rules (including Medical Device Rule 2017) made there under and all subsequent amendments till date will always be applicable. This will include all notifications issued by Central Drugs Standard Control Organization (CDSCO), Ministry of Health & Family Welfare (MoHFW) and Department of Pharmaceuticals (DOP), Ministry of Chemicals & Fertilizers in this regard.
2. The seller's registration and product upload on GeM is based on their declaration of possessing a valid Medical Device License for the product, certifications, test reports as per MDR (2017), latest amended. However, buyers must check, validate and verify the details at their end for all applicable licenses and certifications e.g., validity and authenticity/genuineness of medical device license (or registration), product certifications, manufacturer's certifications/ licenses, test reports at the time of supply.
3. In case of authorized resellers/distributors, it will be the legal and regulatory liability of the manufacturer to ensure that their resellers/distributors are operating in compliance with all relevant laws and regulations, and are licensed to sell the manufacturer's products, including verifying the validity and authenticity of license held by them.

Underpad may also be used in operation theaters as spreadsheet or bedcover to prevent leakage of body fluids.
- b) Flat pad with absorbent filler and waterproof backing, bleached elementary chlorine free designed to absorb bodily fluids resulting from incontinence, surgical procedure or other reason and to prevent soiling of bedding, furniture and medical equipment.
- c) The material used for manufacture of underpad shall not have harmful effect during normal use and shall be comfortable for the user. The underpads shall mainly constitute of:
 - a) top cover or the top sheet;
 - b) absorbent core;
 - c) outer protective barrier or back sheet; and
 - d) adhesive
- d) **Top cover/Top sheet:** The top cover/top sheet is the material which comes under skin contact during use and allows liquid to pass through. It shall cover the absorbent filler completely and prevent the filler from reaching the user skin or his/her clothes under normal handling. The top sheet shall be of good quality hydrophilic nonwoven/woven fabric or any other suitable materials with sufficient porosity to permit the assembled pad to meet the absorbency requirements.
- e) **Absorbent Core:** An absorbent core forming the middle layer(s) with filler materials, such as cellulose pulp, tissue, wood pulp, other absorbent and super absorbent materials or combination of these materials, etc. The absorbent core shall have good ability to absorb the liquid, and formed into suitable shape rectangular or square and must be free from lumps, oil spots, dirt or foreign material. It shall be arranged in a manner that will speed up the liquid absorption and helps in avoiding the bed to get wet.
- f) **Outer Protective Barrier or Back Sheet:** The barrier shall be made from suitable material that is not prohibited for use for the purpose under any applicable law/regulation in force. It shall not allow the passage of absorbed fluid through it, thus preventing liquid leakage out of the underpad.
- g) **Adhesive:** The construction of the underpads shall be done using different kinds of hot melt adhesive or any other method of suitable quality for fixation of the various components of the underpad.
- h) **Workmanship And Finish:** The absorbent filler of the underpad shall be arranged and neatly cut to the required size and shape without any wrinkles and distortion. The material used for underpad shall be free from odour, harmful dyes, lotions, fragrance and all sorts of foreign material. The underpad shall have sealed edges to prevent leakage.
- i) The pH of the underpad shall be between 6.0 to 8.0 when tested by the method given in IS 1390.
- j) **Hygiene Testing Requirement:** Total viable count (total number of bacteria and fungi) shall not be

- more than 1,000 cfu/gm and Staphylococcus aureus shall be absent.
- k) The underpad shall be manufactured under good hygienic conditions.
 - l) For cytotoxicity, the material shall show reactivity as “None” when tested as per IS/ISO 10995. Similarly, the material shall be “Non-irritant and Non-sensitizer” when tested as per IS/ISO 10993.
 - m) Each pack of the underpads shall be legibly and indelibly marked with following information:
 - a) Name of the product;
 - b) Dimension/size of the product;
 - c) Manufacturer’s name, initials or trademark, if any;
 - d) Month and year of manufacture, batch/lot number;
 - e) An indication that the product has been specified by the manufacturer for single-use only;
 - f) Instruction for safe disposal for single-use product;
 - g) Country of origin;
 - h) Any other requirement as per Medical Device Rules 2017 or as required by the law in force or as agreed between the buyer and the seller.
 - i) The underpad shall be packed securely so as to allow normal handling and transport without tearing and exposing the contents. Packaging of the product shall be, such as to maintain the integrity of the product throughout its shelf life.
 - j) Required product certifications: IS 17786:2022/CE/USFDA
 - k) ISO 9001:2015 for Quality Management Systems and ISO 13485:2016 for Medical Devices
 - l) All bidders are required to submit a duly signed undertaking or self-declaration as part of their bid, explicitly confirming full compliance with the technical specifications outlined under Serial Numbers 01 to 08 of the tender document.
