The bidder seeking Relaxation from Experience Criteria, shall upload the supporting documents to prove his eligibility for Relaxation.
2. If the bidder is a Micro or Small Enterprise (MSE) as per latest orders issued by Ministry of MSME, the bidder shall be relaxed from the eligibility criteria of "Bidder Turnover" as defined above subject to meeting of quality and technical specifications. Benefits of MSE will be allowed only if the credentials of the service provider are validated on-line in GeM profile as well as validated and approved by the Buyer after evaluation of submitted documents.
6. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

1.The Integrity Pact Agreement shall be executed on a ₹100/- non-judicial stamp paper, duly signed by the bidder with the company seal and the signatures of two witnesses (including their names & address). The original hard copy of the Integrity Pact shall be sent to the Chief Administrative Officer, All India Institute of Speech and Hearing, Mysuru - 570006 and must reach within 07 days from the date of bid opening.

Integrity Pact agreement is a mandatory document. Bidders must upload the duly signed IP agreement in the GeM portal and also submit the hard copy to this office. The format of the IP agreement cannot be altered or modified by the bidders; however, they may include essential details such as the title of the bid, GeM Bid No., etc. Any other deviation or non-compliance identified by this office will result in summary rejection of the bid.

2. The total quantity of food is tentatively mentioned. However, at the time of issuing of contract order, actual quantity will be mentioned. Accordingly, the bills will be processed (based on the actuals).

4.The supply shall be executed and delivered at AIISH, Mysore, on 24th FEB 2026 & 25th FEB 2026. (Morning Breakfast @08:00AM, Morning Snacks @ 9.30 am., Afternoon Lunch @12.30PM, Evening Snacks @ 02.30 PM)

5.Food to be served in ceramic plates, steel spoons and paper cups for 75 participants

6. Eco friendly cups, plates and spoons to be provided for refreshments.

7. Coffee and tea have to be served in 01 counter.

8. Lunch has to be served in 03 counters.

9. Caterer is responsible for clean up and disposal of trash and equipment's.

10. In case, if there is any deficiency in supply date, time, quality, quantity and service by the caterer penalty will be levied @ 0.5% of the Purchase order for each day of delay or part thereof up to a maximum of 10% of PO value.

11. Advance/ Interim payments will not be made and Bill shall be submitted exactly as per purchase order.
12. No additional transportation /packaging/unloading charges will be applicable
13. Firm shall arrange for men and material required for the execution of the Purchase order.
14. All the suppliers must use head cap, mask, gloves while supplying the food.

8. **Generic**

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 50 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 50 percent. Bidders are bound to accept the revised quantity or duration.

अस्वीकरण/Disclaimer

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
16. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
17. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
