If the bidder is a Micro or Small Enterprise (MSE) as per latest orders issued by Ministry of MSME, the bidder shall be relaxed from the eligibility criteria of "Bidder Turnover" as defined above subject to meeting of quality and technical specifications. If the bidder itself is MSE OEM of the offered products, it would be relaxed from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. 2. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
4. Years of Past Experience required: The bidder must have experience for number of years as indicated above in bid document (ending month of March prior to the bid opening) of providing similar type of services to any Central / State Govt Organization / PSU. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.
5. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the

bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price. The buyers are advised to refer to the [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if the credentials of the service provider are validated on-line in GeM profile as well as validated and approved by the Buyer after evaluation of submitted documents.

6. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price.

7. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

8. Past Experience of Similar Services: The bidder must have successfully executed/completed similar Services over the last three years i.e. the current financial year and the last three financial years(ending month of March prior to the bid opening): -

1. **Generic**

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

2. **Generic**

Option Clause: Excess Settlement. The excess settlement has been enabled for the service, allowing service providers to include additional charges up to a specified percentage of the item-level total value, including add-ons, in their invoices. Service providers must declare the applicability of additional charges during invoice creation and submit mandatory supporting documents to avail this option. The total invoice amount, including additional charges, shall not exceed the agreed-upon excess settlement percentage for the order.

3. **Generic**

Bidder financial standing: The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.

4. **Certificates**

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

8. Past Project Experience

In the event where the distance travelled exceeds the monthly usage variant, amount will be paid for additional Kms as per schedule. Similarly, the unused Kms in a particular month as against the minimum guaranteed usage variant will be carried forward to the next month and additional Km if any in the next month shall be adjusted against this. However, the payment for the selected usage variant in a month will be paid every month.” Further, the unused Kms in a particular month shall not be carried forward or adjusted beyond 6 months

12. Buyer Added Bid Specific Scope Of Work(SOW)

Text Clause(s)

1. The vehicle shall be a covered lorry having a hauling capacity of 5 tonne with a minimum platform length of 5 m (Five metre). However higher capacity truck also will be entertained, if the same can be offered in the rate of 5 tonne capaci

ty. (The capacity of the truck means the RAW specified by the manufacturer shall be minimum 5000 Kg).

2. Temporary roofing cover namely a 'dome' with wood/metal reinforcement/ frame covered with good quality tarpaulin cover at least should be provided in the vehicle to protect the staff from rains during travel. A tool box cum temporary seating arrangement in the rear platform at a length equal to the width of the platform shall also be provided in the truck. The temporary roofing cover will be removable type for transporting Over size material

3. The model of the vehicle shall be 2023 or latest of any reputed manufacturer. The vehicle shall be in good working condition and must be capable of working in difficult terrains including kutcha roads. The vehicle shall have nice interior finishing and certificates, viz. driver's license, RC book, Smoke emission certificate, Fitness certificate, Insurance and First Aid Box.

4. The section of Palakkad Division comprises of Kerala, Tamil Nadu and Karnataka areas. The vehicle should have PERMIT for Tamilnadu, Karnataka and Kerala as frequent movement are involved. The temporary permit cost towards Tamil Nadu and Karnataka to be borne by the Contractor.

5. The movement of the vehicle shall be reckoned only from SSE/Permanent way/Kollengode

6. The vehicle shall always be parked at the section or at a location as instructed by the section in-charge SSE/Pway/Kollengode. The engine switch key shall be kept at the location specified by the section in-charge when the driver or the contractor's representative leaving the railway premises for a period more than 30 minutes in day or night. No work other than those prescribed in schedule, no deviation and no extra quantity indicated in the schedule should be carried out by you without prior written approval of the DEN/EAST/PGT.

7. The normal working of the vehicle shall be from 9.00 hrs to 17.00 hrs in the normal working days. Occasionally, in emergency cases, the lorry shall be made available during night and other hours also. In some cases the vehicle may be required for 2 hours before 9.00 hours or after 17.00 hours or part thereof. In such cases the maximum working hours/ day will be limited to 8.00 Hrs including the allowance time for loading/unloading and this will be informed to the contractor in advance. No additional payment will be arranged for such working.

8. If the vehicle is not required for one day or more, prior intimation will be given before 48 hrs. Under such advance information, the vehicle shall not be brought for operation of the contract and no payment for the non operated days will be made even if the contractor is making available the vehicle.

9. Scope of work includes "Hire charges for diesel driven lorry capable for hauling 5 ton load for running round the clock (normally 8 Hrs per day ie. 9.00 hrs to 17.00 hrs) on all days including sundays and holidays up to 100 km per Day.

10. Note

a) Model of the vehicle shall be of 2023 or latest.

b) Payment will not be made for the days for which prior intimation has been given 48 Hrs in advance regarding non- requirement of lorry. The price shall cover

the hire charges for diesel driven lorry with a platform length of minimum 5 m and capable to run at 80 kmph and modified suitably with back cover, the cost of diesel, lubricating oil, spare parts and other required consumables, driver's salary, overtime allowance and other allowance if any, and all kinds of taxes (GST) and service charges etc, if applicable.

c) The unused Kms in a particular months as against the minimum guaranteed usage variant will be carried forward to the next month and additional Kms if any in the next month shall be adjusted against this. However, the payment for the selected usage variant in a month will be paid every month. Further the unused Kms in a particular month shall not be carried forward or adjusted beyond 6 months.

11. Driver can be called upon for any hour around the clock of any day including Sunday for going to any place pertaining to the jurisdiction of the consignee. If failing to do so will be treated as non deployment of vehicle and driver.

12. In case of non supply of Lorry as per demanded by Engineering supervisor a penalty of 3 times the cost of Lorry arrangement has done in such case via some other source by Engineering supervisor.

13. Driver catering the transportation service should not be changed frequently.

अस्वीकरण/Disclaimer

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1

bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.

16. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
17. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

जेम की सामान्य शर्तों के खंड 26 के संदर्भ में भारत के साथ भूमि सीमा साझा करने वाले देश के बिडर से खरीद पर प्रतिबंध के संबंध में भारत के साथ भूमि सीमा साझा करने वाले देश का कोई भी बिडर इस निविदा में बिड देने के लिए तभी पात्र होगा जब वह बिड देने वाला सक्षम प्राधिकारी के पास पंजीकृत हो। बिड में भाग लेते समय बिडर को इसका अनुपालन करना होगा और कोई भी गलत घोषणा किए जाने व इसका अनुपालन न करने पर अनुबंध को तत्काल समाप्त करने और कानून के अनुसार आगे की कानूनी कार्रवाई का आधार होगा।/In terms of GeM GTC clause 26 regarding Restrictions on procurement from a bidder of a country which shares a land border with India, any bidder from a country which shares a land border with India will be eligible to bid in this tender only if the bidder is registered with the Competent Authority. While participating in bid, Bidder has to undertake compliance of this and any false declaration and non-compliance of this would be a ground for immediate termination of the contract and further legal action in accordance with the laws.
