Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. 1.0 TENDER ELIGIBILITY CRITERIA:

[a] Purchase will be made only from those sources which are appearing as registered vendors with operative license from Bureau of Indian Standards (BIS) for **IS 8406** or latest as available on BIS website. Authorized agents/dealers of such OEMs shall also be eligible to participate subject to submission of certificate to that effect along with the offer. The status of the firm will be reckoned as on the date of bid opening. However, any downgrading of status till the placement of formal order shall be duly taken into account.

[b] The bidder with past performance of satisfactory execution of contracts to SC Railway/Other Zonal Railways/PUs/Central Govt/State Govt/PSUs for supply of the same/similar items for a quantity of 1 Barrel or more of the tendered quantity against a single contract during the last three years prior to and excluding the tender opening date shall be considered as responsive to SC Railways requirements for placement of bulk and regular order. bidders are requested to submit the past performance report such as Copies of R Notes/CRAC/proof of acceptance of material by consignee etc. along with their offer; failing which offer will be summarily rejected without making any back reference.

It may so happen that the agent/dealer has credentials of past supply for a different Principal/OEM, then it will not be considered as performance. For Authorised dealers, tender specific authorization from OEM has to be uploaded with bid.

(d) Only OEM or their authorised dealers are eligible to quote in this bid.

(e) The bidders must submit a certificate stating that all their statements/documents submitted along with the bid are true and factual. 4.0. Payment Terms: 100% payment will be made against receipt and acceptance of the material by the consignee.

5.0. Inspection: No deviation from the stipulated inspection clause shall be permitted. The inspection shall strictly be carried out by the designated inspection agency as per the prescribed norms.

Material to be supplied against manufacturers TC & GC.

6.0 Warranty : Unless otherwise specified in the bid document, attached specifications/terms/scope of supply etc., warranty shall be as per IRS condition of contract. Warranty period of the supplied products from the date of final acceptance of goods or after completion of installation, commissioning & testing of goods (if included in the scope of supply), at consignee location. OEM Warranty certificates must be submitted by the contractor at the time of delivery of Goods.

7.0 General Damages: The supplier fails to supply goods as per the conditions of the contract, as amended from time to time. The purchaser shall have the right to cancel the purchase order with general damages at 5% of the contract value, not by way of penalty. These damages shall be treated as recoveries outstanding against the vendor and dealt with accordingly.

8.0. Buyer Added Bid Specific ATC:

8.1. Bidder should upload the attached specification document in ATC duly signed, stamped, and complied with in all respects, along with the bid. Else, the offer shall be summarily rejected.

8.2. The contractor has to submit the bills with B2B forms along with the annual turnover certificate.

8.3. Bidders must invariably submit point to point specifications of the product being offered duly comparing with the indent specifications duly stamped and signed. Else, their offer shall be summarily rejected.

8.4. Bidders must invariably submit all the certificates mentioned in the specifications with date of validity available on the date of bid submission.

8.5. Tender specific authorization must be enclosed with the offer. Else, their offer shall be summarily rejected without negotiation.

The Additional Terms and Conditions (ATC) have been incorporated by the Buyer after approval of their Competent Authority. The Buyer is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any restriction arising in the bidding process due to these ATCs and including the modification of technical specifications and / or terms and conditions governing the bid. All representations / grievances pertaining to the ATC clauses shall be raised with the buyer organization directly and not with GeM. If any of the clause(s) is/are incorporated by the Buyer regarding the following, the bid & resultant contract shall be treated as null & void. Further, GeM reserves the right, at its sole discretion, to cancel the bid forthwith, without issuance of any prior notice or intimation :-

1. Publishing Custom / BOQ bids for items for which regular GeM categories are available (unless such Custom / BOQ item is bunched with the major regular product Category Item).
2. Mandating procurement of / from specific Brand / Make / Model / Manufacturer / Dealer except in case of Single Bid / Proprietary Article Certificate (PAC) Buying.
3. Inclusion of disqualification criteria related to suspension of seller / service provider, where such suspension period has already expired.
4. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
5. Publishing bids on GeM for procurement of works.
6. Procurement of Goods by creating a Service bid on GeM & vice-versa.
7. Seeking sample with bid or approval of samples during bid evaluation process. However, trial / sample, as the case may be, shall be permitted in cases where trial / sample are allowed as per approved and published procurement policy of the Buyers' controlling Ministry / Department / State / Public Sector Enterprises Headquarters. If there is any violation of trial / sample clause with regard to approved policy of the Buyers' Ministry / Department / State / Public Sector Enterprises Headquarters, then this is to be determined and redressed by the concerned Buyer Organisation only.
8. Seeking experience from specific organization / department / institute only or from foreign / export experience.
9. Creating bid for items from incorrect categories.
10. Reference of conditions published on any external site or reference to external documents/clauses.
11. Asking for any Tender fee / Bid Participation fee, as the case may be.
12. Buyer added ATC Clauses which are in contravention of clauses defined in bid detail section, including specifications, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by the applicable GeM GTC.
13. Any ATC clause in contravention with GeM GTC Clause 4 (xiii) (h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
14. In a category based bid, adding additional items, through buyer added, additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogues or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers/Service Providers shall ensure full compliance with all applicable labour laws, including the provisions, rules, schemes and guidelines under the four Labour Codes i.e. the Code on Wages, 2019; the Industrial Relations Code, 2020; the Occupational Safety, Health and Working Conditions Code, 2020; and the Code on Social Security, 2020 as and when notified and brought into force by the Government of India.

For all provisions of the Labour Codes that are pending operationalisation through rules, schemes or notifications, the corresponding provisions of the pre-existing labour enactments (such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972, etc. and relevant State Rules) shall continue to remain applicable.
