If the bidder is a Micro or Small Enterprise as per latest orders issued by Ministry of MSME, the bidder shall be relaxed from the eligibility criteria of "Experience Criteria" as defined above subject to meeting of quality and technical specifications. The bidder seeking Relaxation from Experience Criteria, shall upload the supporting documents to prove his eligibility for Relaxation.
2. 6. Years of Past Experience required: The bidder must have experience for number of years as indicated above in bid document (ending month of March prior to the bid opening) of providing similar type of services to any Central / State Govt Organization / PSU. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.

7. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price. The buyers are advised to refer to the [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if the credentials of the service provider are validated on-line in GeM profile as well as validated and approved by the Buyer after evaluation of submitted documents.

8. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

9. Past Experience of Similar Services: The bidder must have successfully executed/completed similar Services over the last three years i.e. the current financial year and the last three financial years(ending month of March prior to the bid opening): -

1. Three similar completed services costing not less than the amount equal to 40% (forty percent) of the estimated cost; or

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

### 2. Payment

**PAYMENT OF SALARIES AND WAGES:** Service Provider is required to pay Salaries / wages of

contracted staff deployed at buyer location first i.e. on their own and then claim payment from Buyer alongwith all statutory documents like, PF, ESIC etc. as well as the bank statement of payment done to staff.

### 3. **Certificates**

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

### 4. **Past Project Experience**

**Proof for Past Experience and Project Experience clause:** For fulfilling the experience criteria any one of the following documents may be considered as valid proof for meeting the experience criteria:a. Contract copy along with Invoice(s) with self-certification by the bidder that service/supplies against the invoices have been executed.b. Execution certificate by client with contract value.c. 3. The firm should have his local office/premises in J&K state for availability at short notice in case of any administrative/medical issue. A copy of form-C, for establishment register for the office premises should be uploaded as a proof.
4. The firm should have a certificate from the central labour commissioned, demonstrating registration for supply of manpower/Labour.
5. Solvency certificate of the firm-Bank Solvency certificate amounting to 80% of the contract value.
6. The experience criteria of 80%,50% & 40% of the previous contracts as per GeM guidelines shell be incorporated, if feasible.
7. No Need to submit physical document. Bidder's should have submit all required documents online within time limits.
8. Service provider is required to pay salaries/wages of contracted staff deployed at buyerlocation first i.e on their own and then claim payment from buyer alongwith all statutory documents like PF,ESIC etc as well as the bank statement of payment done to staff.
9. The working hours will be from 0800hrs to 1700hrs with a lunch break of 1/2 hours.However, the subject manpower may required to attend office on Sunday/holiday or attend office before/after working hours subject to the exigencies of service and the same will be adjusted in the subsequent of each month.
10. The contractor shell furnish the following documents in respect of the individual deployed before commencement of work: 6 / 8 (a) Bio-Data of person 6 / 8 (b) Attested copy of secondary education (10th) certificate containing date of birth. (c) Character certificate from two group 'A'/class-1 Officer of the Central/state Govt. (d) Certificate of verification antecedents of person by local police authority (e) Aadhar card bearing photograph.
11. Contractor to submit documents for issue of pass from station HQ in r/o employed staff within 07 days of receipt of contract.
12. In case person employed by the seller commits any act of omission/commission which amounts to misconduct/indiscipline.incompetence the seller will be liable to take appropriate disciplinary action .

13. Seller should be provide request services according to latest rate revised by Ministry of Labour and em  
ployment vide their office order No F. No 1/6 (3)/2025-LS-II dt 30 Mar 2026.
