If the bidder is a Micro or Small Enterprise as per latest orders issued by Ministry of MSME, the bidder shall be relaxed from the eligibility criteria of "Experience Criteria" as defined above subject to meeting of quality and technical specifications. 7. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. ### 2. Generic

**Bidder financial standing:** The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.

### 3. Past Project Experience

**Proof for Past Experience and Project Experience clause:** For fulfilling the experience criteria any one of the following documents may be considered as valid proof for meeting the experience criteria: a. Contract copy along with Invoice(s) with self-certification by the bidder that service/supplies against the invoices have been executed. b. Execution certificate by client with contract value. c. Any other document in support of contract execution like Third Party Inspection release note, etc. **Proof for Past Experience and Project Experience clause:** For fulfilling the experience criteria any one of the following documents may be considered as valid proof for meeting the experience criteria: a. ### 5. Buyer Added Bid Specific ATC

Vendor has to submit following documents without which the vendor will be disqualified in Technical Evaluation:

- a) ESI Registration Certificate- Attested copies of ESI certificate along with latest receipt of premium paid should be attached failing which the certificates / receipt will be considered invalid.

- k) Balance Sheet & ITR : The bidder has to submit Income Tax Return Acknowledgement of last three financial year along with Balance Sheet and P/L Account of last three FY.

l) Office Location: The vendor should have its main office / Head Office / Regional Office registered preferably in West Bengal. Documents in this regard have to be attached in the Bid.

m) Buyer will interview the manpower provided by the vendor, if needed to see the suitability of the Job.

n) Declaration is required to be attached for extension of the duration of present contract for another 3 months in case required by the buyer.

Payment Clause:

(i) Payment to be made within stipulated time i.e 1st day of the month.

(ii) Payment to be made strictly as per contract i.e within profit margin.

(iii) No extra charges will be taken from the employees.

(iv) Adherence to the contract is mandatory.

(v) PF/ESI to be paid as per extant rules and proof to be submitted monthly.

(vi) Bills need to be submitted by the 5th of the next month for necessary clearance

(vii) PBG to be given 5% of the contract value after issuance of supply order. The PBG should be valid for 17 months from the date of Contract as the contract may be extended upto five months (i.e 12 months + 5 months).

(viii) Service Charge will only be paid on Minimum wages and not on ESI & PF or other elements. Acceptance of the same is mandatory to be provided by vendor for Technical Evaluation.

(ix) Contract amount will be finalized by competent financial authority in concurrence of integrated financial adviser and the same will be applicable to all vendor. No alteration amount will be allowed except in case of revision of pay by the GOI, Ministry of Labour.

(x) As per Order No. 209/CEO-GeM/2023 dt. 24.08.2023, the bidder should upload the following declaration in his official letter head duly signed and stamped:

**The Service Provider (Name of the Bidder) hereby undertakes not to charge any money /fees/deductions in whatever manner, name, or form, or take any monetary/ non-monetary considerations, or make any unlawful deductions from the compensation/salary of the manpower / employees /resources engaged by it and, to be deployed at the Buyer side. The Service provider (Name of the Bidder) further agrees that it will not indulge in unethical practices and acknowledges that any non compliance of the aforesaid undertaking will be treated as a material breach of the contract, in which case the Buyer and GeM shall have the right to take appropriate independent actions including termination of the contact and actions as per GeM Incident Management Policy.**

जेम की सामान्य शर्तों के खंड 26 के संदर्भ में भारत के साथ भूमि सीमा साझा करने वाले देश के बिडर से खरीद पर प्रतिबंध के संबंध में भारत के साथ भूमि सीमा साझा करने वाले देश का कोई भी बिडर इस निविदा में बिड देने के लिए तभी पात्र होगा जब वह बिड देने वाला सक्षम प्राधिकारी के पास पंजीकृत हो। बिड में भाग लेते समय बिडर को इसका अनुपालन करना होगा और कोई भी गलत घोषणा किए जाने व इसका अनुपालन न करने पर अनुबंध को तत्काल समाप्त करने और कानून के अनुसार आगे की कानूनी कार्रवाई का आधार होगा।/In terms of GeM GTC clause 26 regarding Restrictions on procurement from a bidder of a country which shares a land border with India, any bidder from a country which shares a land border with India will be eligible to bid in this tender only if the bidder is registered with the Competent Authority. While participating in bid, Bidder has to undertake compliance of this and any false declaration and non-compliance of this would be a ground for immediate termination of the contract and further legal action in accordance with the laws.
