However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

2. **Certificates**

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

3. **Service & Support**

AVAILABILITY OF OFFICE OF SERVICE PROVIDER: An office of the Service Provider must be located in the state of Consignee. DOCUMENTARY EVIDENCE TO BE SUBMITTED.

4. **Buyer Added Bid Specific ATC**

1. Availability of office of service provider must be a located in the state of buyer. documentary evidence to be submitted.
2. OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration upto 50 % at the time of issue of the contract. however, once the contract is issued, contract quantity or contract duration can only be increase upto 50%. bidder are bound to accept the revised quantity or duration

Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
