If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.
4. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$, subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

1. BoQ for Job work has been uploaded/ issued in GeM portal (www.gem.gov.in). You are requested to quote your reasonable rate for the same within the bid submission end date.

2. The BoQ (Bill of Quantities) published has been digitally signed by buyer. The tender type is opened. Modification/altering the BoQ format will lead to rejection of quotation. The bidders are requested to fill only the column/row meant for use of seller. Rates should be in figures for the accounting unit given at BoQ. Your rates should be inclusive for the free delivery/repair/replacement amendment of works and the various taxes including GST.

3. Bids received will be opened by the **buyer** at office of the GE (Army) Jamnagar. Technical evaluation of bid will be done as per the conditions and various documents required as mentioned in BoQ. Non observance of those conditions may make your BID invalid and unacceptable.

4. **Period of Completion:** One months from the date of issue of formal order.
5. Stationary shall have quality system compliance and shall be STQC/ TEC / BIS/any Indian standards as applicable to the items. All supportive documents should be attached with the technical bid.
6. **Working Hours:** Normal hours of the work for department staff are from 0900 hours to 1700 hours on all days except on Sunday and closed holidays. However the contractors may observe unrestricted hours of work for all the work to be executed on written permission of Garrison Engineer only.
7. **Enlisted Suppliers / Vendor with MES :** Vender shall be enlisted with MES in Suppliers Job Works With MES Enlisted Suppliers. Enclose copy of registration copy in MES Suppliers / job work.
8. PAN Card. Firm should have valid PAN Card in the name of firm or in the name of proprietor of the firm in case of proprietary firm (copy to be enclosed).
9. The bidder should have registered office/area office in/around Jamnagar area i.e Gujarat. Copy of the shop registration/establishment registration/proof under the respective Act of the state needs to be enclosed.
10. Data Sheets of each item/s in respect of which rates are quoted should also be attached.
11. The Bidder should not have been debarred/black-listed by any Central/State Government Agency.
12. Items of which specifications are mentioned in tender documents should be of ISI/Industrial standards marked according to applicable Government's Norms.

13. Bidder will ensure that the entire work (SITC work) should be completed within the stipulated period of time i.e. within 90 days of award of work order (based on the site readiness).

(e) Payment will be made to the vendor account by CMP Fund Transfer.

(f) The quoted rate should include all the taxes including GST.

(g) AO, GE(Army) Jamnagar will be the paying authority.

अस्वीकरण/Disclaimer

The Additional Terms and Conditions (ATC) have been incorporated by the Buyer after approval of their Competent Authority. The Buyer, is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any restriction arising in the bidding process due to these ATCs and including the modification of technical specifications and / or terms and conditions governing the bid. All representations / grievances pertaining to the ATC clauses shall be raised with the buyer organization directly and not with GeM. If any of the clause(s) is/are incorporated by the Buyer regarding the following, the bid & resultant contract shall be treated as null & void. Further, GeM reserves the right, at its sole discretion, to cancel the bid forthwith, without issuance of any prior notice or intimation :-

1. Publishing Custom / BOQ bids for items for which regular GeM categories are available (unless such Custom / BOQ item is bunched with the major regular product Category Item).
2. Mandating procurement of / from specific Brand / Make / Model / Manufacturer / Dealer except in case of Single Bid / Proprietary Article Certificate (PAC) Buying.
3. Inclusion of disqualification criteria related to suspension of seller / service provider, where such suspension period has already expired.
4. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
5. Publishing bids on GeM for procurement of works.
6. Procurement of Goods by creating a Service bid on GeM & vice-versa.
7. Seeking sample with bid or approval of samples during bid evaluation process. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogues or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of

this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers/Service Providers shall ensure full compliance with all applicable labour laws, including the provisions, rules, schemes and guidelines under the four Labour Codes i.e. the Code on Wages, 2019; the Industrial Relations Code, 2020; the Occupational Safety, Health and Working Conditions Code, 2020; and the Code on Social Security, 2020 as and when notified and brought into force by the Government of India.

For all provisions of the Labour Codes that are pending operationalisation through rules, schemes or notifications, the corresponding provisions of the pre-existing labour enactments (such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972, etc. and relevant State Rules) shall continue to remain applicable.

The Seller/ Service Providers shall, therefore, be responsible for ensuring compliance under:

- **All notified and enforceable provisions of the new Labour Codes as mentioned hereinabove; and**
- **All operative provisions of the erstwhile Labour Laws until their complete substitution.**

All obligations relating to wages, social security, safety, working conditions, industrial relations etc. and any other statutory requirements shall be strictly met by the Seller/ Service Provider. Any non-compliance shall constitute a breach of the contract and shall entitle the Buyer to take appropriate action in accordance with the contract and applicable law.

This Bid is governed by the General Terms and Conditions, conditions stipulated in Bid and Service Level Agreement specific to the Service, as the case may be, as provided in the Marketplace.

However, in case of Service, if any condition specified in General Terms and Conditions is contradicted by the conditions stipulated in Service Level Agreement specific to said Service, then it will over-ride the conditions in the General Terms and Conditions.
