This agreement made on this _____ **MAY, 2026** between the President of India represented by his authorized agent "**DEFENCE ESTATE OFFICER, TEZPUR CIRCLE, TEZPUR**" hereinafter called 'BUYER' on the ONE PART AND " _____ " hereinafter called the '**SERVICE PROVIDER**' on the OTHER PART. It is necessary for the service provider to provide one number DGPS (CORS Enabled) survey equipment alongwith all accessories, fitments and Technical Manpower as and when desired by DEO TEZPUR telephonically or otherwise.

AND that the rates and other terms and conditions for payment thereof shall be determined by a written agreement between the aforesaid parties.

NOW THEREFORE IT IS AGREED BETWEEN THE PARTIES AS GIVEN UNDE

R:

SCOPE OF WORK

1 . Requirement of DGPS (CORS enabled) on per acre hiring basis should be provided with all accessories, fitments and Technical Manpower with sufficient qualification and experience. The quantity of procurement "1" indicates project based hiring which involves supply of aforesaid survey equipment alongwith all accessories , fitments and Technical Manpower for survey of 4000 acres of land on per acre hiring basis. The interested Service Provider should quote the lumpsum cost taking into consideration of per acre rate of hiring of DGPS (CORS enabled) equipment with Technical Manpower.

The lumpsum cost for "1" project based hiring = supply of DGPS (CORS enabled) survey equipments alongwith all accessories, fitments and Technical Manpower of 4000 acres of land X Per acre rate

Note : The area mentioned in the bid documents is tentative in totality and not in a single location, single pocket or single polygon. The area will be surveyed in different locations, different pockets and polygons in the state of **Assam**. The payment will be made as per actual area surveyed in different locations and pockets.

1. Scope of Work for Manpower/Technical Operator:-

- i) Service Provider/Agency shall have to deliver the Survey Team at site within 24 Hrs. as per need basis (i.e. based upon any direction of higher authorities, assemble of Board by LMAs of Army/Air Force, availability of Revenue Reps etc.)
- ii) Technical Staff with adequate qualifications and experience in the field to operate Base and Rover of CoRS enabled DGPS.

2. The details of Scope of Work for hiring of DGPS (CORS enabled) with Technical Manpower are as follows:-

i) Supply of DGPS (CORS enabled) survey equipment on per acre hiring basis should be provided with all accessories, fitments and Technical Manpower with sufficient qualification and experience. Survey instrument with all its accessories should be in good working condition. Faulty/defective instrument will be summarily rejected.

ii) This office will not be responsible of any software and hardware damages that occur during the period.

iii) If any defects of instruments occur during the period of survey, the service provider will immediately replace it with a good condition instrument. The data of survey from such instrument will be recovered by the service provider and submitted to this office/survey-in-charge. If the data could not be recovered re-survey should be done by the replaced instrument at no gain and no extra payment shall be made for this work.

iv) Survey data after completion of survey work of every pocket of Defence land, should be downloaded/extracted from DGPS and handed over to the survey-in-charge/Surveyor/SDO of this office. This data will be the property of DEO Tezpur and service provider can't share this data to anybody and all data to be strictly confidential. Further, following items to be deliverable by the service provider post- survey of any land under this contract:

- a) Excel Sheet of co-ordinates.
- b) Shape File, AutoCAD files, KML file, TIFF, GEO-TIFF, CAD format (DXF/DWG) file of each property/pocket.
- c) The soft copy and hard copy of AutoCAD files.
- d) Superimposition of survey plans over base map to trace out the variation and providing final maps in A0/A1/A2/A3 size paper as per area of the plot in 1:1000 scale or specified by DEO, Tezpur Circle.

(v) Establishing control points with DGPS (CORS enabled) survey instruments.

vi) Distributing Control Points with DGPS (CORS enabled) survey instruments as per requirement of survey site.

vii) Peripheral and/or detailed survey of Defence land or any other land and using DGPS (CORS enabled) as may be directed by the buyer.

viii) Survey data i.e. co-ordinates, bearing, distance etc. should be handed over after completion of survey.

ix) Necessary internet for establishing connection between CORS network and DGPS (CORS enabled) survey equipment are to be arranged and provided by the service provider.

x) The service provider should make available adequate option/facilities/arrangements with the DGPS (CORS enabled) survey instruments for uninterrupted internet connection for the survey work.

xi) Encroachment on defence land if any, demarcated by the Survey team of DEO, Tezpur, LMA & Revenue Authority during Joint Survey, the same also required to be surveyed and encroachment details to be shown in distinct colour on outcome map of the survey. The survey equipment will be utilized to record additional data for geo-referencing of the revenue maps, acquisition map as and when necessary.

xii) The hired survey equipment will be utilized for all technical tasks explained above to complete the entire exercise. The survey of land is inclusive of all the above practice and procedures for which no additional payment will be made separately.

xiii) Joint survey will be carried out in association with the representatives of military authority, revenue authority, defence estates authority etc. no compensation/extra payment will be for any delay, slow progress, non-attendance of representatives, delay due to unforeseen reasons on whatsoever.

xiv) There will be no minimum or maximum limit for area of survey in a day as well as in any project or requisition. Nonfunctioning and nonoperational of equipment due to technical fault in the equipment will attract penalty as may be decided by the buyer and the service provider will be bound by to comply the same. In case of non-responding to the buyer and non detailment of survey equipment, the security deposit of buyer will summarically be forfeited.

xv) The Survey will be carried out in association of Civil Revenue Authority and based on Revenue Maps/Acquisition Maps etc. No-compensation/extra payment will be made for delay in proper demarcation of the survey land.

xvi) The service provider will also make available necessary electronic gazette for digitization of survey data on day to day work basis to check the correct progress of the survey demarcation and also to avail any discrepancy in the outcome data. In case of detection of any wrong demarcation, the said area will have to be re-demarcated and for which no extra payment will be made.

xvii) As the contract includes survey demarcation of defence land as per Revenue Maps/Acquisition Maps etc. existing holding of land, encroachment if any, geo-referencing of Revenue Maps based on permanent features, neighboring plots etc. no separate payment will be made for each of the task.

The service provider will have to arrange all administrative, technical support for his equipment at site at his own cost.

2. SPECIAL TERMS AND CONDITIONS

- (i) Requirement of DGPS (CORS enabled) survey equipment with Technical Manpower as and when informed telephonically or otherwise, should be made available at the notice period of one working day. Any delay on this part may lead to cancellation of contract as per decision of DEO Tezpur Circle.
- (ii) The service provider will be fully responsible for the safety and security of aforesaid survey equipment. The service provider will be solely responsible and bear all expenses/compensation for any untoward incident/mishaps that occurs to the instruments with all accessories and fitments. No compensation will be paid by the DEO Tezpur in this regard.
- (iii) Complete payment will not be cleared until all survey data i.e. co-ordinates, bearing, distance etc. are handed over and duly verified by the technical staffs of this office. Re-survey, if needed should be done at no extra payment.
- (iv) The Service Provider should quote the lumpsum cost taking into consideration of per acre rate of hiring of DGPS (CORS enabled) alongwith all accessories and fitments and Technical Manpower.
- (v) The payment will not be made for those days when the aforesaid survey equipment are not workable at site.
- (vi) General working hour would be from 8.00 a.m. to 5.00 p.m., which can vary as per working condition of the place where land is located.
- (vii) The terrain proposed for survey will be plain, hilly and jungle areas. Payment will include all field and office work derivation of survey data in form of co-ordinates, printing of data etc. payment will be made after handing over of survey data and after checking/verification by technical staffs of this office. Re-survey, if needed should be re-done with the help of aforesaid survey instruments at no extra payment.
- (viii) DEO Tezpur shall have final decision on quality of work done. In case the work is found unsatisfactory, no payment shall be made to service provider.
- (ix) This invitation of rate is subject to the applicable Govt. policy and may be withdrawn at any stage of offer or contract if decided so by the Competent Authority without giving any reasons. The service provider may note that they will not be entitled to enquire any explanation or cost etc. for such withdrawal of the notice/offer or contract at any stage of the process.
- (x) The service provider should have its own active Bank Account for transaction. Certified copy of the bank mandate form duly signed by the Bank shall be enclosed.
- (xi) The service provider should be registered with GST. Self-certified copy of the GST registration and copy of the PAN card shall also be attached with the Bid document.
- (xii) The payment will not be made for those days when the aforesaid survey equipment or Technical Manpower are found absent from site.
- (xiii) The DGPS (CORS enabled) Technical Manpower should be experienced and well versed in handling DGPS (RTK/PPK/CORS enabled) and at least three years' experience in field survey works. Deployment of fresh personnel as DGPS (CORS enabled) Technical Manpower will not be permitted.

(xiv) Local transportation will be provided by the office. Other than that, the service provider shall bear the fooding/lodging expenses for survey support staffs provided by him.

(xv) The service provider will be fully responsible for the safety and security of aforesaid survey Technical Manpower. The service provider will be solely responsible and bear all expenses/compensation for any untoward incident/mishaps occurs to his men i.e. survey Technical Manpower. No compensation will be paid by the DEO Tezpur in this regard.

OTHER TERMS & CONDITIONS

-

(i) Service provider shall not be permitted to withdraw his offer or modify the terms and conditions thereof. In case the Service provider fails to observe and comply with the stipulations laid down in or backs out after quoting the rates, the bidder will be disqualified and restricted to participate in any further tender/bid proceedings with this office.

(ii) Service provider shall not be permitted to offer and incorporate any terms and conditions in the bid contract agreement.

(iii) Service provider is bound to supply the instruments as may be asked by the buyer. There will be no minimum days or quantity in a single demand by the buyer during the contract period.

(iv) Service provider shall not be permitted to withdraw his survey equipment or Technical Manpower from the project site without prior intimation (at least 3 days in advance) to the buyer.

(v) Service provider shall not be permitted to withdraw his survey equipment or Technical Manpower from the project site without proper replacement of survey equipment at project site at his own cost and risk.

TERMINATION OF CONTRACT : Competent authority, without prejudice to any other remedy, for breach of contract, may terminate the contract in whole or in parts for the following reasons:-

(i) If the service provider fails to arrange the supply of survey equipment along with all accessories and fitments within the period(s) specified in the contract and any extension thereof has not been granted by the Competent Authority/buyer.

(ii) If the service provider fails to perform any other obligation(s) under the conditions of the contract and all clauses of this tender which are integral part of this tender.

(iii) Termination for Insolvency : The competent authority may at any time terminate the Contract by giving written notice to the service provider, without compensation to the contractor.

AGREEMENT : **The successful bidder will have to enter an agreement. Cost of execution of agreement shall be borne by the service provider. Final work order shall be issued only after execution of the agreement by the successful bidder. Apart from other things, all clauses of this tender document shall form the integral part of the agreement. The terms and conditions mentioned in the GeM generated contract will also be treated as a part of this agreement and be abided by both parties.**

Note : The service provider while quoting the rates in the financial bid, should consider the following aspect:-

(i) The DGPS (CORS enabled) survey equipment with all accessories and fitments are required for carrying out survey in several outstation areas in the state of Assam. The buyer will not make any additional payment for time to time maintenance and repairing. Further, Buyer will also not make any additional payment for the expenses towards fooding and lodging for the Technical Manpower working either in outstation or within the HQ. For that the Service Provider will have to arrange the same. The service provider will have to supply the survey equipment with all accessories and fitments to the office of the DEO Tezpur as and when asked for. The transportation of aforesaid equipment to HQ (Office of DEO Tezpur) or place of work/survey site and return, as may be directed before commencement of survey by the buyer, shall be arranged by the service provider. However transportation of Technical Manpower from place of work and return to HQ and vice-versa shall be arranged by the Buyer.

(ii) The aforesaid survey equipment with all accessories and fitments are required to be working in several outstation areas in the state of Assam. The buyer will not make any additional payment for the expenses towards transportation for the above instruments either in outstation or within the HQ station. The service provider will have to arrange the transportation to place of work and return to HQ etc. for the equipment at their own efforts and cost.

(iii) The Contract for the aforesaid Service i.e. Hiring of DGPS (CORS enabled) on per acre along with all accessories, fitments and Technical Manpower for Survey of 4000 Acres land will be for a period of 01 year. If the aforesaid area could not be surveyed within that contract period, the Buyer has reserved the right to extend the contract period for a further period not more than 01 (one) year without any change in the total Contract value OR the Buyer at his own discretion may initiate process for fresh contract without any extension to the expired contract.

(iv) The Area measuring 4000 acres projected for survey includes Defence acquired, Hired, Leased land as well as land under acquisition, hiring, related to Infra Project etc. at various locations in Assam Pradesh. The Buyer reserves the right to direct the Service Provider for detailing his Survey equipment along with Technical Manpower as and where necessary.

4. **PERIOD OF CONTRACT** : The contract will be upto **30st April, 2027**. The DEO Tezpur reserves the right to terminate the contract with service provider within the contract period at any stage, if the service is not found satisfactory, breach of contract or otherwise.

5. **FORCE MAJEURE** : If any time, during the continuance of this contract, the performance in whole or in part by either party of any obligation under this contract is prevented or delayed by reason of any war, or hostility, acts of the public enemy, civil commotion, sabotage, fires, floods, explosions, epidemics, quarantine restrictions, strikes, lockouts or act of God (hereinafter referred to as events) provided notice of happenings, of any such eventuality is given by either party to the other within 7 days from the date of occurrence thereof, neither party shall by reason of such events be entitled to terminate this contract nor shall either party have any claim for damages against the other in respect of such non performance or delay in performance under the contract shall be resumed as soon as practicable after such an event may come to an end or cease to exist, and the decision of the purchaser as to whether the services have been so resumed or not shall be final and conducive, provided further that if the performance in whole or part of any obligation under this contract is prevented or delayed by reason of any such event for a period exceeding 15 days either party may, at his option terminate the contract.

6. RATE/CHARGES AND TERMS OF PAYMENT :

The service provider has quoted the following rates in the bid which has been found lowest and approved by the buyer.

(a) No payment shall be made in advance and payment will be initiated only after the successful completion of the work as per the contract. In that account the work completion report/inspection report will be given from DEO, Tezpur.

(b) The service provider shall submit the quarterly bill in the first week of month of following quarter in respect of previous quarter for sanction of the amount of bill and passing the bill for payment, with supporting attendance sheets duly signed by the users.

(c) All payment shall be made by the CDA Guwahati through RTGS/NEFT.

(d) The competent authority shall be at liberty to withhold any of th

the payments in full or in part subject to satisfaction of the service, output of the work by the buyer.
(e) The service provider will not be allowed to incorporate any condition on the terms of the payment

7. PENALTY :-

As per provisions incorporated in the SLA finalized by the GeM.

8. TERMINATION OF CONTRACT : Competent authority, without prejudice to any other remedy, for breach of contract, may terminate the contract in whole or in parts for the following reasons:-

(i) If the service provider fails to arrange the supply of survey equipments and /or operator, any or all the survey equipments alongwith all accessories, fitments and Technical Manpower within the period(s) specified in the contract and any extension thereof has not been granted by the Competent Authority/buyer.

(ii) If the service provider fails to perform any other obligation(s) under the conditions of the contract and all clauses of this tender which are integral part of this tender.

(iii) **Termination for Insolvency** : The competent authority may at any time terminate the Contract by giving written notice to the service provider, without compensation to the contractor.

9. Assignment and Sub-letting of Contract. The Contractor shall not transfer, assign or sublet this contract to any other party without the previous permission in writing from DEO TEZPUR and in case of any default, the contractor shall be liable to be cancelled unconditionally at the risk and cost of the contractor including penalty and litigation costs and other such costs as may be incurred by DEO TEZPUR to remedy this clause.

10. Arbitration Clause. All disputes or differences arising between the parties hereto, related to the subject matter of this agreement and of the respective rights, duties under these presents except those the decision whereof is herein before specifically provided for, shall be referred to the sole arbitration of the **PRINCIPAL DIRECTOR, DEFENCE ESTATES**, Eastern Command whose decision thereon shall be final and binding to both the parties. **PRINCIPAL DIRECTOR, DEFENCE ESTATES**, Eastern Command may appoint an arbitrator to resolve the disputes arising out of this agreement and during the pendency of the arbitration, unless the agreement is terminated unconditionally by DEO TEZPUR the contractor will continue to provide the services.

SCOPE OF WORK

1 . Requirement of DGPS (CORS enabled) on per acre hiring basis should be provided with all accessories, fitments and Technical Manpower with sufficient qualification and experience. 1. Scope of Work for Manpower/Technical Operator:-

- i) Service Provider/Agency shall have to deliver the Survey Team at site within 24 Hrs. as per need basis (i.e. based upon any direction of higher authorities, assemble of Board by LMAs of Army/Air Force, availability of Revenue Reps etc.)

- ii) Technical Staff with adequate qualifications and experience in the field to operate Base and Rover of CoRS enabled DGPS.

2. The details of Scope of Work for hiring of DGPS (CORS enabled) with Technical Manpower are as follows:-

i) Supply of DGPS (CORS enabled) survey equipment on per acre hiring basis should be provided with all accessories, fitments and Technical Manpower with sufficient qualification and experience. Survey instrument with all its accessories should be in good working condition. Faulty/defective instrument will be summarily rejected.

ii) This office will not be responsible of any software and hardware damages that occur during the period.

iii) If any defects of instruments occur during the period of survey, the service provider will immediately replace it with a good condition instrument. The data of survey from such instrument will be recovered by the service provider and submitted to this office/survey-in-charge. If the data could not be recovered re-survey should be done by the replaced instrument again and no extra payment shall be made for this work.

iv) Survey data after completion of survey work of every pocket of Defence land, should be downloaded/extracted from DGPS and handed over to the survey-in-charge/Surveyor/SDO of this office. This data will be the property of DEO Tezpur and service provider can't share this data to anybody and all data to be strictly confidential. Further, following items to be deliverable by the service provider post-survey of any land under this contract:

- a) Excel Sheet of co-ordinates.
- b) Shape File, AutoCAD files, KML file, TIFF, GEO-TIFF, CAD format (DXF/DWG) file of each property/pocket.
- c) The soft copy and hard copy of AutoCAD files.

- d) Superimposition of survey plans over base map to trace out the variation and providing final maps in A0/A1/A2/A3 size paper as per area of the plot in 1:1000 scale or specified by DEO, Tezpur Circle.
- (v)** Establishing control points with DGPS (CORS enabled) survey instruments.
- vi)** Distributing Control Points with DGPS (CORS enabled) survey instruments as per requirement of survey site.
- vii)** Peripheral and/or detailed survey of Defence land or any other land and using DGPS (CORS enabled) as may be directed by the buyer.
- viii)** Survey data i.e. co-ordinates, bearing, distance etc. should be handed over after completion of survey.
- ix)** Necessary internet for establishing connection between CORS network and DGPS (CORS enabled) survey equipment are to be arranged and provided by the service provider.
- x)** The service provider should make available adequate option/facilities/arrangements with the DGPS (CORS enabled) survey instruments for uninterrupted internet connection for the survey work.
- xi)** Encroachment on defence land if any, demarcated by the Survey team of DEO, Tezpur, LMA & Revenue Authority during Joint Survey, the same also required to be surveyed and encroachment details to be shown in distinct colour on outcome map of the survey. The survey equipment will be utilized to record additional data for geo-referencing of the revenue maps, acquisition map as and when necessary.
- xii)** The hired survey equipment will be utilized for all technical tasks explained above to complete the entire exercise. The survey of land is inclusive of all the above practice and procedures for which no additional payment will be made separately.
- xiii)** Joint survey will be carried out in association with the representatives of military authority, revenue authority, defence estates authority etc. no compensation/extra payment will be for any delay, slow progress, non-attendance of representatives, delay due to unforeseen reason whatsoever.
- xiv)** There will be no minimum or maximum limit for area of survey in a day as well as in any project or requisition. Nonfunctioning and nonoperational of equipment due to technical fault in the equipment will attract penalty as may be decided by the buyer and the service provider will be bound by to comply the same. In case of non-responding to the buyer and non detailment of survey equipment, the security deposit of buyer will summarically be forfeited.
- xv)** The Survey will be carried out in association of Civil Revenue Authority and based on Revenue Maps/Acquisition Maps etc. No-compensation/extra payment will be made for delay in proper demarcation of the survey land.

xvi) The service provider will also make available necessary electronic gazette for digitization of survey data on day to day work basis to check the correct progress of the survey demarcation and also to avail any discrepancy in the outcome data. In case of detection of any wrong demarcation, the said area will have to be re-demarcated and for which no extra payment will be made.

xvii) As the contract includes survey demarcation of defence land as per Revenue Maps/Acquisition Maps etc. existing holding of land, encroachment if any, geo-referencing of Revenue Maps based on permanent features, neighboring plots etc. no separate payment will be made for each of the task.

The service provider will have to arrange all administrative, technical support for his equipment at site at his own cost.
