5. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and

1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

2. Generic

Bidder financial standing: The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.

3. Payment

PAYMENT OF SALARIES AND WAGES: Service Provider is required to pay Salaries / wages of contracted staff deployed at buyer location first i.e. on their own and then claim payment from Buyer alongwith all statutory documents like, PF, ESIC etc. as well as the bank statement of payment done to staff.

4. Forms of EMD and PBG

2. Service provider office must be located in Ahmedabad District. Bidder has to submit valid documents with bid.

3. The cost of work shall be deemed to be inclusive of the following: a) Fuel e.g. petrol/diesel cost, all main tenance expenditure of vehicle i. e. major and minor repairs required for good running of vehicles, all consumables like lubricants, brake oil, etc. b) The driver's salary with all statutory contributions e.g., EPF, ESIC, etc.; all types of taxes, tolls and fees payable to RTO office. c) Uniform and other consumables cost for vehicle drivers. d) Any other cost involved for execution of this contract. e) The vehicle may sometimes be required to travel outstation for upto 3 days. f) The contractor will bear the driver's staying, lodging, food and other expenses during this time period. g) Parking/toll tax/entry fee etc. shall also be paid by the contractor. h) Applicable GST. i) The estimated rates are all inclusive i. e. inclusive of GST and all other expenses pertaining to the work. 4. There will be no reimbursement of Toll-tax and payment will be completely as per special terms and conditions.

5. Monthly running of vehicle: The vehicle will run for a fixed 2500 kilometers (KM) per month, for which fixed monthly payment will be made to the contractor. Monthly 2500 Kms x 320 Hrs shall be utilized. If during the month, running of vehicle is less than 2500 kilometers then the remaining kilometers will be carried forward to the next month. Further if the running of vehicle is more than 2500 kilometers in a month then the additional kilometers will be adjusted in the subsequent months. Overall, at the end of contract, the execution of work should be 2500 X 36 = 90000 Kilometers. If execution of work will be more than 90000 Kilometers at the end of 03 years of contract then the payment for extra Kilometers executed will be made as per GeM conditions for extra per Km charges.

6. No price variation shall be admissible in this contract on any account. The rates accepted shall remain firm during the entire period of contract.

7. No post submission of any documents will be entertained.

8. Bidders are obliged to follow all the rules of special terms and conditions.

9. Consignee will verify manufacturing year of vehicle as well as availability of vehicle and driver.
