If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. 6. In the absence of any of the above, the Store Keeper (Receipt and Inspection) shall refuse to take delivery of the stores. The supplier should submit the warranty/ guarantee card/certificate along with the Delivery Challan in whichever case it is applicable while effecting delivery of item.

3) The Packages should be securely packed and **details regarding Purchase Order/GeM Contract reference, complete address of Consignor/Consignee (with Contact details) should be clearly marked on all the packages.**

4) When dispatching multiple orders, **material of each order should be packed in separate package, and details regarding Order reference should be clearly marked.**

**5) OTP based deliveries are not possible** inside DAE Units. Hence dispatch of material shall be through standard transporters, **WITHOUT OTP.**

**6) In the event of dispatch through Speed Post, the date of actual delivery/physical collection will be considered as Delivery Date.**
