1. If the bidder is a Micro or Small Enterprise (MSE) as per latest orders issued by Ministry of MSME, the bidder shall be relaxed from the eligibility criteria of "Bidder Turnover" as defined above subject to meeting of quality and technical specifications. If the bidder itself is MSE OEM of the offered products, it would be relaxed from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. 2. 4. Purchase preference to Micro and Small Enterprises (MSEs) from the State of Bid Inviting Authority: Purchase preference will be given to MSEs as Micro and Small Enterprises from the State of Bid Inviting Authority. If the bidder wants to avail the Purchase preference, the bidder must be the Service provider of the offered Service. 6. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

#### 1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

#### 2. Generic

**Bidder financial standing:** The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.

### 3. **Generic**

1. The Seller shall not assign the Contract in whole or part without obtaining the prior written consent of buyer.
2. The Seller shall not sub-contract the Contract in whole or part to any entity without obtaining the prior written consent of buyer.
3. The Seller shall, notwithstanding the consent and assignment/sub-contract, remain jointly and severally liable and responsible to buyer together with the assignee/ sub-contractor, for and in respect of the due performance of the Contract and the Sellers obligations there under.

### 4. **Payment**

**PAYMENT OF SALARIES AND WAGES:** Service Provider is required to pay Salaries / wages of contracted staff deployed at buyer location first i.e. on their own and then claim payment from Buyer alongwith all statutory documents like, PF, ESIC etc. as well as the bank statement of payment done to staff.

### 5. **Forms of EMD and PBG**

Bidders can also submit the EMD with Fixed Deposit Receipt made out or pledged in the name of A/C

. The bank should certify on it that the deposit can be withdrawn only on the demand or with the sanction of the pledgee. For release of EMD, the FDR will be released in the favour of the bidder by the Buyer after making endorsement on the back of the FDR duly signed and stamped along with covering letter. Bidder has to upload scanned copy/ proof of the FDR along with bid and has to ensure delivery of hardcopy to the Buyer within 5 days of Bid End date/ Bid Opening date

### 6. **Service & Support**

AVAILABILITY OF OFFICE OF SERVICE PROVIDER: An office of the Service Provider must be located in the state of Consignee. DOCUMENTARY EVIDENCE TO BE SUBMITTED.

### 7. **Service & Support**

### 8. **Buyer Added Bid Specific ATC**

Buyer Added text based ATC clauses

1. The bidder must submit a valid shop and establishment registration certificate in the state of consignee to substantiate his address in **Andaman & Nicobar Islands (Mandatory Clause)**.
2. The MSME certificate for Electronic Data Processing must be uploaded.
3. The successful bidder should furnish the details list of deployed manpower within 05 days to the Director of Health Services, Port Blair, A&N Islands and Labour Commissioner, Port Blair.
4. The bidder has to mandatorily upload signed and scanned copy of registration / Incorporation certificate of the firm, GST registration certificate, ESIC & EPFO registration certificate etc.
5. As per minimum wage Act an employee in a scheduled employment in respect of which minimum rates of wages have been fixed under the Act, shall be allowed a day of rest every week (hereinafter referred to as "the rest day") which shall ordinarily be Sunday, but the employer may fix any other day of the week as the rest day for any employee.
6. The firm should submit EMD @ 3% of the estimated cost may be deposited in the form of DD /FDR /TRD etc from Nationalised / Commercial / Scheduled bank drawn in favour of "Sr. Accounts Officer, Directorate of

Health Services, Port Blair”.

7. The successful firm should submit ePBG @ 5% of the bid amount may be deposited in the form of FDR /TR D etc from Nationalised / Scheduled bank drawn in favour of “Sr. Accounts Officer, Directorate of Health Services, Port Blair”.
8. The bidders must have successfully executed/completed similar services over last three years i.e. last three financial years with average annual turnover of 30% of the bid amount. (document must be attached).
9. The appointment of any Data Entry Operators does not confer any right or privilege upon them to claim regular appointment under various health institutions under this directorate.
10. Their services shall automatically stand terminated on expiry of above contract period and no further claims or objections from these staffs would be entertained.
11. The staffs engaged therein shall show utmost professionalism towards his / her duty failing which necessary actions as deemed fit would be initiated against them.
12. The Competent Authority reserves the right to terminate the services of the above staff or the whole contract if deemed fit by assigning reasons thereof to the service provider.
13. OPTION CLAUSE : The purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserve the right to increase the ordered quantity by upto 25% of the contracted A quantity during the currency of the contract at the contracted rates. Bidder are bound to accept the orders accordingly.
14. The persons deployed by the service provider shall not claim nor shall be entitled to pay, perks and other facilities admissible to regular / confirmed employees of the A&N Administration during the currency or after expiry of the Agreement.
15. The staffs so engaged must have the ID Cards issued by the contractor at all time failing which they shall not be allowed to enter the official premises where they have been deputed.
16. No medical facilities or reimbursement or any short of medical claims thereof in respect of employees provided by the service provider will be entertained by the buyer.
17. The staffs so engaged must maintain absolute integrity towards the department and must not indulge in any agitation / strikes /leaking of official document or data. If anyone found guilty, legal action will be initiated immediately.
18. The staff engaged must follow the official duty hours of 8 hours (excluding half an hour lunch break) as decided by the officer-in-charge. Unauthorised and unofficial works / absence during the working hours shall be viewed and dealt strictly.
19. In case minimum wages is revised by the A&N Administration / GOI, the same shall be paid to the contractor subject to satisfactory proof that the revised wages has been paid to the employees engaged.
20. The service provider shall ensure the payment of the employees within 7th days of the succeeding month through bank account only. The successful bidder shall also submit a copy of GST return, EPF, ESIC to the Director of Health Services, Port Blair or concerned DDOs alongwith the bills.
21. Duration of the service contract may be extended upto 3 months beyond the initial contract duration (Subject to satisfactory performance and mutual consent).
22. The bidder shall depute only experienced Data Entry Operators. The Buyer shall conduct a trade test of the deputed personnel prior to their deployment.
23. If the firm fails to abide the terms and conditions of the contract, the firm will be blacklisted for 02 years.
24. The agreement which shall be signed between the Director of Health Services, Port Blair, A&N Administration and the successful bidder after successful award of the contract on GeM Portal shall always be in-force and must be adhered to in full spirit strictly failing which necessary administrative and legal action shall be initiated.

**Bidders shall upload only those documents that are specified in the bid documents. No additional documents will be accepted after the opening of the technical bid. Any unwanted or irrelevant documents will not be entertained.**

## अस्वीकरण/Disclaimer

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.

9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.

17. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. जेम की सामान्य शर्तों के खंड 26 के संदर्भ में भारत के साथ भूमि सीमा साझा करने वाले देश के बिडर से खरीद पर प्रतिबंध के संबंध में भारत के साथ भूमि सीमा साझा करने वाले देश का कोई भी बिडर इस निविदा में बिड देने के लिए तभी पात्र होगा जब वह बिड देने वाला सक्षम प्राधिकारी के पास पंजीकृत हो। बिड में भाग लेते समय बिडर को इसका अनुपालन करना होगा और कोई भी गलत घोषणा किए जाने व इसका अनुपालन न करने पर अनुबंध को तत्काल समाप्त करने और कानून के अनुसार आगे की कानूनी कार्रवाई का आधार होगा।/In terms of GeM GTC clause 26 regarding Restrictions on procurement from a bidder of a country which shares a land border with India, any bidder from a country which shares a land border with India will be eligible to bid in this tender only if the bidder is registered with the Competent Authority. While participating in bid, Bidder has to undertake compliance of this and any false declaration and non-compliance of this would be a ground for immediate termination of the contract and further legal action in accordance with the laws.
