1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.

2. Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM of the product offered in the bid {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU for number of Financial years as indicated above in the bid document before the bid opening date. Copies of relevant contracts and delivery acceptance certificates like CRAC to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this criterion.

3. Past Performance: The Bidder or its OEM {themselves or through re-seller(s)} should have supplied same or similar Category Products for 50% of bid quantity, in at least one of the last three Financial years before the bid opening date to any Central / State Govt Organization / PSU. Copies of relevant contracts (proving supply of cumulative order quantity in any one financial year) to be submitted along with bid in support of quantity supplied in the relevant Financial year. In case of bunch bids, the category related to primary product having highest bid value should meet this criterion.

**क्रेता द्वारा जोड़ी गई बिड की विशेष शर्तें/Buyer Added Bid Specific Terms and Conditions**

**1. Generic**

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be  $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$ , subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

**2. Sample Clause**

After award of contract - Successful Bidder shall have to get advance sample approved from buyer before bulk manufacturing / starting bulk supplies. Successful Bidder shall submit

samples for Buyer's approval, within 7 days of award of contract. Buyer shall, as per contract specifications

framework, either approve the advance sample or will provide complete list of modification required in the sample within 7 days of receipt of advance sample. Seller shall be required to ensure supply as per approved sample with modifications as communicated by Buyer. If there is delay from buyer side in approval of advance sample – the delivery period shall be refixed without LD for the period of delay in sample approval. In case, the sample is found to have major deviations / not conforming to the Contract specifications, the buyer at its discretion may call for fresh samples for approval before allowing bulk supplies or may terminate the contract after notifying the deviations to the seller.

Unless otherwise provided in the contract, all samples required for test shall be supplied by the contractor free of cost. Where under the contract, the contractor is required to submit an advance sample, any expenses incurred by the contractor on or in connection with the production of stores in bulk, before the sample has been approved unconditionally shall be borne by the Seller and he shall not claim any compensation in the event of such sample being found unacceptable by the Buyer / Consignee.

### 3. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

1. The bidder must first upload necessary documents on the GeM portal. Necessary documents will be reviewed first. Bidders whose documents are incomplete will be declared ineligible.
2. In order to upload the bidding online on the GEM portal, it is mandatory to attach the following documents :-
  01. Copy of the live GST registration form 06/25.
  02. Copy of the PAN card and Aadhaar card.
  03. Copy of the income tax return for the last year.
  04. Copy of the experience certificate/ purchase order for supplying bid required materials to a government institution for 3 years.
  05. Turnover proof of the Bidder firm.
  06. Valid registration certificate of FSSAI Act 2006.
  07. EMD as Desired.
3. As per regulations, GST and TDS deductions will be made on payments to creditors.
4. The successful bidder must deliver the materials at the jail gate at their own expense. The materials will be tested at the jail gate. If the materials do not meet the specified standards, rejected materials must be immediately taken back.
5. If necessary, the goods may be sent for chemical testing. If the quality of the goods sent for testing is found not to meet the standards, the bidder and their firm will be declared ineligible for bidding, and their bid and purchase order will be canceled.
6. The Superintendent of Central Jail, Ambikapur, reserves the right to cancel bids on the GeM portal without providing reasons, and no correspondence will be entertained in this regard. The decision of the Superintendent will be final and binding for all bidders.
7. No conditions from the bidders will be accepted on the GeM portal.
8. In addition to the above-mentioned conditions, if any rules/conditions are issued at the government level before the bid meeting date, they must be adhered to.
9. The bidding process will be conducted online through the GeM portal.
10. The rates for the materials mentioned in the bid will include all taxes; no additional taxes will be payable separately.
11. The payment for the supply is subject to availability of funds and clearance of claims of government treasuries.
12. Bidder will follow the rules and procedures of GeM.
13. The bill must be placed in the name of the Jail Superintendent, Central Jail Ambikapur.

14. The successful bidder has to submit an agreement for supply of goods with such terms and condition to buyer in notarized non-judicial stamp of Rs.100 as per regulations. The expense shall be borne by the supplier firm.
15. The bidder must not have a history of involvement in any criminal activities and no cases shall be registered against him and he should not be held guilty of any offence. He should submit notarized affidavit in non judicial stamp of 100 rupees in this regard. Any submission of false document can lead to cancellation of bidder's participation and he shall be disqualified.
16. Successful bidder must submit an additional Ten percent value of total goods quoted as Security Deposit as per Rule 10 of Chhattisgarh Jail Supply Rules 1968. Earnest Money Deposit in the form of Demand Draft in the name of Jail Superintendent Central jail Ambikapur from authorized bank.
17. The quantity and number of goods can be increased or decreased as per requirement of buying authority. Also the goods shall be procured on monthly requirement basis.
18. Earnest money deposit (EMD) is mandatory for all bidders.
19. Earnest Money Deposit will not be accepted in cash. Bidder can submit an Earnest Money Deposit in the form of Demand Draft in the name of Jail Superintendent Central jail Ambikapur from authorized bank. Also the bid number shall be mandatorily written on the Demand Draft. The copy of the same has to be uploaded on the GEM portal and the original copy must be submitted at the office of Superintendent Central jail Ambikapur before Two days of closing of the bid. The earnest money deposit of only successful bidder will be retained and the deposit of rest of the bidders will be returned after opening/finalization of the tender.
20. The rates quoted by the successful bidder shall remain valid for a period of one year or until the tender is approved, whichever is earlier.
21. The tender may be cancelled at any time without assigning any condition or reason.
22. The materials supplied must be of high quality.
23. All documents must be accurate, complete and self-attested as applicable. Incomplete submissions will be rejected.
24. The Original certificate issued by the Superintendent Of Police office in the Year of 2026 to prove that the person has not been involved in any criminal activity will have to be uploaded on the Gem portal.

## अस्वीकरण/Disclaimer

The Additional Terms and Conditions (ATC) have been incorporated by the Buyer after approval of their Competent Authority. The Buyer, is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any restriction arising in the bidding process due to these ATCs and including the modification of technical specifications and / or terms and conditions governing the bid. All representations / grievances pertaining to the ATC clauses shall be raised with the buyer organization directly and not with GeM. If any of the clause(s) is/are incorporated by the Buyer regarding the following, the bid & resultant contract shall be treated as null & void. Further, GeM reserves the right, at its sole discretion, to cancel the bid forthwith, without issuance of any prior notice or intimation :-

1. Publishing Custom / BOQ bids for items for which regular GeM categories are available (unless such Custom / BOQ item is bunched with the major regular product Category Item).
2. Mandating procurement of / from specific Brand / Make / Model / Manufacturer / Dealer except in case of Single Bid / Proprietary Article Certificate (PAC) Buying.
3. Inclusion of disqualification criteria related to suspension of seller / service provider, where such

suspension period has already expired.

4. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
5. Publishing bids on GeM for procurement of works.
6. Procurement of Goods by creating a Service bid on GeM & vice-versa.
7. Seeking sample with bid or approval of samples during bid evaluation process. However, trial / sample, as the case may be, shall be permitted in cases where trial / sample are allowed as per approved and published procurement policy of the Buyers' controlling Ministry / Department / State / Public Sector Enterprises Headquarters. If there is any violation of trial / sample clause with regard to approved policy of the Buyers' Ministry / Department / State / Public Sector Enterprises Headquarters, then this is to be determined and redressed by the concerned Buyer Organisation only.
8. Seeking experience from specific organization / department / institute only or from foreign / export experience.
9. Creating bid for items from incorrect categories.
10. Reference of conditions published on any external site or reference to external documents/clauses.
11. Asking for any Tender fee / Bid Participation fee, as the case may be.
12. Buyer added ATC Clauses which are in contravention of clauses defined in bid detail section, including specifications, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by the applicable GeM GTC.
13. Any ATC clause in contravention with GeM GTC Clause 4 (xiii) (h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
14. In a category based bid, adding additional items, through buyer added, additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogues or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

**All GeM Sellers/Service Providers shall ensure full compliance with all applicable labour laws, including the provisions, rules, schemes and guidelines under the four Labour Codes i.e. the Code on Wages, 2019; the Industrial Relations Code, 2020; the Occupational Safety, Health and Working Conditions Code, 2020; and the Code on Social Security, 2020 as and when notified and brought into force by the Government of India.**
