##### 1. Special Terms and Conditions for Hopper Tipper Dumper for Garbage

1. This category is created to cater to the requirement of buyer for procurement of Hopper Tipper for garbage collection. This category is a **BID-ONLY Category**, and procurement will occur exclusively through the bidding process.

2. The detailed specifications for the fabricated tipper container is to be defined by the buyer in the bid. These may include the following parameters :

1. Dimensions of garbage tipper container
2. Grade of material to be used for tipper construction
3. Payload Capacity defined in the category is the total of weight of container body and weight of material to be carried. Buyer may like to define minimum container weight required as per the selected tipper container capacity/volume (cubic meters). Additionally, Buyers may estimate the weight of the material based on the density of the waste intended to be collected. Based on these two inputs- container weight and weight of material to be carried, payload capacity may be selected while creating the bid.
4. Minimum gross vehicle weight of chassis to be allowed for the required tipper.

3. Buyer may seek Chassis / Original Vehicle Manufacturer's authorization from Body Builders in the bid.

Seller shall notify the Buyer through e-mail about readiness of goods for pre-dispatch inspection and Buyer will notify the Seller about the Authorized Representative/ Nominated External Inspection Agency and the date for testing. The goods would be dispatched to consignee only after clearance in pre-dispatch inspection. Consignee's right of rejection as per GTC in respect of the goods finally received at his location shall in no way be limited or waived by reason of the goods having previously been inspected, tested and passed by Buyer/ Consignee or its Nominated External Inspection Agency prior to the goods' shipment. While bidding, the sellers should take into account 7 days for inspection from the date of email offering the goods for inspection. **35. Warranty**
