1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
2. Years of Past Experience required: The bidder must have experience for number of years as indicated above in bid document (ending month of March prior to the bid opening) of providing similar type of services to any Central / State Govt Organization / PSU. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.
3. Purchase preference to Micro and Small Enterprises (MSEs) from the State of Bid Inviting Authority: Purchase preference will be given to MSEs as Micro and Small Enterprises from the State of Bid Inviting Authority. If the bidder wants to avail the Purchase preference, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+15% of margin of purchase preference /price band defined in relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price.
4. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and

based on competitive prices received in Bid / RA process.

2. **Service & Support**

AVAILABILITY OF OFFICE OF SERVICE PROVIDER: An office of the Service Provider must be located in the state of Consignee. DOCUMENTARY EVIDENCE TO BE SUBMITTED.

3. **Service & Support**

Dedicated /toll Free Telephone No. for Service Support : BIDDER/OEM must have Dedicated/toll Free Telephone No. for Service Support.

4. **Service & Support**

Escalation Matrix For Service Support : Bidder/OEM must provide Escalation Matrix of Telephone Numbers for Service Support.

5. **Service & Support**

The Service Provider is required to have at least 10 % of the required manpower on service provider's payroll for at least one year. Necessary documents relating to such manpower will be uploaded by the bidder for verification of the buyer. Such manpower will be part of total manpower to be provided by the Service Provider in case he gets the contract against this bid.

6. **Payment**

PAYMENT OF SALARIES AND WAGES: Service Provider is required to pay Salaries / wages of contracted staff deployed at buyer location first i.e. on their own and then claim payment from Buyer alongwith all statutory documents like, PF, ESIC etc. as well as the bank statement of payment done to staff.

A. Additional Terms and Conditions

1. Agency must provide experience and qualified person in same field (run ning contract or recent end contract on priority base) to district planning office.
2. The agency should have 11 months experience in same type of **MAN POWER CATEGORY**.
3. 3% of Estimated Contract Values of EMD shall be submitted in the form o f Demand Draft.
4. The Work order shall be given initially for a period of 6 months from the date of award. Then after examination of the performance and found satis factory of the agency, this contract may be renewed furthermore 11 mont hs.
5. As per the approval of NITI Aayog, the requirement of the office, this cont ract shall be extended till 2 (two) years on the same terms and conditions as mentioned in the tender document.

B. Documentary Evidence Required in Bid Submission

Eligibility Criteria for Bidder: (Experience work Order copy from any department of Government of Gujarat)

The Bidder should have executed order of supply/ provision of **same MAN POWER CATEGORY with same type of Functional Profile** of Bid Document during last 3 financial years (i.e. current year and three previous financial years) as on opening of bid, as per following:

- (A) Single Order of at least 100% of tendered value in same man power Category of Bid Document
 - Or
 - (B) Two Orders of at least 50% each of tendered value in same man power Category of Bid Document.
2. Documentary Evidence of Educational Qualification and Computer Knowledge for the proposed outsourcing post in the Bid should be submitted.
 3. Ownership/Lease document or any other proof of Office locally in district PANCHMAHAL.
 4. C.A. Certificate for turnover should be submitted along with Audit Reports. (Last 3 years)
 5. Bidder must provide Latest ISO certificate.
 6. Bidder must provide Escalation Matrix of Telephone Numbers for Service Support.
 7. Bidder must provide UNDERTAKING that the company is not be under liquidation, court receivership or similar proceedings, should not be bankrupt.
 8. Bidder must provide Copy Of Certificate For Incorporation/Registration Of Bidding Entity Under Appropriate Act/Authority In India
 9. Only Sellers, who have fulfilled the eligibility criteria in Technical Evaluation, will be evaluated further for Financial Evaluation.
 10. All the bidders shall have to submit supporting documents in the prescribed index with page number and respective annexure. The bidders shall have to give page number to every document and make reference of Page number in Index as well as respective annexures.

C. EDUCATIONAL QUALIFICATION AND EXPERIENCE

Aspirational Block Fellow (AB Fellow)

- 2) Should possess data analysis and presentation skills
- 3) Should be conversant with use of social media

- 7) Knowing the local language of the respective aspirational block is a requirement for Aspirational Block Fellows.

Note: Preference will be given to candidates who have completed their higher education in the development/rural stream.

Scope of Work (AB Fellow): -

- All work related to implementation of Aspirational Block Programme.
- Assist Block level Officials in designing and implementing strategies for accelerated development

across ABP thematic areas.

- Facilitate data-driven planning to ensure optimal resource allocation and utilization.
- Strengthen monitoring and evaluation mechanisms to track progress effectively.
- Foster greater community engagement and participation in developmental initiatives.
- Empower local stakeholders with knowledge, skills, and capacity building.
- Should possess Project Management Skills
- Experience of working/internship with a Development Organisation
- Self-driven with good communication skills.
- Knowing the local language of the respective Aspirational Block is a requirement for all Aspirational Blocks Fellows.
- Note: Preference will be given to candidates who have completed their higher education in the development/rural stream.

Role of Aspirational Blocks Fellows:

- The Aspirational Blocks Fellows will be positioned as a critical link between the Block level Officials and NITI Aayog. Their primary responsibilities will include:
 - Collaborating with Block level Officials to design and execute development strategies aligned with ABP thematic areas.
 - Conducting regular field visits to assess project implementation, address challenges, and collect ground-level insights.
 - Analyzing data and providing evidence-based recommendations to BLOs, District level Officials to optimize developmental initiatives.
 - Organizing workshops, awareness campaigns, and skill-building programs to empower the local community
 - Keeping States and NITI abreast with the issues, challenges and need for support.

Tenure of AB Fellows:

The tenure of Aspirational Blocks Fellows will initially span one year, during which they will actively engage with Block level Officials to drive developmental initiatives and empower local communities. Recognizing the potential for sustained impact, the program allows for a one-year extension of the fellowship, contingent upon the fellow's satisfactory performance and demonstrated contributions to the program's objectives, as determined by the State Governments.

अस्वीकरण/Disclaimer

The Additional Terms and Conditions (ATC) have been incorporated by the Buyer after approval of their Competent Authority. The Buyer is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any restriction arising in the bidding process due to these ATCs and including the modification of technical specifications and / or terms and conditions governing the bid. All representations / grievances pertaining to the ATC clauses shall be raised with the buyer organization directly and not with GeM. If any of the clause(s) is/are incorporated by the Buyer regarding the following, the bid & resultant contract shall be treated as null & void. Further, GeM reserves the right, at its sole discretion, to cancel the bid forthwith, without issuance of any prior notice or intimation :-

1. Publishing Custom / BOQ bids for items for which regular GeM categories are available (unless such Custom / BOQ item is bunched with the major regular product Category Item).
2. Mandating procurement of / from specific Brand / Make / Model / Manufacturer / Dealer except in case of Single Bid / Proprietary Article Certificate (PAC) Buying.
3. Inclusion of disqualification criteria related to suspension of seller / service provider, where such

suspension period has already expired.

4. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
5. Publishing bids on GeM for procurement of works.
6. Procurement of Goods by creating a Service bid on GeM & vice-versa.
7. Seeking sample with bid or approval of samples during bid evaluation process. However, trial / sample, as the case may be, shall be permitted in cases where trial / sample are allowed as per approved and published procurement policy of the Buyers' controlling Ministry / Department / State / Public Sector Enterprises Headquarters. 8. Seeking experience from specific organization / department / institute only or from foreign / export experience.
9. Creating bid for items from incorrect categories.
10. Reference of conditions published on any external site or reference to external documents/clauses.
11. Asking for any Tender fee / Bid Participation fee, as the case may be.
12. Buyer added ATC Clauses which are in contravention of clauses defined in bid detail section, including specifications, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by the applicable GeM GTC.
13. Any ATC clause in contravention with GeM GTC Clause 4 (xiii) (h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
14. In a category based bid, adding additional items, through buyer added, additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogues or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers/Service Providers shall ensure full compliance with all applicable labour laws, including the provisions, rules, schemes and guidelines under the four Labour Codes i.e. the Code on Wages, 2019; the Industrial Relations Code, 2020; the Occupational Safety, Health and Working Conditions Code, 2020; and the Code on Social Security, 2020 as and when notified and brought into force by the Government of India.
