1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$, subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

2. Scope of Supply

Scope of supply (Bid price to include all cost components) : Supply Installation Testing Commissioning of Goods and Training of operators and providing Statutory Clearances required (if any)

3. Turnover

5. **Service & Support**

Availability of Service Centres: Bidder/OEM must have a Functional Service Centre in the State of each Consignee's Location in case of carry-in warranty. (Not applicable in case of goods having on-site warranty). If service center is not already there at the time of bidding, successful bidder / OEM shall have to establish one within 30 days of award of contract. Payment shall be released only after submission of documentary evidence of having Functional Service Centre.

8. **Certificates**

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

9. **Certificates**

ISO 9001: The bidder or the OEM of the offered products must have ISO 9001 certification.

10. **Certificates**

The bidder is required to upload, along with the bid, all relevant certificates such as BIS licence, type test certificate, approval certificates and other certificates as prescribed in the Product Specification given in the bid document.

11. **Buyer Added Bid Specific ATC**

Buyer Added text based ATC clauses

1 All necessary certificates and proofs of experience/financial capacity to be up loaded along with the Bid.

2 If the bidder is an authorized re-seller/dealer/ Service provider of OEM or submitting the bid on behalf of OEM, then MAF is necessary. Manufacturer's Authorization Form should be bid specific and should be uploaded.

3 After delivery, Installation and testing, the vendor will have to register the product with the respective OEM and confirm genuineness of the product and warranty.

4 Payment will be done after successful installation, testing, commissioning and submission of bank guarantee for covering the Warranty period +2 months. Payment will be done by NEFT/RTGS.

5 Once the Successful bidder is awarded the PO/Work order, the bidder will have to execute the same and supply the goods within deadline, failing which an appropriate legal action will be initiated against him/her, if necessary.

6 If the Unit cost is below Rs 3 lakh then the Warranty should be 2 years from the date of installation and final acceptance. If the Unit cost is more Rs 3 lakhs and up to Rs 7 lakhs, then the Warranty should be 3 years from the date of installation and final acceptance. If the Unit cost is more than Rs 7 lakhs and above, then the Warranty should be 5 years from the date of installation and final acceptance.

7 Supplier should provide the Pre order/delivery Verification/inspection of the equipment at supplier's cost. Authority reserves the rights to accept or reject the bid based on Pre order verification/inspection.

8 The cost of Pre order verification/inspection should be borne by the bidder.

9 The bidder must have a registered office and service Centre in the state of Maharashtra and preferably at a near place to consignee location. A declaration with detailed address of office and service Centre and Bi

dder/OEM must provide Escalation Matrix , Telephone Numbers/ Toll Free numbers for Service Support.

10 The bidder should have experience of supply to Governments / Semi Government organizations either Central Govt. or State Govt. or Govt. Undertaking etc. especially in Maharashtra based offices. Proof should be attached.

11 Failing to submit any supporting document, the bidder will be declared DISQUALIFIED during Technical Scrutiny.

14 If shortage or breakage has been reported, the goods should be replaced at bidder own cost. Any service call should be attended within 48 hrs. otherwise penalty and losses shall be applicable as per govt. rules and warrantee will be automatically extend for the breakdown period.

15 GSTN registration Number & certified copy of GST paid clearance certificate up to last three financial years.

16 Attested copy of last three financial years ITR, Balance sheet etc. certified by the Competent Authority.

17 "Technical specifications of every equipment quoted should be typed & signed on separate sheet. It must match with asked specifications and original technical leaflets and pamphlets / brochure.
