2. 6. Years of Past Experience required: The bidder must have experience for number of years as indicated above in bid document (ending month of March prior to the bid opening) of providing similar type of services to any Central / State Govt Organization / PSU. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.
7. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price. The buyers are advised to refer to the [OM\\_No.1\\_4\\_2021\\_PPD\\_dated\\_18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if the credentials of the service provider are validated on-line in GeM profile as well as validated and approved by the Buyer after evaluation of submitted documents.
8. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and

based on competitive prices received in Bid / RA process.

### 1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

### 2. Generic

**Bidder financial standing:** The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.

### 3. Generic

1. The Seller shall not assign the Contract in whole or part without obtaining the prior written consent of buyer.
2. The Seller shall not sub-contract the Contract in whole or part to any entity without obtaining the prior written consent of buyer.
3. The Seller shall, notwithstanding the consent and assignment/sub-contract, remain jointly and severally liable and responsible to buyer together with the assignee/ sub-contractor, for and in respect of the due performance of the Contract and the Sellers obligations there under.

### 4. Service & Support

AVAILABILITY OF OFFICE OF SERVICE PROVIDER: An office of the Service Provider must be located in the state of Consignee. DOCUMENTARY EVIDENCE TO BE SUBMITTED.

### 5. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

### 6. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

1. The Service Provider/ Travel Agency should be registered with the appropriate government department/authorities. The copies of registration document of the vehicles to be provided should be submitted along with the quotation. The Office of the Service Provider/ Travel Agency must be within Birbhum, West Bengal (Documentary evidence to be submitted at the time of submission of this bid).

2. The contract will be initially for 01 (one) year and vehicle should be stayed at office premises 24\*7.
3. The vehicle services will be required for deployment within the jurisdiction of West Bengal and the vehicle should be registered in West Bengal State.
4. All expenses/charges of the driver, oil, fuel (Petrol/Diesel/CNG), Insurance, taxes, repairs, Toll taxes and maintenance etc., of the vehicle, by whatever name called will be borne by the Service Provider/ Travel Agency.
5. The Bid estimated value will inclusive of all taxes.
6. The monthly bill will be submitted for the hire charges for distance of 2,000 Kms on or before the next month and payment will be made accordingly.
7. The duty hours for the driver and vehicle and will be normally from 8:00 AM to 7:00 PM all days. In case of emergency, driver can be retained for 24 hours duty.
8. In case of accident /fine due to violation of traffic rules, all the claims arising shall be met by the Travel Agency only.
9. In case of service not provided on any day(s) for any reason, the monthly charges shall be paid after deducting the amount for the number of day(s) service not provided on pro-rata basis.
10. In case of any CNG vehicle(s) provided by the travel agency, petrol/diesel vehicles may be provided in lieu of CNG vehicle(s) for outstation duties.
11. Outstation Night Charges will not be applicable.
12. The driver should be well mannered, experienced, well uniformed and must carry a mobile phone (at the cost of the seller). The driver should pose a valid driving license for LMV.
13. The driver and the vehicle must comply with all the provisions of the Motor Vehicle Act and other relevant laws. His services will be subject to satisfaction of the controlling officer.
14. The vehicle hire agreement can be terminated by either party after serving 30 days advance notice on the other party.
15. For the purpose of calculating the hire charges payable, log book shall be provided along with vehicle. Form of log book will be the same as maintained by the Central Government department for their official vehicle. The log book shall be maintained and it should be verified on monthly basis. After the completion of contract, the log book shall be deposited to the office/buyer.
16. No request for enhancing the rate /rental amount per km due to hike in fuel price, insurance payment, rise in cost-of-living index etc. during the contract period will be allowed.
17. The office/buyer reserves the right to accept or reject any quotation without assigning any reason; the decision of the office/buyer is final.
18. The service provider/contractor shall be responsible for paying wages at the rates not less than the minimum wages as notified by the Appropriate Government.
19. The Service Provider shall nominate a coordinator/ Single Point of Contact (SPOC) who shall be responsible for regular interaction with the Buyer Department so that optimal services of the persons deployed could be availed without any disruption.

20. The Bidder should not have been blacklisted or debarred by any Central/State Government /agency of Central/State Government/Public Sector Undertaking/Regulatory Authority of India at the time of submission of this bid.

21. The Government servant and his relative involved in bidding directly or indirectly shall not be considered / entertained.

12. Buyer added ATC Clauses which are in contravention of clauses defined in bid detail section, including specifications, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by the applicable GeM GTC.
13. Any ATC clause in contravention with GeM GTC Clause 4 (xiii) (h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
14. In a category based bid, adding additional items, through buyer added, additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogues or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.
