If the bidder is a Micro or Small Enterprise as per latest orders issued by Ministry of MSME, the bidder shall be relaxed from the eligibility criteria of "Experience Criteria" as defined above subject to meeting of quality and technical specifications. The bidder seeking Relaxation from Experience Criteria, shall upload the supporting documents to prove his eligibility for Relaxation.
2. If the bidder is a Micro or Small Enterprise (MSE) as per latest orders issued by Ministry of MSME, the bidder shall be relaxed from the eligibility criteria of "Bidder Turnover" as defined above subject to meeting of quality and technical specifications. 4. 6. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.

7. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price. 1. Generic

OPTION CLAUSE 25% : The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, the contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration.

For lumpsum-based service contracts, the buyer may increase the scope of work and contract value up to 25 percent with the consent of the service provider

2. Buyer Added Bid Specific ATC

ATC

1. Past Experience. Service provider should have past experience in similar works as per CVC guidelines as follows: -

1.1 Number of years for validity of check - 3 years prior to current financial year, viz with effect from FY 2022-23.

1.2 Value of work executed to be as under:-

1.2.1 One similar work of 80% of tender value.

OR

1.2.2 Two similar works of 50% of tender value.

OR

1.2.3 Three similar works of 40% of tender value.

1.3 Value of work will be checked for individual trade, viz separate for fitter in water supply installation and electrician in HT/LT installation works.

1.3 Scope of executed works to be as per stipulations given in terms and conditions of concerned government department/ private company as per executed contract. The same contract (s) to be uploaded for reference.

2. Electrical License. Vendors should engage electricians for HT/LT installation and have valid electrical license of required class from Rajasthan/any other state.

3. Labour License. The service provider will be required to submit copy of valid labour license, within fifteen days of commencement of work. If the contractor fails to submit the same within the stipulated period, the contract shall be liable to be cancelled and the Performance Security of the firm shall be forfeited accordingly.

4. MSE Purchase Preference. Bidders availing exemption towards purchase preference shall upload valid MSE registration certificate registered under National Industry Code as per corresponding requirement (applicable) in scope of work as follows:-

- 4.1 Conservancy staff 8110 & 8121
- 4.2 Electricians 35109
- 4.3 Water Supply (fitter) 3600
- 4.4 Electricians/ Ref Mech for air conditioning 35302

Bidders not registered under relevant NIC codes shall not be allowed for this exemption and shall not be eligible for purchase preference.

5. Provident Fund. EPF/ UAN (Universal Account Number) for each workman shall be mandatory for each successful bidder.

6. LIN. Labour Identification Number will be mandatory for each successful bidder. Vendor is required to follow all the labour laws & related laws & provisions for engaging labour.

7. Terms and Conditions specific to MES are as attached as PDF.

8. The following additional requirement from the bidder has to be ensured.

8.1 Contractor shall submit monthly EPF Challan copies by a 10th of every month, if applicable. Penalty clause will be applicable as per the Act in case of delay, failing Rs 500/- day/per person. As such, GE being the principal Employer is responsible for EPF compliance of outsourced manpower.

8.2 The Contractor shall pay the full monthly wages to all the deployed personnel through bank transfer only to their individual salary accounts. Salaries to be disbursed monthly by the contractor to each employee latest by 7th of the month irrespective of RAR claim by the contractor.

8.3 No deduction or recovery from the wages shall be made by the Contractor or its representatives except statutory deductions like EPF, ESIC, TDS etc. As permitted by law.

8.4 Any instance of the contractor or its representative taking back wages (partly or wholly) from the worker, whether in cash or kind, shall be treated as a serious breach of contract.

9. Upon such breach being established by the Department, the department shall have the right to:-

- 9.1 Forfeit the performance Security.
- 9.2 Withhold or recover payments due to the Contractor.
- 9.3 Terminate the contract with immediate effect.
- 9.4 Recommend the contractor for blacklisting on GeM and other government platforms.
- 9.5 Report the matter to the concerned labour office/equivalent in State Govt. for further due diligence.

10. The department reserves the right to directly interact with deployed workers to verify actual wages receipt. Workers shall not be penalized or threatened for cooperating with such verification.

11. Charter of duties to be performed by outsourced staff as per the BOQ.

अस्वीकरण/Disclaimer

The Additional Terms and Conditions (ATC) have been incorporated by the Buyer after approval of their Competent Authority. The Buyer, is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any restriction arising in the bidding process due to these ATCs and including the modification of technical specifications and / or terms and conditions governing the bid. All representations / grievances pertaining to the ATC clauses shall be raised with the buyer organization directly and not with GeM. If any of the clause(s) is/are incorporated by the Buyer regarding the following, the bid & resultant contract shall be treated as null & void. Further, GeM reserves the right, at its sole discretion, to cancel the bid forthwith, without issuance of any prior notice or intimation :-

1. Publishing Custom / BOQ bids for items for which regular GeM categories are available (unless such Custom / BOQ item is bunched with the major regular product Category Item).
2. Mandating procurement of / from specific Brand / Make / Model / Manufacturer / Dealer except in case of Single Bid / Proprietary Article Certificate (PAC) Buying.
3. Inclusion of disqualification criteria related to suspension of seller / service provider, where such suspension period has already expired.
4. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
5. Publishing bids on GeM for procurement of works.
6. Procurement of Goods by creating a Service bid on GeM & vice-versa.
7. Seeking sample with bid or approval of samples during bid evaluation process. However, trial / sample, as the case may be, shall be permitted in cases where trial / sample are allowed as per approved and published procurement policy of the Buyers' controlling Ministry / Department / State / Public Sector Enterprises Headquarters. If there is any violation of trial / sample clause with regard to approved policy of the Buyers' Ministry / Department / State / Public Sector Enterprises Headquarters, then this is to be determined and redressed by the concerned Buyer Organisation only.
8. Seeking experience from specific organization / department / institute only or from foreign / export experience.
9. Creating bid for items from incorrect categories.
10. Reference of conditions published on any external site or reference to external documents/clauses.
11. Asking for any Tender fee / Bid Participation fee, as the case may be.
12. Buyer added ATC Clauses which are in contravention of clauses defined in bid detail section, including specifications, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by the applicable GeM GTC.
13. Any ATC clause in contravention with GeM GTC Clause 4 (xiii) (h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
14. In a category based bid, adding additional items, through buyer added, additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogues or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
