If the bidder is a Micro or Small Enterprise as per latest orders issued by Ministry of MSME, the bidder shall be exempted from the eligibility criteria of "Experience Criteria" as defined above subject to meeting of quality and technical specifications. The bidder seeking exemption from Experience Criteria, shall upload the supporting documents to prove his eligibility for exemption.
2. If the bidder is a Micro or Small Enterprise (MSE) as per latest orders issued by Ministry of MSME, the bidder shall be exempted from the eligibility criteria of "Bidder Turnover" as defined above subject to meeting of quality and technical specifications. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
6. Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM of the product offered in the bid {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU for number of Financial years as indicated above in the bid document before the bid opening date. Copies of relevant contracts and delivery acceptance certificates like CRAC to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this criterion.
7. OEM Turn Over Criteria: The minimum average annual financial turnover of the OEM of the offered product during the last three years, ending on 31st March of the previous financial year, should be as indicated in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the OEM is less than 3 year old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
8. Preference to Make In India products (For bids < 200 Crore): Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020. 9. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are

validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 25% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

10. Past Performance: The Bidder or its OEM {themselves or through re-seller(s)} should have supplied same or similar Category Products for 20% of bid quantity, in at least one of the last three Financial years before the bid opening date to any Central / State Govt Organization / PSU. Copies of relevant contracts (proving supply of cumulative order quantity in any one financial year) to be submitted along with bid in support of quantity supplied in the relevant Financial year. In case of bunch bids, the category related to primary product having highest bid value should meet this criterion.

11. Short Duration Bid has been published by the Buyer with the approval of the Competent authority due to Emergency procurement of critical products/services.

12. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting bidder. The technically qualified Highest Quoting bidder will not be allowed to participate in RA. However, H-1 will also be allowed to participate in RA in following cases:

- i. If number of technically qualified bidders are only 2 or 3.
- ii. If Buyer has chosen to split the bid amongst N sellers, and H1 bid is coming within N.
- iii. In case Primary product of only one OEM is left in contention for participation in RA on elimination of H-1.

1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery

time shall be $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$, subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

2. Service & Support

Availability of Service Centres: Bidder/OEM must have a Functional Service Centre in the State of each Consignee's Location in case of carry-in warranty. (Not applicable in case of goods having on-site warranty). If service center is not already there at the time of bidding, successful bidder / OEM shall have to establish one within 30 days of award of contract. Payment shall be released only after submission of documentary evidence of having Functional Service Centre.

3. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

1. System Compatibility:

The equipment offered by the bidder must be fully compatible with the existing Audio-Visual (AV) infrastructure already deployed in the Academy. It is the bidder's responsibility to ensure that all proposed hardware, software, control systems, and network interfaces can integrate seamlessly with the existing setup without requiring major modifications or additional components. Any incompatibility found after the contract is awarded will not be accepted.

2. Site Visit/Pre bid meeting:

Due to product customization and the presence of existing IT and AV infrastructure, all prospective bidders are requested to conduct a detailed site survey before submitting their bids. The purpose of this visit is to assess compatibility of the proposed solutions, identify any potential challenges, and understand the spatial and functional requirements of the installation areas. Site visit will serve as a platform to clarify the scope of work, technical specifications, and site-specific requirements. No claims for extra payments will be entertained after contract award due to misunderstandings that could have been clarified during site visit. **(In view of the security of the campus, interested bidder must take prior approval for visit camps through email dbsiddiq@svpnpa.gov.in or contact on 040-24234476)**

3. Responsibility for All Works:

The selected bidder will be fully responsible for the complete execution

ution of the project. This includes the supply, delivery, installation, configuration, integration, testing, and commissioning of all required AV, IT and electric component required for installation of the offered product. The scope also includes any civil works such as drilling or minor carpentry, any electrical works including power cabling or sockets, and any IT or networking activities necessary to complete the project. The bidder must arrange all tools, safety equipment, manpower, software licenses , and other resources necessary for timely and safe execution.

4. Certification of Product Support:

The bidder must **submit a certificate separately** from the original equipment manufacturer (OEM) or an authorized distributor confirming that the quoted equipment is the latest model in current production and is not nearing end-of-life. The certificate must also confirm that all quoted products will be supported with spare parts, firmware and software updates, and service facilities for a minimum of eight years after the expiry of the warranty period. This support may be on a chargeable basis or under an Annual Maintenance Contract.

5. OEM Authorization:

An OEM Authorization Certificate must be submitted along with the bid. The certificate must specifically reference this tender and confirm that the bidder is an authorized partner, dealer, distributor, or system integrator for the quoted products. It must further authorize the bidder to supply, install, and provide after-sales support for the said equipment. Failure to include this certificate may lead to rejection of the bid during technical evaluation.

6. Warranty Terms:

All equipment supplied must carry a minimum on-site warranty of **5 (five) years** from the date of successful installation and commissioning. During the warranty period, the bidder shall be responsible for attending to all faults and failures, providing technical assistance, and replacing or repairing any defective hardware or software components. Th

e bidder must also ensure the availability of firmware and software updates during this period. A dedicated point of contact must be assigned for handling warranty-related issues throughout the duration.

7. After-Sales Service Commitment:

The bidder must provide a **formal declaration separately** confirming their after-sales service commitment. The declaration must state that service support will be provided during both the warranty and post-warranty periods, whether on an AMC or chargeable basis, as decided by the Academy. The maximum permitted downtime for any equipment failure shall be four hours. In case of failure to restore service within this time, the Academy reserves the right to get the system repaired through a third party, and the cost incurred will be deducted from the Earnest Performance Bank Guarantee (EPBG) or any outstanding payment due to the bidder.

8. Local Service Support:

The bidder/OEM must have a fully operational service centre located in Hyderabad or elsewhere in Telangana. Proof of the service centre's address and contact details must be submitted with the bid. The service centre must be staffed with qualified technical personnel and must have the capacity to provide spare parts and maintenance support within the defined service levels.

9. Demonstration / Technical Presentation:

If desired by the Technical Purchase Committee, shortlisted bidders must be prepared to conduct a technical presentation explaining the proposed system, its architecture, key features, and implementation methodology. In addition, if desired by the TPC, a physical demonstration or Proof of Concept of critical components may be requested. The presentation or demonstration must be arranged at short notice and at the bidder's own expense. Demonstration must clearly show that the solution is capable of handling all input media. This includes compatibility with all types of laptops—both latest and older models, including Apple/Mac

Books—as well as iPads, mobile phones with varying screen resolutions , and different video input types such as HDMI, VGA, USB-C, wireless and Display Port or any other latest input option. The demonstration should confirm that the system functions seamlessly across all these devices.

10. Post-Delivery Inspection:

The buyer reserves the right to inspect and test the delivered equipment after installation and commissioning, even if the equipment has passed technical evaluation. Final acceptance will be granted only after the system is found to be fully functional, complies with all specified requirements, and performs satisfactorily under real-use conditions. The bidder must address any deficiencies at their own cost.

11. Training:

The selected bidder must provide hands-on training to the Academy's designated staff members. The training must cover complete system operation, user interface handling, basic troubleshooting, and regular maintenance tasks. Training must be provided on-site and should include instructional materials such as user manuals and quick reference guides. The objective is to ensure that staff can operate and manage the system independently after handover.

12. MII preference: As per the Government of India's Make in India (MII) policy, all bidders are required to ensure accurate **local value addition** before declaring themselves as **Class-I** or **Class-II local suppliers**. Certifications should not be submitted blindly for the purpose of gaining procurement preference. Please note that bidders offering imported products will fall under the category of non-local suppliers. They can't claim themselves as Class-I local suppliers/Class-II local suppliers by claiming the services such as transportation, insurance, installation, commissioning, training and after sales service support like AMC/CMC etc. as local value addition.

13. MSE Preference: All bidders seeking MSE preference under public procurement policy are requested to ensure possession of a valid MSME certificate. The bidder must be the **actual manufacturer of the offered product** and **must hold a valid MSME certificate under the manufacturing category.**

Merely acting as a supplier, trader, or reseller does not entitle the bidder to claim MSE preference benefits. **MSE preference is strictly applicable only to manufacturers of the quoted product**, as per prevailing Government of India guidelines.

14. Import of the above product or any of its components/accessories from countries subject to import bans or restrictions imposed by the Government of India (GOI), if any, is strictly prohibited.

LIQUIDATED DAMAGES /PENALTY CLAUSE:
