1. Preference to Make In India products (For bids < 200 Crore): Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. - d. Supply shall be made only to the consignee.

2. The Packages should be securely packed and **details regarding Purchase Order/GeM Contract**

**reference, complete address of Consignor/Consignee (with Contact details) should be clearly marked on all the packages.**

3. When dispatching multiple orders, **material of each order should be packed in separate package, and details regarding Order reference should be clearly marked.**
4. **OTP based deliveries are not possible** inside NRB/BARC/IGCAR/DAE Units. Hence dispatch of material shall be through standard transporters, **WITHOUT OTP.**
