1. If the bidder is a DPIIT registered Startup, the bidder shall be relaxed from the the eligibility criteria of "Experience Criteria" as defined above subject to their meeting of quality and technical specifications. The bidder seeking Relaxation from Experience Criteria, shall upload the supporting documents to prove his eligibility for Relaxation.
2. If the bidder is a DPIIT registered Startup, the bidder shall be relaxed from the the eligibility criteria of "Bidder Turnover" as defined above subject to their meeting of quality and technical specifications. If the bidder is DPIIT Registered OEM of the offered products, it would be relaxed from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. The bidder seeking Relaxation from Turnover shall upload the supporting documents to prove his eligibility for Relaxation.
3. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
4. Years of Past Experience required: The bidder must have experience for number of years as indicated above in bid document (ending month of March prior to the bid opening) of providing similar type of services to any Central / State Govt Organization / PSU. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.
5. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.
6. Past Experience of Similar Services: The bidder must have successfully executed/completed similar Services over the last three years i.e. the current financial year and the last three financial years(ending month of March prior to the bid opening): -
  1. Three similar completed services costing not less than the amount equal to 40% (forty percent) of the estimated cost; or
  2. Two similar completed services costing not less than the amount equal to 50% (fifty percent) of the estimated cost; or
  3. One similar completed service costing not less than the amount equal to 80% (eighty percent) of the estimated cost.

1. **Generic**

OPTION CLAUSE 25% : The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, the contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration.

For lumpsum-based service contracts, the buyer may increase the scope of work and contract value up to 25 percent with the consent of the service provider

**Technical Qualifying Criteria:**

1. Registration Certificate issued by the registering authority.
2. company/firm should have minimum 3 years experience in the same nature of work.
3. Goods and Services tax (GST) Registration No. from Govt. of India.
4. PAN card issued by the income Tax Departments.

**Terms and condition:**

1. Bidder must read all the instructions, terms, Conditions carefully before participating in the bid.
2. Bidder must have to submit all required document with their company Stamp and authorized Sign.
3. Bidder should be submitted in the specified bid documents only. If submit in any other form, incomplete in any form, the bid is liable to be rejected. If any bidder stipulates any condition, such conditional bid is liable to be rejected.
4. As this bid is for services, the location of the bidder must be close to the ITI DASHRATH VADODARA.
5. The validity of the bid/tender/quotation should be as per bid.
6. The ITI reserves the right to accept or reject any or all bid/ tender/quotations without assigning any reasons.
7. The contract is initially for a period of two year.
8. Fire NOC Renewal (2 year) with all type of Challan/Stamp cost are included in the contract.

9. The period of maintenance is valid for the same period as the issued N.O.C.
10. All the fire fighting equipments should be checked, serviced and tested thoroughly once in a period of quarterly intervals.
11. The contract does not include any kind of replacement of damaged parts and does not include the cost of reinstalling any missing parts. only consumable material included.
12. Cleaning and lubrication including polishing of all parts should be done once in a period of quarterly intervals with necessary lubricants at no extra costs.
13. The service bills will be issued after the completion of services and due certification by the office in charge of maintenance.
14. The contractor should conduct 2 training programmed per year, power point presentation in, the Auditorium and demonstration on fire drill to the trainee and staff of Industrial Training Institute, Dashrath, Vadodara.
15. The Rates quoted should be Inclusive of all Taxes and all other charges.
16. TDS will be deducted as per Govt. norms.
17. Before quoting the rate bidder may visit the site to judge the conditions of fire fighting system After that, the undertaking to perform mandatory work will have to be given.
18. The Jurisdiction shall be Industrial Training Institute Dashrath, Vadodara.
19. Minimum three visits are mandatory during the contract period of one year and additional visit as and when required.
20. It is understood that Bidder who once participate in this BID is agreed to all the terms and conditions kept for this BID, and terms and conditions related any query or argument are not entertained during any stage
21. The contractor will provide the above-mentioned services once in the contract period.

The Buyer is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any restriction arising in the bidding process due to these ATCs and including the modification of technical specifications and / or terms and conditions governing the bid. All representations / grievances pertaining to the ATC clauses shall be raised with the buyer organization directly and not with GeM. If any of the clause(s) is/are incorporated by the Buyer regarding the following, the bid & resultant contract shall be treated as null & void. Further, GeM reserves the right, at its sole discretion, to cancel the bid forthwith, without issuance of any prior notice or intimation :-

1. Publishing Custom / BOQ bids for items for which regular GeM categories are available (unless such Custom / BOQ item is bunched with the major regular product Category Item).
2. Mandating procurement of / from specific Brand / Make / Model / Manufacturer / Dealer except in case of Single Bid / Proprietary Article Certificate (PAC) Buying.
3. Inclusion of disqualification criteria related to suspension of seller / service provider, where such suspension period has already expired.
4. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
5. Publishing bids on GeM for procurement of works.
6. Procurement of Goods by creating a Service bid on GeM & vice-versa.
7. Seeking sample with bid or approval of samples during bid evaluation process. 9. Creating bid for items from incorrect categories.

11. Asking for any Tender fee / Bid Participation fee, as the case may be.
12. Buyer added ATC Clauses which are in contravention of clauses defined in bid detail section, including specifications, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by the applicable GeM GTC.
13. Any ATC clause in contravention with GeM GTC Clause 4 (xiii) (h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
14. In a category based bid, adding additional items, through buyer added, additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogues or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in

the bid details field in Seller dashboard after logging in as a seller. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
