BIDDER SHALL ENSURE THAT THE OFFER SHALL COMPLY RESTRICTION REGARDING PERSONNEL EMPLOYED AS MENTIONED IN RAILWAY BOARD LETTER No. No. 2017/EnHM/25/11.

2. All bidders must submit a valid GST Registration Certificate, clearly indicating the firm's type of entity/composition along with details of all stakeholders and submit the necessary credentials mentioned in the bid form along with Annexure-V and V(A) to reference -Para 6.1 of ITT. Work Done Certificates must contain complete details such as name of work, contractor, agreement value, completion period (including extensions), dates of commencement and completion/last paid bill, cumulative payments, penalties imposed, status of work, and performance remarks. Non-submission in prescribed format shall result in rejection of the bid without any representation.

3. Bidders must submit only relevant and limited documents, properly scanned and legible, strictly as required under the stated eligibility criteria. Submission of any irrelevant or unrelated documents that do not pertain to the specified eligibility criteria may result in rejection of the bid. No claims or representations from the bidder shall be entertained in such cases.

4. Bidders are advised to comply & submit all the relevant documents in desired format as required for fulfilling of minimum technical eligibility criteria as mentioned in tender terms & condition.

5. The Railway estimated rate are inclusive of all taxes & Duties enforced on Railway work (i.e., GST etc).

6. Railway reserves the right to verify all statements information and documents submitted by the bidder in his tender offer, and the bidder shall, when so required by the railway, make available all such information, evidence and documents as may be necessary for such verification.

7. Action will be taken as per enforced GCC provision & Railway board instructions on the bidder, in case of any incorrect information / documents submitted in support of credential. It may result the contract shall be terminated, Bid security / Earnest Money Deposit / Performance Guarantee / Security Deposit of contract will be forfeited by Railway and agency will be barred for doing business on entire Indian Railways for 5 (Five) years.

8. Railway reserves the right to validate authenticity of any document submitted by the bidder from its issuing authority. Contact details [Name/Designation/Official email/Mobile no.] of the issuing authority must be provided by the bidder failing which the offer will become liable for rejection.

9. Contract terms and conditions shall be governed by "GCC for Services" issued by Ministry of Railways.

10. The bidder shall submit valid certifications for ISO 9001:2015, ISO 22000:2018, ISO 45001:2018, ISO 14001:2015, and ISO 41001:2018 along with the bid. Bids not accompanied by these valid certifications shall be treated as non-responsive and will not be considered for evaluation.

The Buyer ,is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any restriction arising in the bidding process due to these ATCs and including the modification of technical specifications and / or terms and conditions governing the bid.All representations / grievances pertaining to the ATC clauses shall be raised with the buyer organization directly and not with GeM.If any of the clause(s) is/are incorporated by the Buyer regarding the following, the bid & resultant contract shall be treated as null & void. Further, GeM reserves the right, at its sole discretion, to cancel the bid forthwith, without issuance of any prior notice or intimation :-
