Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

2. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

3. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting bidder. The technically qualified Highest Quoting bidder will not be allowed to participate in RA. However, H-1 will also be allowed to participate in RA in following cases:

- i. If number of technically qualified bidders are only 2 or 3.
- ii. If Buyer has chosen to split the bid amongst N sellers, and H1 bid is coming within N.
- iii. In case Primary product of only one OEM is left in contention for participation in RA on elimination of H-1.
- iv. If L-1 is non-MSE and H-1 is eligible MSE and H-1 price is coming within price band of 15% of Non-MSE L-1
- v. If L-1 is non-MII and H-1 is eligible MII and H-1 price is coming within price band of 20% of Non-MII L-1

1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$, subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

2. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

Eligibility Criteria

- The bidder must have their own shop in North & Middle Andaman region (any relevant documentary evidence must be submitted).
- The bidder must possess a valid FSSAI licence/ registration certificate
- Bidding firms fulfilling the above criteria must mandatorily upload the following documents/certificates. Failure to do so will result in the rejection of the bid.
 - a. Shop registration certificate/ document
 - b. PAN card of the firm or proprietor/ partner
 - c. GST registration, if applicable
 - d. FSSAI (Form-C) A&N Administration Food Safety Standard Authority of India license/ registration certificate under FSSAI Act, 2006.
 - e. Other documents, if any.

Terms & Conditions

1. The quality of fish items & dressed chicken should be good/ fresh.
2. The fish items & dressed chicken should be supplied on the strength of the inmates lodged in the jail as per the requisition given by the storekeeper at main gate of District Correctional Home, Mayabunder.
3. The supply of fish items should be made twice weekly, resulting in a total of eight deliveries each month.
4. Dressed Chicken shall be supplied only on the following eleven designated festival days:
 - a. X-Mas
 - b. Diwali
 - c. GurunanakJayanti
 - d. Pongal
 - e. Id-UI-Zuha
 - f. Dusshera
 - g. Onam
 - h. Holi
 - i. Id-UI-Fitr
 - j. Independence Day

k. Republic Day

5. The bidder should carefully go through all the clauses and details indicated in the bid document before quoting the rates. No excuse that the conditions have not been read or understood will be entertained later.
6. The rate quoted by the firms for the items should be final inclusive of all taxes/ charges as applicable.
7. Revision of rates will not be allowed after opening of the bid.
8. The L1 shall be arrived at on the basis of the total amount quoted by the bidder in the bid and shall not be item wise.
9. The successful bidder shall submit a Performance Guarantee @ 5% of the total contract value within two weeks (14 days) from the date of award of the contract. The Performance Guarantee must be submitted in an acceptable form, drawn in favour of the Assistant commissioner, DCH Mayabunder from a commercial bank.
10. The validity period of the contract shall be 01 year from the date of award of contract. However, it may be extended for a further period of up to 03 months or till finalization of the new bid, whichever is earliest.
 11. No relaxation shall be allowed for delayed supply under any circumstances, except under force majeure conditions such as natural calamities, strikes, or other unforeseen events beyond the control of the supplier.
 12. It is the sole responsibility of the seller to deliver the items in good condition. If the fish items & dressed chicken are found spoiled the same should be replaced immediately with fresh items by the supplier without any additional cost.
 13. In case the suppliers fail to honour the commitment after acceptance of the contract this department will be liable to forfeit the performance security lying with us. More than one such default would also cause debarment & exclusion of such bidders and cease all transactions with the firm.
 14. The bid inviting authority at its discretion depending on the actual need of the department reserves the right to increase or decrease the quantity of the required items up to 25% without any change in the terms and conditions and prices quoted by the bidder. In full or in part from L1 bidder by stating reason do so.
 15. If the seller fails to deliver any or all of the items within the original/ re-fixed delivery period(s) specified in the contract, the buyer will be entitled to deduct/ recover the Liquidated Damages for the delay, unless covered under force majeure conditions, @0.5% of the contract value of delayed quantity per week or part of the week of delayed period as per-estimated damages not exceeding 10%

of the contract value of delayed quantity without any controversy/ dispute of any sort whatsoever.

16. The acceptance of bid will rests with Superintendent, DCH Mayabunder, which does not bind itself to accept the lowest rate or any bid, and reserve to itself full rights to reject any or all bids without assigning any reason thereof.
17. The bidder shall not sub-let or entrust the work to any other agency.
18. Advance payment will not be made under any circumstances.
19. The supplier shall submit the bills on the GeM portal in parts, upon completion of each respective month.
20. The supplier shall comply with all state, local & central laws, statutory rules, regulations etc. as applicable
21. Arbitration and Jurisdiction: Both the parties of the Agreement shall make every effort to resolve any disagreement or dispute arising between the parties or in connection with the Agreement amicably at the first instant. In case of failure, all disputes, controversies or claim between parties shall be referred for arbitration to the sole arbitrator to be appointed by Hon'ble Lt. Governor, A&N Islands for the purpose. The arbitration proceeding shall be held in accordance with the provisions of Arbitration and conciliation Act 1996. The venue of arbitration shall be at A&N Islands. In the event of failure through arbitration, the same shall be settled with the jurisdiction of competent court at A&N Islands.

अस्वीकरण/**Disclaimer**

The Additional Terms and Conditions (ATC) have been incorporated by the Buyer after approval of their Competent Authority. The Buyer, is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any restriction arising in the bidding process due to these ATCs and including the modification of technical specifications and / or terms and conditions governing the bid. All representations / grievances pertaining to the ATC clauses shall be raised with the buyer organization directly and not with GeM. If any of the clause(s) is/are incorporated by the Buyer regarding the following, the bid & resultant contract shall be treated as null & void. Further, GeM reserves the right, at its sole discretion, to cancel the bid forthwith, without issuance of any prior notice or intimation :-

1. Publishing Custom / BOQ bids for items for which regular GeM categories are available (unless such Custom / BOQ item is bunched with the major regular product Category Item).
2. Mandating procurement of / from specific Brand / Make / Model / Manufacturer / Dealer except in case of Single Bid / Proprietary Article Certificate (PAC) Buying.
3. Inclusion of disqualification criteria related to suspension of seller / service provider, where such suspension period has already expired.
4. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
5. Publishing bids on GeM for procurement of works.
6. Procurement of Goods by creating a Service bid on GeM & vice-versa.
7. Seeking sample with bid or approval of samples during bid evaluation process. 9. Creating bid for items from incorrect categories.

10. Reference of conditions published on any external site or reference to external documents/clauses.
11. Asking for any Tender fee / Bid Participation fee, as the case may be.
12. Buyer added ATC Clauses which are in contravention of clauses defined in bid detail section, including specifications, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by the applicable GeM GTC.
13. Any ATC clause in contravention with GeM GTC Clause 4 (xiii) (h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
14. In a category based bid, adding additional items, through buyer added, additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogues or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers/Service Providers shall ensure full compliance with all applicable labour laws, including the provisions, rules, schemes and guidelines under the four Labour Codes i.e. the Code on Wages, 2019; the Industrial Relations Code, 2020; the Occupational Safety, Health and Working Conditions Code, 2020; and the Code on Social Security, 2020 as and when notified and brought into force by the Government of India.

While participating in bid, Bidder has to undertake compliance of this and any false declaration and non-compliance of this would be a ground for immediate termination of the contract and further legal action in accordance with the laws.
