If the bidder is a Micro or Small Enterprise as per latest orders issued by Ministry of MSME, the bidder shall be relaxed from the eligibility criteria of "Experience Criteria" as defined above subject to meeting of quality and technical specifications. The bidder seeking Relaxation from Experience Criteria, shall upload the supporting documents to prove his eligibility for Relaxation.
2. If the bidder is a Micro or Small Enterprise (MSE) as per latest orders issued by Ministry of MSME, the bidder shall be relaxed from the eligibility criteria of "Bidder Turnover" as defined above subject to meeting of quality and technical specifications. 6. Years of Past Experience required: The bidder must have experience for number of years as indicated above in bid document (ending month of March prior to the bid opening) of providing similar type of services to any Central / State Govt Organization / PSU. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.

7. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price. The buyers are advised to refer to the [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if the credentials of the service provider are validated on-line in GeM profile as well as validated and approved by the Buyer after evaluation of submitted documents.

8. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price.

9. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

10. Past Experience of Similar Services: The bidder must have successfully executed/completed similar Services over the last three years i.e. the current financial year and the last three financial years(ending month of March prior to the bid opening): -

1. Three similar completed services costing not less than the amount equal to 40% (forty percent) of the estimated cost; or
2. Two similar completed services costing not less than the amount equal to 50% (fifty percent) of the estimated cost; or
3. One similar completed service costing not less than the amount equal to 80% (eighty percent) of the estimated cost.

11. Reverse Auction would be conducted amongst first 50% of the technically qualified bidders arranged in the order of prices from lowest to highest. Number of sellers eligible for participating in RA would be rounded off to next higher integer value if number of technically qualified bidders is odd (e.g. if 7 bids are technically qualified, then RA will be conducted amongst L-1 to L-4). In case number of technically qualified bidders are 2 or 3, RA will be between all without any elimination. If Buyer has chosen to split the bid amongst N sellers, then minimum N sellers would be taken to RA round. In case Primary products of only one OEM are left in contention for participation in RA based on lowest 50% bidders qualifying for RA, the number of sellers qualifying for RA would be increased to get at least products of one more OEM (directly participated or through its reseller) if available. Further, if bid(s) of any seller(s) eligible for MSE preference is / are coming within price band of 15% of Non MSE L-1 or if bid of any seller(s) eligible for Make in India preference is / are coming within price band of 20% of non MII L-1, then such MSE / Make in India seller shall also be allowed to participate in the RA process.

## 2. **Buyer Added Bid Specific ATC**

### **Pre-qualification [Criteria:-](#)**

1. The firm should have executed at least one supply order for subject service OR similar services i.e Outsourcing of Cable Manufacturing operations costing not less than Rs.04 Lakhs in past 03 years to any central govt., state govt., central PSU, Autonomous Bodies or any Ordnance Factories before bid submission end date. The firm has to submit copy of supply order along with documents supporting successful execution of the similar services.
2. The average turnover over the last three years should be at least Rs. 13 Lakhs minimum. The firm shall provide copies of profit loss statement/Turnover certificate duly certified by CA.
3. For claiming any exemption, firm should submit valid UDYAM/MSME Certificate.
4. Execution of subject service requires frequent visit of the firm even in odd hours. So for better coordination for service firms having their name, operational office in any of the following nearby cities only be allowed to participating this bid; **(Tricity) Chandigarh, Mohali, Panchkula**. 6. Turnover and past experience criteria is waived off for Start-ups/MSE firms.
7. All other terms and conditions will be as per GeM & OFBPM 2018.

### **B. OTHER TERMS AND CONDITIONS OF TENDER.**

- i. Quantum of service is 49832 km as per attached OFCd scope of work. Bidder are required to quote their lumpsum price in the instant GeM bid in consideration of above.
- ii. Payment and other terms and conditions will be as attached OFCd scope of work OFCD/WD/Stranding M/c /JWD dated 17/05/2025. Monitoring instruction mentioned in annexure-M shall be part of the tender. Firm should provide compliance with attached scope of work and signed copy all the requisite documents should be uploaded on GeM portal along with other documents.

iii. In case of non performance of the service as per attached OFCd scope of work, OFCd reserve the right to amend/cancel the order qty with penalty deemed fit as per OFBPM-2018.

iv. Execution of subject service will required frequent visit of the firm and apart from that firm may be required to visit as per OFCd on as and when basis for maintaining the qualitative output of the contracted service.

v. Participating firms are required to upload certificate of incorporation/Partnership deed/Proprietorship declaration as applicable along with other bid documents.

vi. All other terms and conditions as per OFBPM-2018 shall be applicable.

### 3. **Generic**
