This Bid provides for Trade Receivables Discounting System (TReDS) as Preferred mode of payment. 1. 3. Years of Past Experience required: The bidder must have experience for number of years as indicated above in bid document (ending month of March prior to the bid opening) of providing similar type of services to any Central / State Govt Organization / PSU. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.
4. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service

provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price. The buyers are advised to refer to the [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if the credentials of the service provider are validated on-line in GeM profile as well as validated and approved by the Buyer after evaluation of submitted documents.

5. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

6. Past Experience of Similar Services: The bidder must have successfully executed/completed similar Services over the last three years i.e. the current financial year and the last three financial years(ending month of March prior to the bid opening): -

1. Three similar completed services costing not less than the amount equal to 40% (forty percent) of the estimated cost; or

1. Generic

OPTION CLAUSE 50% : The buyer can increase or decrease the contract quantity or contract duration up to 50 percent at the time of issue of the contract. However, once the contract is issued, the contract quantity or contract duration can only be increased up to 50 percent. Bidders are bound to accept the revised quantity or duration.

For lumpsum-based service contracts, the buyer may increase the scope of work and contract value up to 50 percent with the consent of the service provider

2. Buyer Added Bid Specific ATC

ATC CONDITIONS OF GEM

1. **Bidders are requested to read the scope of work and quote accordingly.**
2. **EMD Exemption - As per latest guidelines of GeM GTC , the bidder seeking EMD exemption, must submit the valid supporting document for the relevant category as per GeM GTC with the bid. Under MSE category, only manufacturers for goods and service providers for services are eligible for exemption from EMD. Traders are excluded from the purview of this Policy.**
3. **ELIGIBILITY CRITERIA:**
 - a) **The Service provider shall have valid company registration, GST registration, a valid license/ registration of manpower supply and experience in providing Fire tender drivers to State/ Central / PSU's. Firm shall submit copy of Gem contracts / P.O's with successful work completion certificates from clients. Being the hired manpower for Fire tender service, considering safety, MSE exemption shall not be considered.**
 - b) **Firm should submit sealed and signed copy of scope of work as a token of acceptance of the same.**
 - c) **The Service provider shall have a functional office in the state of consignee i.e. Tamilnadu, proof of same shall be submitted while quoting in the technical bid.**
4. **Inspection will be by CGM or by his authorised authority at HEPF, Trichy .**
5. **Delivery Period 365 working days from the date of commencement of the contract. But as per GeM provision, the duration of contract is 360 working days (30 days X 12 months) from the date of commencement of the contract is allowed. Hence tender was floated considering 360 days.**
6. **The bidders shall include all other charges for 365 working days in the Price Bid Template, including the optional allowance 1 for supply of PPE list as per the scope of work. No extra payment shall be made.**
7. **PSD 5% is Applicable.**
8. **MSE/ Start-UP firms - experience exemption not applicable considering safety aspect.**
9. **Public preference Make in India is applicable.**
10. **Payment Terms -Payment will be made on monthly basis within 30 days on submission of all relevant documents.**
11. **Option Clause- 50% of Contract duration as per GeM condition.**
12. **Liquidated Damages the Seller fails to deliver the material to our premises or any consignment thereof within period prescribed for such delivery, Buyer shall be entitled to recover from the Seller agreed liquidated damages, and not by way of penalty a sum of 0.5% per week of delay or part thereof, subject to a maximum of 10% as our claim towards liquidated damages on the undelivered part of the order. The LD will be charged on the basic cost excluding taxes and duties. Tax applicable will be levied on LD amount.**
13. **Price Variation Clause: Applicable as per VDA amendments circulated by Ministry of Labour & Employment, Govt. Of India published by Office of the Chief Labour Commissioner(C), NewDelhi.**

14. **The bidder has to comply with all terms & conditions of the GeM Bid (including EMD, PSD, DP, Validity, Inspection, Payment, LD etc.).**
15. **The bidder has to submit MSME/Udyam Certificate with their offer.**
16. **The Bidder has to read & agree/comply all condition of MIL standard tender enquiry in conjunction with GeM T&C published in Bid.**
17. **The minimum service charge of 3.85% is applicable.**
18. **Firm has to make payment as per the revised VDA amendments circulated by Ministry of Labour & Employment, Govt. of India published by office of the Chief Labour Commissioner(C), NewDelhi. Firm has to submit reimbursement claim accordingly without waiting for any communication from HEPF.**
19. **In case of any contradiction between the standard tender condition will prevail. In case of any dispute between any terms and conditions of scope of work and statutory guidelines then statutory guidelines would prevail**
20. **If any firm discloses the price bid in technical bid, the offer of the firm will be rejected.**
21. **Type of Evaluation: Total Value Wise.**
22. **One self-declaration is to be given by participating firms certifying that “No form of child labour or bonded labour is employed in their supply chains” as per directions received from Labour welfare and skill development (U1) Department vide GO (Ms) No.73, dtd. 24/04/2023 and in line with order issued by Finance department vide its U O N1967/Fin(LW&SD)/2023 dtd.24/04/2023.**
23. **Near relation clause as per MIL vide L. No. MIL/HR/2024-25, Dt: 13/08/2024 applicable. “The participating firms should confirm that none of his/her relative is working in HEPF. The near relative will be immediate brother, sister, son, spouse, father, mother, daughter, first in-laws and first cousin.”**
24. **Note: The Standard terms & conditions & ATCs of TE will be deemed to be accepted by the participated firms unless otherwise specific remarks if any are mentioned by the firm.**

अस्वीकरण/Disclaimer

The Additional Terms and Conditions (ATC) have been incorporated by the Buyer after approval of their Competent Authority. The Buyer, is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any restriction arising in the bidding process due to these ATCs and including the modification of technical specifications and / or terms and conditions governing the bid. All representations / grievances pertaining to the ATC clauses shall be raised with the buyer organization directly and not with GeM. If any of the clause(s) is/are incorporated by the Buyer regarding the following, the bid & resultant contract shall be treated as null & void. Further, GeM reserves the right, at its sole discretion, to cancel the bid forthwith, without issuance of any prior notice or intimation :-

1. Publishing Custom / BOQ bids for items for which regular GeM categories are available (unless such Custom / BOQ item is bunched with the major regular product Category Item).
2. Mandating procurement of / from specific Brand / Make / Model / Manufacturer / Dealer except in case of Single Bid / Proprietary Article Certificate (PAC) Buying.
3. Inclusion of disqualification criteria related to suspension of seller / service provider, where such suspension period has already expired.
4. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
5. Publishing bids on GeM for procurement of works.

6. Procurement of Goods by creating a Service bid on GeM & vice-versa.
7. Seeking sample with bid or approval of samples during bid evaluation process. However, trial / sample, as the case may be, shall be permitted in cases where trial / sample are allowed as per approved and published procurement policy of the Buyers' controlling Ministry / Department / State / Public Sector Enterprises Headquarters. If there is any violation of trial / sample clause with regard to approved policy of the Buyers' Ministry / Department / State / Public Sector Enterprises Headquarters, then this is to be determined and redressed by the concerned Buyer Organisation only.
8. Seeking experience from specific organization / department / institute only or from foreign / export experience.
9. Creating bid for items from incorrect categories.
10. Reference of conditions published on any external site or reference to external documents/clauses.
11. Asking for any Tender fee / Bid Participation fee, as the case may be.
12. Buyer added ATC Clauses which are in contravention of clauses defined in bid detail section, including specifications, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by the applicable GeM GTC.
13. Any ATC clause in contravention with GeM GTC Clause 4 (xiii) (h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
14. In a category based bid, adding additional items, through buyer added, additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogues or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers/Service Providers shall ensure full compliance with all applicable labour laws, including the provisions, rules, schemes and guidelines under the four Labour Codes i.e. the Code on Wages, 2019; the Industrial Relations Code, 2020; the Occupational Safety, Health and Working Conditions Code, 2020; and the Code on Social Security, 2020 as and when notified and brought into force by the Government of India.

For all provisions of the Labour Codes that are pending operationalisation through rules, schemes or notifications, the corresponding provisions of the pre-existing labour enactments (such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972, etc. and relevant State Rules) shall continue to remain applicable.

The Seller/ Service Providers shall, therefore, be responsible for ensuring compliance under:

- **All notified and enforceable provisions of the new Labour Codes as mentioned hereinabove; and**
- **All operative provisions of the erstwhile Labour Laws until their complete substitution.**

All obligations relating to wages, social security, safety, working conditions, industrial relations etc. and any other statutory requirements shall be strictly met by the Seller/ Service Provider. Any non-compliance shall constitute a breach of the contract and shall entitle the Buyer to take appropriate action in accordance with the contract and applicable law.

This Bid is governed by the General Terms and Conditions, conditions stipulated in Bid and Service Level Agreement specific to the Service, as the case may be, as provided in the Marketplace.

However, in case of Service, if any condition specified in General Terms and Conditions is contradicted by the conditions stipulated in Service Level Agreement specific to said Service, then it will over-ride the conditions in the General Terms and Conditions.
