If the bidder is a Micro or Small Enterprise (MSE) as per latest orders issued by Ministry of MSME, the bidder shall be relaxed from the eligibility criteria of "Bidder Turnover" as defined above subject to meeting of quality and technical specifications. If the bidder itself is MSE OEM of the offered products, it would be relaxed from the

"OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. The bidder seeking Relaxation from Turnover, shall upload the supporting documents to prove his eligibility for Relaxation.

2. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price. The buyers are advised to refer to the [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if the credentials of the service provider are validated on-line in GeM profile as well as validated and approved by the Buyer after evaluation of submitted documents.

3. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price.

4. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

For lumpsum-based service contracts, the buyer may increase the scope of work and contract value up to 25 percent with the consent of the service provider

3. Bids received will be opened by the **buyer** at office of the GE (P) (AF) Jamnagar Technical evaluation of bid will be done as per the conditions and various documents required as mentioned in BoQ. Non observance of those conditions may make your quotations invalid and unacceptable.

### **SPECIFIC CONDITIONS**

1. Old retrieved materials will be the property of the vendor the amount of same will be deducted as per schedule of credit.

2. After award of the job work/repair should be done immediately but not later than the 21 days.

3. Rates should be offered as per specification of description mention

ed in Scope of work/BoQ.

4. Rate should be inclusive of all contingencies. Rates should be of delivery at GE (P) (AF) Jamnagar PIN-- 361003.
5. GE (P) (AF) Jamnagar reserves the right of accepting or rejecting of quotation without assessment and reasons thereof.
6. On receipt of order to carry out the works/ repairs, if you fail to make the repairs, in accordance with the above conditions GE (P) (AF) Jamnagar reserves the right to carry out the same elsewhere or by other agency under your risk and cost.
7. If the repairs as shown in conditions above cannot be carried out, you should give alternative date for completion of the repairs alongwith reasons with supporting documents.
8. The department reserves the right to cancel your agreement as and when your services seem to be unsatisfactory
9. Payment will be made to Supplier/Firm only after satisfactory completion of repairs and submission of bill pre-audited and passed for payment.
10. The supplied Stores/items should be guaranteed against/manufacturing defects for a period of one year from the date of supply. The supplier undertakes to repair/replace the defective items up to the period specified as above.
11. The Supplier/ firm shall contact Engineer-in-Charge for the purpose of inspection of site and relevant documents. The Supplier/firm shall also make himself familiar with working conditions, accessibility of site, availability of materials and other cogent conditions which may affect the completion of work. The Supplier/firm shall be deemed to have visited the site and made himself familiar with working conditions whether he actually inspect the site or not.

12. Registration / Empanelment Requirement: Contract shall be awarded to only such sellers, who are registered / empanelled / approved/ enlisted with MES/ or has MES Work experience GeM orders for the required goods / service category on the date of bid opening. Prospective bidders (if not already registered), are advised to get themselves registered with the said registration authority before bid opening date. (It is certified that the registration is granted by the registering agency as per Rule 150 of GFR following a fair, transparent and reasonable procedure.)

13. You or your representative must be present at the time of inspection of job works/ repairs carried out by you.

14. In case any bidder feels that he fulfills the requirements inspite of above conditions, he must enclose such required certificate which he feels that deems him fit. Decision of the technical evaluation committee shall be final and binding of opening of his financial bids.

2. On completion of job works, the vendor will be required to submit his invoice. Payment will be made through CMP Fund Transfer hence it is requested to submit your Bank Account details. Bills will be subject to pre-audit by associated finance.
3. Copy of the contract order will be attached with the bill.
4. Where GST is charged, the vendor will quote his GST Registration Number.
5. Payment will be made to the vendor account by CMP Fund Transfer.
6. The quoted rate should include all the taxes including GST.

### अस्वीकरण/**Disclaimer**

The Additional Terms and Conditions (ATC) have been incorporated by the Buyer after approval of their Competent Authority. The Buyer is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any restriction arising in the bidding process due to these ATCs and including the modification of technical specifications and / or terms and conditions governing the bid. All representations / grievances pertaining to the ATC clauses shall be raised with the buyer organization directly and not with GeM. Further, GeM reserves the right, at its sole discretion, to cancel the bid forthwith, without issuance of any prior notice or intimation :-
