If the bidder is a Micro or Small Enterprise as per latest orders issued by Ministry of MSME, the bidder shall be relaxed from the "Experience Criteria" as defined above subject to meeting of quality and technical specifications. The bidder seeking Relaxation from Experience Criteria, shall upload the supporting documents to prove his eligibility for Relaxation.
2. If the bidder is a Micro or Small Enterprise (MSE) as per latest orders issued by Ministry of MSME, the bidder shall be relaxed from the criteria of "Bidder Turnover" as defined above subject to meeting of quality and technical specifications. If the bidder is offering OEM products, it would be relaxed from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. The bidder seeking Relaxation from Turnover, shall upload the supporting documents to prove his eligibility for Relaxation.
3. If the bidder is a DPIIT registered Startup, the bidder shall be relaxed from the the eligibility criteria of "Experience Criteria" to their meeting of quality and technical specifications. The bidder seeking Relaxation from Experience Criteria, shall upload supporting documents to prove his eligibility for Relaxation.
4. If the bidder is a DPIIT registered Startup, the bidder shall be relaxed from the the eligibility criteria of "Bidder Turnover" to their meeting of quality and technical specifications. If the bidder is DPIIT Registered OEM of the offered products, it shall be relaxed from "Average Turnover" criteria also subject to meeting of quality and technical specifications. 5. Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM of the product offered through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State PSU for number of Financial years as indicated above in the bid document before the bid opening date. Copies of relevant acceptance certificates like CRAC to be submitted along with bid in support of having supplied some quantity during the period of bunch bids, the category of primary product having highest value should meet this criterion.
6. OEM Turn Over Criteria: The minimum average annual financial turnover of the OEM of the offered product during the period ending 31st March of the previous financial year, should be as indicated in the bid document. Documentary evidence in the form of Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover of the OEM should be uploaded with the bid. In case the date of constitution / incorporation of the OEM is less than 3 year old, the average turnover of the completed financial years after the date of constitution shall be taken into account for this criteria.
7. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated on the GeM portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference. In case of L-1, the bidder must be the manufacturer / OEM of the offered product or service and Buyer will decide eligibility for purchase preference. If L-1 is not an MSE and MSE Seller (s) has / have quoted by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given purchase preference. The contract will be awarded for 25% (selected by Buyer) percentage of total quantity. The buyers are advised to refer to the Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be available only if mentioned in line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.
8. Past Performance: The Bidder or its OEM {themselves or through re-seller(s)} should have supplied same or similar quantity, in at least one of the last three Financial years before the bid opening date to any Central / State Govt Org or other Govt Org contracts (proving supply of cumulative order quantity in any one financial year) to be submitted along with bid in support of relevant Financial year. In case of bunch bids, the category related to primary product having highest bid value should be taken into account.
