1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.

2. Years of Past Experience required: The bidder must have experience for number of years as indicated above in bid document (ending month of March prior to the bid opening) of providing similar type of services to any Central / State Govt Organization / PSU. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.

3. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. 4. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

(i) As per Service GCC 2018, para 2.6.1 Minimum Eligibility Criteria for Work experience are required: -Work Experience: - The bidder should have satisfactorily Completed\* in the last three previous financial years and the current financial year up to the date of opening of the tender, one similar single service contract for a minimum of 35 % of advertised value of the bid to any Central / State Govt. (ii) Years of Past Experience required : The bidder must have experience for 01 year as indicated above in bid document (ending month of March prior to the bid opening) of providing similar type of services to any Central / State Govt Organization / PSU. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during financial year.

(iii) Minimum 02 Nos. of vehicle SUV category or higher version same category must be registered with the name of the contractor itself or quoted firm name or MOU (Memorandum of Understanding) with the owner of the vehicle on stamp paper. Evidence of vehicle must be attached along with original bid otherwise offer will be rejected during technical evaluation.

(iv) Firms are bounded to provide any vehicle mentioned in bid document/ GeM contract. Only similar/higher category vehicles can be accepted after approval by consignee.

(v) This vehicle will be running Rajasthan & Haryana, hence contractor shall be arranged road permit for vehicle accordingly.

(vi) Contractor shall be fully responsible for any case i.e. repair, accident, loss, damage to the vehicle and driver.

(vii) The vehicle proposed to be offered on hire should be in good condition and also it should be registered in the name of tenderer, or the tenderer should have an MOU (Memorandum of Understanding) with the owner of the vehicle for the proposed hiring with Railway and the tenderer is required to submit the supporting documents at the time of provide the vehicle to consignee. (xii) Supplier shall ensure that the Invoice is raised in the name of Consignee with GSTIN of Consignee only

(xiii) While generating invoice in GeM portal, the seller must upload scanned copy of GST invoice and the screenshot of GST portal confirming payment of GST.

(xiv) Any defaulter/suspended firm in previous six month from date of publish of bid from this office also will be considered disqualified during technical evaluation.

(xv)The seller/contractor needs to arrange drivers as per labour laws applicable for day/night time as vehicle being 24\*7

(xvi) The tenderers shall submit a copy of certificate stating that all their statements/ documents submitted along with bid are true and factual. Standard format of certificate to be submitted by the bidder is enclosed as Annexure-I. Non- submission of above certificate by the bidder shall result in summary rejection of his / their bid. It shall be mandatorily incumbent upon the tenderer to identify, state and submit the supporting documents duly self-attested/ digitally signed by which they/ he is qualifying the Qualifying Criteria mentioned in the Tender Document. It will not be obligatory on the part of Tender Committee/ Accepting Authority to scrutinize beyond the submitted document of tenderer as far as his qualification for the tender is concerned. Partly / wrongly filled annexure will not be considered. Submission of this annexure (duly filled, sealed and signed) is mandatory, failing which offer will be summarily rejected.
