1. Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM of the product offered in the bid {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU for number of Financial years as indicated above in the bid document before the bid opening date. Copies of relevant contracts and delivery acceptance certificates like CRAC to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this criterion.

2. OEM Turn Over Criteria: The minimum average annual financial turnover of the OEM of the offered product during the last three years, ending on 31st March of the previous financial year, should be as indicated in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. 3. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. ### 3. Generic

### 4. Generic

#### 9. **Generic**

Without prejudice to Buyer's right to price adjustment by way of discount or any other right or remedy available to Buyer, Buyer may terminate the Contract or any part thereof by a written notice to the Seller, if:

- i) The Seller fails to comply with any material term of the Contract.
- ii) The Seller informs Buyer of its inability to deliver the Material(s) or any part thereof within the stipulated Delivery Period or such inability otherwise becomes apparent.
- iii) The Seller fails to deliver the Material(s) or any part thereof within the stipulated Delivery Period and/or to replace/rectify any rejected or defective Material(s) promptly.

#### 14. **Service & Support**

#### 17. **Certificates**

#### 18. **Certificates**

The bidder is required to upload, along with the bid, all relevant certificates such as BIS licence, type test certificate, approval certificates and other certificates as prescribed in the Product Specification given in the bid document.

#### 19. **Warranty**

Warranty period of the supplied products shall be 1 years from the date of final acceptance of goods or after completion of installation, commissioning & testing of goods (if included in the scope of supply), at consignee location. OEM Warranty certificates must be submitted by Successful Bidder at the time of delivery of Goods. The seller should guarantee the rectification of goods in case of any break down during the guarantee period. Seller should have well established Installation, Commissioning, Training, Troubleshooting and Maintenance Service group in INDIA for attending the after sales service. Details of Service Centres near consignee destinations are to be uploaded along with the bid.

#### 20. **Warranty**

Timely Servicing / rectification of defects during warranty period: After having been notified of the defects / service requirement during warranty period, Seller has to complete the required Service / Rectification within 10 days time limit. If the Seller fails to complete service / rectification with defined time limit, a penalty of 0.5% of Unit Price of the product shall be charged as penalty for each week of delay from the seller. Seller can deposit the penalty with the Buyer directly else the Buyer shall have a right to recover all such penalty amount from the Performance Security (PBG). Cumulative Penalty cannot exceed more than 10% of the total contract value after which the Buyer shall have the right to get the service / rectification done from alternate sources at the risk and cost of the Seller besides forfeiture of PBG. Seller shall be liable to re-imburse the cost of such service / rectification to the Buyer.

## 21. Buyer Added Bid Specific ATC

1. **Acceptance and Payment.** Items shall be accepted and CRAC shall be generated only after satisfactory completion of inspection/trials (as per scope of supply) at the user location. Payment shall be made to the firm within 40 days from the date of CRAC generation, through offline mode

2. **Definition of Delivery.** The term 'delivery' shall imply supply, installation, testing, and commissioning of goods/services, whichever is applicable as per the scope of supply. The successful bidder shall ensure delivery within the stipulated contract delivery period.

3. **Performance Security.** The successful bidder shall furnish Performance Security within 15 days of award of contract on GeM (**for contracts with a value exceeding ₹5 lakh**) in the form of Insurance Surety Bond/Account Payee Demand Draft/Fixed Deposit Receipt/Bank Guarantee from a commercial bank, along with SFMS-transmitted confirmation. The amount shall be 5% of contract value, valid for 60 days beyond completion of all contractual obligations, including warranty obligations.

4. **Updating Delivery Details.** The seller shall update delivery details on the GeM portal only after successful completion of supply and commissioning as per the scope of supply.

5. **Bid Security & Product Details.** All the Bidders must submit Bid Security Declaration and Model of all the items wherever relevant along with Technical Catalogues/Brochures of the offered product as per the Technical Specification document.

6. **Transporter/Representative Details.** The successful bidder shall communicate the details of their transporter/representative to the Buyer at least one day prior to physical delivery, through e-mail, phone, or any other appropriate means of communication. Details shall include copies of Aadhaar, Driving License, and RC of vehicle for the transporter, and Aadhaar for firm representatives. Originals must be carried during delivery.

### 7. Eligibility/OEM Authorization.

7.1 The bidder should be OEM/OEM authorised dealer for the tractor. Further, the trailer to be manufactured through reputed vehicle body builder strictly complying to the standards enumerated in the technical specifications document. Design approval to be sought prior manufacture.

7.2 Any bidder holding valid authorisation from either the OEM/OEM authorised dealer for the tractor is also qualified to participate.

7.3 Any bidder holding valid bid-specific authorisation from either the OEM/OEM authorised dealer is also qualified to participate.

7.4 All bidders shall submit a valid OEM Authorization Certificate for the tractor, issued directly by the OEM/OEM authorised dealer.

### 8. Experience and Past Performance.

**10. Financial Standing (Under all Conditions).**

10.1 The average annual financial turnover of 'The Bidder' during the last three years, ending on 'The Relevant Date', should be at least 21 Lakhs, as per the annual report (audited balance sheet and profit & loss account) of the relevant period, duly authenticated by a Chartered Accountant/ Cost Accountant in India.

10.2 The net worth of the Bidder firm (manufacturer or principal of authorized representative) on 'The Relevant Date' should not be less than 17 Lakhs.

10.3 The net worth of the Bidder firm (manufacturer or principal of authorized representative) should not be negative on 'The Relevant Date' and also should have not eroded by more than 30% (thirty percent) in the last three years, ending on 'The Relevant Date'.

**12. **14. Dispatch Clearance.** Delivery of items shall commence only after receipt of formal Dispatch Clearance from the Buyer. Under no circumstances shall the supplier initiate shipment without such clearance.

**15. Design and Approval Requirement.** The successful bidder shall be responsible for preparing a detailed design drawing of the offered item in line with the specifications laid down in the bid document, wherever applicable. The Design drawing shall be submitted to the User Department for review and approval prior to commencement of manufacturing/ fabrication activities. Manufacturing shall proceed only after obtaining such written approval.

**16. Compliance to technical specifications.** Statement of compliance with respect to technical specifications document is to be submitted. Deviations from the same stating better standards or latest technology or as per the OEM engineering system design but meeting the functional requirement of the equipment may be mentioned and justified. The right to verify the authenticity of such deviations either to rule-in or eliminate lies with the Buyer.

ARAI Certification.** The bidder shall upload a valid ARAI/ICAT Type Approval Certificate or equivalent certification issued by any Government-approved test agency for the offered model(s) conforming to the relevant provisions of the Central Motor Vehicle Rules (CMVR) and Automotive Industry Standards (AIS) as applicable. along with the technical bid. In cases where ARAI certification is not applicable (for example, non-roadworthy or custom-fabricated industrial equipment), the bidder shall upload a self-declaration stating the reason for non-applicability, duly supported by manufacturer's confirmation/documentation indicating that such certification is not required under CMVR.
