Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
