1. If the bidder is a Micro or Small Enterprise as per latest orders issued by Ministry of MSME, the bidder shall be relaxed from the eligibility criteria of "Experience Criteria" as defined above subject to meeting of quality and technical specifications. The bidder seeking Relaxation from Experience Criteria, shall upload the supporting documents to prove his eligibility for Relaxation.
2. If the bidder is a Micro or Small Enterprise (MSE) as per latest orders issued by Ministry of MSME, the bidder shall be relaxed from the eligibility criteria of "Bidder Turnover" as defined above subject to meeting of quality and technical specifications. If the bidder itself is MSE OEM of the offered products, it would be relaxed from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. The bidder seeking Relaxation from Turnover, shall upload the supporting documents to prove his eligibility for Relaxation.
3. If the bidder is a DPIIT registered Startup, the bidder shall be relaxed from the the eligibility criteria of "Experience Criteria" as defined above subject to their meeting of quality and technical specifications. The bidder seeking Relaxation from Experience Criteria, shall upload the supporting documents to prove his eligibility for Relaxation.
4. If the bidder is a DPIIT registered Startup, the bidder shall be relaxed from the the eligibility criteria of "Bidder Turnover" as defined above subject to their meeting of quality and technical specifications. If the bidder is DPIIT Registered OEM of the offered products, it would be relaxed from the "OEM Average Turnover" criteria also

subject to meeting of quality and technical specifications. The bidder seeking Relaxation from Turnover shall upload the supporting documents to prove his eligibility for Relaxation.

5. Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM of the product offered in the bid {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU for number of Financial years as indicated above in the bid document before the bid opening date. Copies of relevant contracts and delivery acceptance certificates like CRAC to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this criterion.

6. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 25% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to

increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$, subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

2. **Scope of Supply**

Scope of supply (Bid price to include all cost components) : Supply Installation Testing Commissioning of Goods and Training of operators and providing Statutory Clearances required (if any)

3. **Buyer Added Bid Specific ATC**

Buyer Added text based ATC clauses

1. Following documents are to be submitted along with the bid failing which the offers may be rejected.
 - i. GST registration of the bidder.
 - ii. PAN of the bidder.
 - iii. Licence for executing electrical works .
 - iv. Detailed specifications of the offered equipments along with brochures etc. The name of the manufacturers, model etc should be mentioned properly.
 - v. Compliance statement for the technical specifications requested in the tender.
 - vi. MSE-Udyam registration (if any).
 - vii. CA certified Turn Over certificate.
 - viii. Acknowledgement of IT return filed during AY 2024-25 and AY 2023-24.
 - ix. Experience in executing similar electrical works
 - x. Declaration of applicable warranty declaration for the offered items.
2. The successful bidder hereinafter referred to as 'Contractor/ Service Provider' shall execute the work awarded to the satisfaction of ICFRE-Rain Forest Research Institute (ICFRE-RFRI) and ensure that all the items supplied and installed are according to the specifications prescribed. Total **2 nos** number of panel boards needs to be supplied and installed in this job. (Refer the scope of work enclosed for details).
3. The Contractor shall be fully responsible for carrying out the assigned work strictly according to the specifications enclosed in the bid and those offered by the bidder and accepted by ICFRE- RFRI.
4. The Contractor is bound by the details and documents as furnished by him to the ICFRE-RFRI while submitting the tender or at any other time. In case, any detail of such documents furnished by him is found to be false at any stage this would be deemed to be a breach of the terms of contract, and the contract is liable for termination forthwith.
5. The work assigned under the contract will be reviewed by the competent authority or any committee/official authorized by the authority and the Contractor will remain present personally or through an authorized representative.
6. The Contractor, after completion of the work will inform the Institute in writing.
7. The Institute will arrange for inspection and verification of the completed work. Thereafter, if satisfied with the work done, the handing and taking over documents will be signed. If it is found that the work is not according to the specifications, the contractor will have to rectify the same on priority basis.
8. In case the workers/ any worker deployed by the Contractor commit/commits any act of offence which is against the good interest of the Institute, the Contractor will be liable and responsible to take action against the person(s).

9. The ICFRE-RFRI shall not be responsible financially or otherwise for any injury/death to workmen employed by the Contractor for carrying out the awarded work. In case, compensation is awarded by the Court of Law, it shall be the responsibility of the Contractor.

10. In case the Contractor fails to comply with statutory obligation under any Laws, and ICFRE-RFRI is put to any obligation, monetary or otherwise, the ICFRE-RFRI will be entitled to get itself reimbursed out of the bill of the Contractor or otherwise, to the extent of the obligation in monetary terms.

11. Director, ICFRE-RFRI reserves the right to reject/drop any/ all of the components of the work, if necessary, depending upon the availability of budget.

12. Director, ICFRE-RFRI reserves the absolute right to terminate/ stop the contract at any time during the period of the contract if any deviation from the laid terms and conditions is found.

13. Director, ICFRE-RFRI has absolute right to terminate the contract at any time before the due date of expiry without assigning any reason but by giving a notice in advance to the Contractor in writing or by making equivalent payment thereof in case of early termination.

14. The Contractor if in any manner defaults in the performance or in making good of any losses, damage or expenses or any part thereof, then it shall be lawful for the Institute to recover the loss from the bill towards the liquidation of liability of the Contractor in respect of such default.

15. The performance security submitted by the Contractor shall stand forfeited if there is any deviation from terms and conditions mentioned herein or in the tender document .

16. Neither party shall be responsible for delays or failures in performance resulting from acts beyond the control of the party. Such acts shall include but not limited to acts of God, strikes, lockouts, riots, acts of war, epidemics, Government regulation imposed after the implementation, communication line failure, earthquakes etc.

17. Income Tax and GST will be deducted at source as per Income Tax Act and GST Act and the TDS certificate to this effect shall be issued to the Contractor by the ICFRE-RFRI.

18. The contractor shall INDEMNIFY and shall keep this office indemnified against acts of omission or negligence, dishonesty or misconduct or men & women engaged for the work and this office shall not be liable to pay any damage or compensation to such person or to third party. All damages caused by workmen shall be charged to the Contractor and recovered from its dues/ bills.

19. If any dispute or disagreement arises between the Contractor and the Institute under any circumstance or in connection with the terms & conditions, they shall make every effort to resolve the matter amicably by direct negotiation.

20. In case of failure of negotiation the dispute, differences or questions which may arise between the Contractor and RFRI will be referred to an arbitrator to be appointed by the Director General, ICFRE & the applicable Arbitration procedure will be as per Indian Arbitration and Conciliation Act, 1996.

4. **Warranty**

Timely Servicing / rectification of defects during warranty period: After having been notified of the defects / service requirement during warranty period, Seller has to complete the required Service / Rectification within 3 days time limit. If the Seller fails to complete service / rectification with defined time limit, a penalty of 0.5% of Unit Price of the product shall be charged as penalty for each week of delay from the seller. Seller can deposit the penalty with the Buyer directly else the Buyer shall have a right to recover all such penalty amount from the Performance Security (PBG). Cumulative Penalty cannot exceed more than 10% of the total contract value after which the Buyer shall have the right to get the service / rectification done from alternate sources at the risk and cost of the Seller besides forfeiture of PBG. Seller shall be liable to re-imburse the cost of such service / rectification to the Buyer.

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
16. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers/Service Providers shall ensure full compliance with all applicable labour laws, including the provisions, rules, schemes and guidelines under the four Labour Codes i.e. the Code on Wages, 2019; the Industrial Relations Code, 2020; the Occupational Safety, Health and Working Conditions Code, 2020; and the Code on Social Security, 2020 as and when notified and brought into force by the Government of India.

For all provisions of the Labour Codes that are pending operationalisation through rules, schemes or notifications, the corresponding provisions of the pre-existing labour enactments (such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972, etc. and relevant State Rules) shall continue to remain applicable.

The Seller/ Service Providers shall, therefore, be responsible for ensuring compliance under:

- **All notified and enforceable provisions of the new Labour Codes as mentioned hereinabove;**

and

- **All operative provisions of the erstwhile Labour Laws until their complete substitution.**

All obligations relating to wages, social security, safety, working conditions, industrial relations etc. and any other statutory requirements shall be strictly met by the Seller/ Service Provider. Any non-compliance shall constitute a breach of the contract and shall entitle the Buyer to take appropriate action in accordance with the contract and applicable law.

While participating in bid, Bidder has to undertake compliance of this and any false declaration and non-compliance of this would be a ground for immediate termination of the contract and further legal action in accordance with the laws.
