The buyers are advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

2. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

1. **Scope of Supply**

Scope of supply (Bid price to include all cost components) : Only supply of Goods

2. **Certificates**

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

3. **Buyer Added Bid Specific ATC**

Buyer Added text based ATC clauses

- Bidders should go through the Technical Specification or Scope of Supply in "**Buyer specification document**" carefully and submit their technical offer as per **Format-T1** attached therein, on firm's letterhead or stamped, signed by firm's competent authority and upload in GeM as Compliance of BoQ Specification.
- Authorization Certificate:** The materials are proprietary items of **M/S. BECKMAN COULTER INDIA PVT LTD.** Hence offers of **M/S. BECKMAN COULTER INDIA PVT LTD.** and/or their authorized distributors/ dealers/ channel partners/system integrators will be acceptable in this bid.

In case of participation from distributors/ dealers/ channel partners/system integrators, they need to submit valid & genuine authorization certificate from principal vendor along with the offer/technical bid, failing which the offer shall be rejected. 3. **Guarantee Certificate:** In case authorized resellers i.e. distributors/dealers/channel partners/system integrators are awarded with the contract, they are to submit certification letter of their manufacturer/OEM/principal vendor along with the supply which should state that the supplied medicines/reagents by their distributor/dealer/channel partner (mentioning name) with batch number are genuine and quality product.
4. **Shelf life:** Expiry period should be minimum 1 year from date of invoice.
5. **Packing and Labelling:** proper packing shall be given by you for the quoted material to avoid any damage during transportation. **"NALCO STOCK, NOT FOR SALE"** to be inscribed on all blister/packs and strips.
6. **Delivery Schedule:** The items should be supplied in two lots within an interval of six months or as on our requirement. 50% of the ordered quantities (1st lot) should be made within 30 days from the date of GeM Contract.
7. **Inspection:** Final inspection and acceptance shall be done at NALCO HOSPITAL and the result shall be final and shall be binding on the supplier on whom order is placed.
8. **MRP:** In the event of order and while supplying against the said order, the bill/invoice must indicate MRP on the date of supply against each batch. You must confirm to this effect in your offer.
9. The commercial terms & conditions are mentioned in the BID Details along with Buyer added Bid Specific Additional Terms & Conditions (ATC). The formats for commercial terms and condition compliance, no-deviation and other required certificates (Annexures) are provided in **"Buyer uploaded ATC documents"** of the bid. Bidders must submit/upload the certificates, dully filled on firm's letterhead or stamped, signed by firm's competent authority with the Technical Bid.
10. All the **commercial terms and conditions** will be strictly as per GeM standard terms and conditions without any deviations. Bidders should submit bid only if Buyer added Bid specific Additional Terms & Conditions (ATC) read with GEM General Terms & Conditions (GTC) are acceptable to them. Any other commercial term mentioned by the bidder as an attachment shall be ignored.
11. **Price Basis:** Prices on GeM portal are inclusive of all cost components i.e. GST, packing and forwarding charges, freight charges, transit insurance etc. Accordingly, the bidders must quote price in GEM portal on F.O.R., NALCO HOSPITAL, ANGUL, ODISHA basis/ free delivery at NALCO HOSPITAL, ANGUL, ODISHA basis inclusive of packing and forwarding charges, freight charges, GST, transit insurance etc. Any deviation to above conditions mentioned in the offer shall be ignored or the offer shall be rejected.
12. **Price Firmness:** All prices quoted must remain firm and fixed till complete execution of the order (i.e without any escalation/price variation terms) except for statutory variation in taxes and duties during contractual delivery/completion period. Any increase in taxes and duties after expiry of the delivery/completion period shall be to supplier's account. However, in case of any price decrease during the same period as applicable to govt./public sector hospitals, it will be applicable, and you will intimate accordingly for issue of necessary amendment by NALCO.
13. **Payment Terms:** 100% payment shall be released within 10 days after receipt and acceptance of material at site (CRAC) and submission of Invoice, subject to reflection of the party's invoice/credit or debit note in GSTR 2A/ANX-2 (GST NEW RETURN) of NALCO.
14. **Anti-profiteering clause (SEC171 OF CGST ACT):** If any new tax/taxes is introduced on sale of goods/services, either in lieu of existing tax/taxes or as separate tax/taxes, then the overall incidence of tax/taxes on the vendor on account of its inputs and outputs wherever less than the incidence of existing taxes, then the vendor shall pass on to owner, the benefits thereof by way of commensurate reduction in the basic price w.r.t input tax benefits and reduction in tax chargeable to 'NALCO' w.r.t output tax benefits in connection

ction with goods and/or services provided. If on the other hand, the incidence of tax/taxes is in excess of the incidence of existing tax/taxes, the owner on submission of satisfactory proof, shall reimburse the vendor or the additional incidence of tax provided they are within the contractual completion date. The vendor must provide a declaration (as per attached format in ATC Upload) along with the tender that they will abide by the requirements under cl 171 of CGST ACT, 2017.

15. **Income Tax Clause:** A) NALCO, being Buyer (under Section 194Q inserted in the Income Tax Act, 1961 vide Finance Act 2021) having total sales, gross receipts, or turnover from business above Rupees Ten Crores during the last Financial Year, will deduct TDS under Section 194Q, w.e.f. 01.07.2021, at the prescribed rate of 0.1% on the purchase value of any goods, aggregate of which is exceeding the threshold limit of Rs .50 Lakhs in a Financial year. Accordingly, Vendors/Sellers are not to collect tax at source under section 206C(1H) of the Act w.e.f. 01.07.2021, in case provisions of section are applicable to them. The above is as per the current status and is subject to modification(s) based on amendments/notifications under Income Tax Act, 1961, from time to time.

B) Vendor / Party categorized/designated as "specified person" under Section 206AB of Income Tax Act, 1961 shall be liable for TDS at higher rate as provided under the said section, by NALCO. So, Vendors/Contractors are advised to submit self-certified copies of Income Tax return (ITR) for each of the Two Previous Years for which due date for filing of ITR has expired, along with the Invoice/Bill so as to facilitate NALCO, verify the applicability of Section 206AB. NALCO will also check linking of PAN with AADHAR as required under the act, with the help of facility provided by Income Tax Department for deciding the TDS %. However, this is as per current status and is subject to modification based on further notification on the subject by Govt. of India under Income Tax Act.

16. In case of successful award of GeM Contract, the seller is advised to ensure submission of GeM invoice, original tax invoice, challan copy, lorry receipt and P&F receipt along with dispatch documents during supply of material failing which material will not be accepted by consignee at site.

For all provisions of the Labour Codes that are pending operationalisation through rules, schemes or notifications, the corresponding provisions of the pre-existing labour enactments (such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972, etc. and relevant State Rules) shall continue to remain applicable.

The Seller/ Service Providers shall, therefore, be responsible for ensuring compliance under:

- **All notified and enforceable provisions of the new Labour Codes as mentioned hereinabove; and**
- **All operative provisions of the erstwhile Labour Laws until their complete substitution.**

All obligations relating to wages, social security, safety, working conditions, industrial relations etc. and any other statutory requirements shall be strictly met by the Seller/ Service Provider. Any non-compliance shall constitute a breach of the contract and shall entitle the Buyer to take appropriate action in accordance with the contract and applicable law.

This Bid is governed by the General Terms and Conditions, conditions stipulated in Bid and Service Level Agreement specific to the Service, as the case may be, as provided in the Marketplace.

However, in case of Service, if any condition specified in General Terms and Conditions is contradicted by the conditions stipulated in Service Level Agreement specific to said Service, then it will over-ride the conditions in the General Terms and Conditions.
