6. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

### 7. **Buyer Added Bid Specific ATC**

Buyer Added text based ATC clauses

I. Visits: Two (02) Preventive Maintenance visits & One (01) Breakdown visit . (Preventive Maintenance visits to be made at equally spaced intervals).

II. Payment Terms: Payment shall be released on a half-yearly basis, with 50% after successful completion of the 1st Preventive Maintenance visit (at the end of six months) and the remaining 50% after satisfactory completion of the annual AMC year. Payment shall be made through RTGS.

III. Bills shall be admitted for payment only after satisfactory completion of the applicable AMC period and submission of duly certified service report/visit certificate from the User/HOD. In the absence of such certification, the bill shall not be considered for payment.

IV. A copy of the service report for each service visit shall be submitted to the Stores & Purchase Division. The service engineer shall sign the AMC attendance register maintained in the S&P Division on the same day of service. Failure to comply with either requirement shall render the bill liable for rejection and shall not be admitted for payment.

V. Each service visit shall be extended without any additional charges, if a job is not completed then the additional day/s spent will be treated as the same service visit of the contract. In case your engineer has located a fault but could not put the instrument in working condition due to non-availability of spare parts. The days spent by him will be adjusted as mentioned above. After the required spare part/s is/are made available, your engineer will visit again to replace the spare part/s. This visit will also be treated as same contract visit.

VI. If there is no breakdown call within Six (06) months, one preventive maintenance will be given after every Six (06) month during the contract period.

VII. GST TDS/TCS/Income tax and other Taxes, if applicable will be deducted as per applicable statutory norms prescribed by the Govt. VIII. Denial Clause: No upward price variation including statutory levies will be admissible beyond the original scheduled AMC period for default on the part of the service provider. However, downward price variation would be availed by the purchase as per the denial clause.

IX. Amendment: Any amendment made will be treated as the part of the contract.

X. Replacement: All incidental expenses concerned to warranty / faulty items replacement will be borne by the supplier.

XI. Settlement of Disputes: The purchaser and the supplier shall make every effort to resolve amicably by direct informal negotiation any disagreement or dispute arising between them under or in connection with the Contract. All disputes, differences and questions which may, if any time, arise shall be referred to Delhi International Arbitration Centre (DIAC), Delhi High Court, New Delhi as per the provisions of Indian Arbitration and Reconciliation Act 1996 and his award shall be final and binding on the parties to the dispute.

XII. Jurisdiction: Place of Jurisdiction is Bhubaneswar.
