If the bidder is a Micro or Small Enterprise (MSE) as per latest orders issued by Ministry of MSME, the bidder shall be relaxed from the eligibility criteria of "Bidder Turnover" as defined above subject to meeting of quality and technical specifications. If the bidder itself is MSE OEM of the offered products, it would be relaxed from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. The bidder seeking Relaxation from Turnover, shall upload the supporting documents to prove his eligibility for Relaxation.
2. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.
4. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price. Benefits of MSE will be allowed only if the credentials of the service provider are validated on-line in GeM profile as well as validated and approved by the Buyer after evaluation of submitted documents.
5. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

##### 1. Generic

- The Seller shall not assign the Contract in whole or part without obtaining the prior written consent of buyer.
- The Seller shall not sub-contract the Contract in whole or part to any entity without obtaining the prior written consent of buyer.
- The Seller shall, notwithstanding the consent and assignment/sub-contract, remain jointly and severally liable and responsible to buyer together with the assignee/ sub-contractor, for and in respect of the due performance of the Contract and the Sellers obligations there under.

##### 2. Service & Support

Dedicated /toll Free Telephone No. for Service Support : BIDDER/OEM must have Dedicated/toll Free Telephone No. for Service Support.

##### 3. Service & Support

The Service Provider is required to have at least 40 % of the required manpower on service provider's payroll for at least one year. Necessary documents relating to such manpower will be uploaded by the bidder for verification of the buyer. Such manpower will be part of total manpower to be provided by the Service Provider in case he gets the contract against this bid.

##### 4. Payment

**PAYMENT OF SALARIES AND WAGES:** Service Provider is required to pay Salaries / wages of contracted staff deployed at buyer location first i.e. on their own and then claim payment from Buyer alongwith all statutory documents like, PF, ESIC etc. as well as the bank statement of payment done to staff.

#### 8. **Buyer Added Bid Specific ATC**

Buyer Added text based ATC clauses

1. The firm should be located within Municipal Corporation Limits of Kanpur and should be in a position to provide vehicles at short notice for emergency use round the clock within 3 Hours.
2. Photo copies of RC books of vehicles with fitness certificate of Yellow Board vehicle (all 2 vehicles) is to be uploaded.
3. Copies of the vehicle permit for the U.P. State and latest tax paid receipt (all 2 vehicles) is to be uploaded.
3. A certificate will be submitted by the bidder as the firm has not been blacklisted by any Government or Non-Government Organisation as on bid submission date.
4. The Odometer reading will start and terminate at Akashvani, Lucknow. The driver will not be allowed to take the vehicle for lunch or tea. Under no circumstances the odometer reading from vendor's office to Akashvani, Kanpur will be entertained.
5. In case of breakdown of hired vehicle while under use, the agency should make alternate arrangements immediately, failing which the additional amount spent for fulfilling the assignment by engaging other vehicle on the spot by the department, will be recovered from the travel agency.
6. Akashvani, Kanpur shall not be liable for any loss / damage / Death by accident / otherwise to the employees engaged by the agency. Any legal claim in the matter of wages, compensation, insurance, PF, Gratuity & other benefits in respect of the drivers engaged by the agency shall be the sole responsibility of the agency / firm.
7. It will be the responsibility of the firm / agency to see that the driver should not, under any circumstances, drive the vehicle in a bad condition, under the influence of drugs or any kind of intoxication. The driver should have valid commercial license, valid vehicle documents, insurance etc. The driver should be courteous and punctual. The firm / agency will also be responsible for the conduct of the driver. If the vehicle is challaned for breaking the traffic rules by the driver and any penalty is imposed on the driver, the firm / agency will be responsible for the same.
8. On the events to be organized by Akashvani, Kanpur, the firm will have to provide vehicles to Akashvani, Kanpur as per requirement at the rates approved by Akashvani, Kanpur. The number of vehicles requisitioned on special events can exceed 02. If the required vehicle is not provided on time and vehicle is hired from other travel agency and its payment is more than the approved rates, then the total difference will be recovered from the firm / agency.
9. The firm should be registered and should have a permanent office / Branch office in Kanpur. The bidder must have registered at least 2 vehicles in respective RTO's under their name or in the name of the firm in any combination (Sedan, SUV/MUV, Premium SUV /MUV) and should be in a position to provide more vehicles at any given time only, should apply. All the vehicles should be 2022 and later model. The successful bidder must produce all the original documents at the time of executing the agreement, failing which the su

successful bidder will not be considered even if it is the lowest bid.

10. An undertaking that he will engage experienced drivers with minimum of 3 years professional / driving License and who can perform 24 hrs. duty. All drivers employed / contracted by the company should hold valid Driving License, PUC certificate is also required to be submitted.

11. The Bidder shall have a valid PAN, GST Registration and AADHAAR. Copy is required to be uploaded.

If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
16. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
17. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM.
