1. Preference to Make In India products (For bids < 200 Crore): Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. ### 1. **Generic**

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be  $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$ , subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

### 2. **Generic**

**Manufacturer Authorization:** Wherever Authorised Distributors/service providers are submitting the bid, Authorisation Form /Certificate with OEM/Original Service Provider details such as name, designation, address, e-mail Id and Phone No. required to be furnished along with the bid

### 3. **Scope of Supply**

Scope of supply (Bid price to include all cost components) : Only supply of Goods

### 4. **Buyer Added Bid Specific ATC**

**4.1** Item specification should be as per RDSO specification: RDSO/SPN/153/2023 Revision 5.0. The bidders are required to submit specification compliance for the attached specification.

**4.2** Max. dimension of housing (HxWxD) without hood is 34.5cmX43cmX26.5cm.

**4.3** Housing & Mounting socket shall be made of stainless steel and black powder coated inside and out side.

**4.4** Sample and Design document should get approved before bulk supply.

**4.5** Any other accessories required for installation of Shunt Signal Assembly shall be provided by supplier without any additional cost.

**4.6** Warranty: 60 months from date of supply.

**4.7** The details of deviations, if any, should be clearly submitted through the Annexure -'A' attached in Buyer uploaded Bid ATC documents. All implicit and explicit deviations, remarks and comments mentioned elsewhere in the tenderer's proposal shall be treated as NULL and VOID and considered without exception unconditionally. Tenderers may note that conditions deviating from the tender conditions/ description/specifications may render the offer liable to be ignored.

**4.8** If the authorized channel partners of the OEM are participating in this bid, then they have to submit the bid specific OEM authorization certificate failing which offer shall be summarily rejected.

**4.9** The bidders are required to submit the declaration regarding percentage of local content of the offered product(s) from the OEM failing which their offer shall be considered with 0% (Nil) local content

or further evaluation.

**4.9.1** The bidders shall be required to submit the percentage of local content as per Public Procurement (Preference to Make in India), Order 2017 dated 19th July, 2024 (as amended from time to time). However, at the time of execution of the contract, for all contracts above ₹ 10 Crore, the seller/service provider shall be required to give local content certification duly certified by cost/chartered accountant in practice. For cases where it is not possible to provide certification by cost/chartered accountant at the time of execution of contract, the seller / service provider shall be permitted to provide the certificate for local content from cost / chartered accountant after completion of the contract, within time limit acceptable to the Buyer.

In case Seller / Service Provider does not meet the stipulated local content requirement and the category of the Seller/ Service Provider changes from Class-I to Class-II/Non-local supplier or from Class-II to Non-local supplier, a penalty up to 10% of the contract value may be imposed. However, contract once awarded shall not be terminated on this account.

**4.9.2** False declaration(s) regarding percentage of local content in line with Public Procurement (Preference to Make in India), Order 2017 dated 19th July, 2024 (as amended from time to time) by Sellers/ Service Providers will be treated as breach of the Code of Integrity under Rule 175(1)(i)(h) of General Financial Rules for which the Sellers /Service Providers or its successors can be debarred for up to two years as per Rule 151(iii) of General Financial Rules along with such actions as may be permissible under law

**4.9.3** Decisions on complaints, including prescribed fees, relating to implementation of Public Procurement (Preference to Make in India), Order 2017 (as amended from time to time) will be taken by Competent Authority empowered to look into procurement related complaints relating to procuring entity.

**4.10** Bidders has/have to comply all the specifications/parameters/ conditions as mentioned in the specification documents uploaded in specification tab and also submit all required/mentioned declaration/supporting documents. Compliance of all the specifications including additional specifications must be submitted by the bidder fails to which their offer shall be liable to be rejected.

**4.11** Make and Model offered through GeM Catalogue and through documents submitted along with bids shall be same, failing which offer is liable to be rejected.

**4.12** Certificates: Bidder's offer is liable to be rejected if they don't upload any of the certificates/documents /technical data sheet of the offered product sought in the Bid document, Employer's Requirement (uploaded with item specification document), ATC and Corrigendum if any.

**4.13** A bidder shall participate either as OEM or Authorized channel partner of the OEM and not both.

**4.14** Bidders are required to submit proper data sheet of the offered product, merely copy paste of the required specification may not be considered a proper data sheet (may not be considered for evaluations) and failing which offer is liable to be rejected.

**4.15** Tenderer not submitting the requisite information may note that his offer is liable to be ignored. In case the tenderers do not submit the requisite documents/evidence in regard to qualifying requirements as required, along with their e-offer, the tender will be decided on the basis of their past supply performance records/credentials as available with COS Office, DMRC.

**4.15.1** Further documents available with DMRC/Signaling department may be considered for evaluation of the offers.

**4.16** EMD shall be accepted only through online mode failing which offer is liable to be rejected.

**4.17** PBG shall be submitted in the prescribed attached format.

Further, GeM reserves the right, at its sole discretion, to cancel the bid forthwith, without issuance of any prior notice or intimation :-

12. Buyer added ATC Clauses which are in contravention of clauses defined in bid detail section, including specifications, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by the applicable GeM GTC.
13. Any ATC clause in contravention with GeM GTC Clause 4 (xiii) (h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
14. In a category based bid, adding additional items, through buyer added, additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogues or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.
