1. If the bidder is a Micro or Small Enterprise (MSE) as per latest orders issued by Ministry of MSME, the bidder shall be relaxed from the eligibility criteria of "Bidder Turnover" as defined above subject to meeting of quality and technical specifications. If the bidder itself is MSE OEM of the offered products, it would be relaxed from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. The bidder seeking Relaxation from Turnover, shall upload the supporting documents to prove his eligibility for Relaxation.
2. 4. Years of Past Experience required: The bidder must have experience for number of years as indicated above in bid document (ending month of March prior to the bid opening) of providing similar type of services to any Central / State Govt Organization / PSU. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.
5. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order

quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price. The buyers are advised to refer to the [OM No.1\\_4\\_2021\\_PPD\\_dated\\_18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if the credentials of the service provider are validated on-line in GeM profile as well as validated and approved by the Buyer after evaluation of submitted documents.

6. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

7. Past Experience of Similar Services: The bidder must have successfully executed/completed similar Services over the last three years i.e. the current financial year and the last three financial years(ending month of March prior to the bid opening): -

1. Three similar completed services costing not less than the amount equal to 40% (forty percent) of the estimated cost; or
2. Two similar completed services costing not less than the amount equal to 50% (fifty percent) of the estimated cost; or
3. One similar completed service costing not less than the amount equal to 80% (eighty percent) of the estimated cost.

8. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting bidder. The technically qualified Highest Quoting bidder will not be allowed to participate in RA. However, H-1 will also be allowed to participate in RA in following cases:

- i. If number of technically qualified bidders are only 2 or 3.
- ii. If Buyer has chosen to split the bid amongst N sellers, and H1 bid is coming within N.
- iii. In case Primary product of only one OEM is left in contention for participation in RA on elimination of H-1.
- iv. If L-1 is non-MSE and H-1 is eligible MSE and H-1 price is coming within price band of 15% of Non-MSE L-1
- v. If L-1 is non-MII and H-1 is eligible MII and H-1 price is coming within price band of 20% of Non-MII L-1

**1. Generic**

OPTION CLAUSE 25% : The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, the contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration.

For lumpsum-based service contracts, the buyer may increase the scope of work and contract value up to 25 percent with the consent of the service provider

### **ADDITIONAL TERMS AND CONDITIONS**

(1) Vehicle provided in CHT shall be tested and ensure functionality and fitness in all respect on daily basis before going on duty at 9.00 AM to 5.00 PM on each working day at Ha CEPZ in presence of MES/Rep /Engr-in-Charge. If the contractor fails to provide the vehs at a schedule place, date, time there shall be penalty at the rate of one and half times the rate quoted for the specific vehs and worked out for the day/period. (li) Contractor shall provide commercially registered veh in CHT for conveyance of Officers at HQ CEPZ Pune for local duties at AOR of HQ CEPZ within Pune, MES offices/HO's with in Pune area and connected areas as mention in Job work.

CHT shall be reported at HQ CEPZ all working days at 09.00 AM. Duty timing be for 08 hrs timing of duty as per requirement will be decided by E7 MT Adm Section at HQ CEPZ /Sr Adm Offr.

(iv) Payments will be admissible on monthly basis after satisfactory completion of 11 months of duty:

(v) FOL for operation of vehicle will be provided by the contractor. Contractor shall be responsible for keeping the vehicle fit and any maint/repair required on vehicle will be responsibility of contractor and no extra charge will be paid by department.

(vi) The vehs will be consigned to HQ CEPZ Pune and reported daily on all working days at HQ CEPZ E7 Adm Section at 09.00 AM.

(vii) Veh detailed should be neat and clean with and proper seat cover, matting and upholstery. There should not be any FOL odor or ratting sound inside the cabin.

(viii) Driver detailed shall be courteous and well versed with the terms and conditions of the contract. He should have experience of min 5 years of driving of vehicle. He should have experience of doing such duties with MES formation and should be familiar with the : locations of MES offices within the Pune area.

(ix) Contractor shall deploy the driver in proper uniform/ dress (Pant, shirt, belt black formal shoes, with name plate of driver etc all as directed by Engr-in-Charge. Driver should have valid license of driving LMV issued by competent auth and should be in possession of all the requisite documents of Veh like RC, Insurance, Pollution clearance certificate etc. Contractor shall submit photo copy of requisite documents of veh like RC, Valid Insurance, valid Pollution clearance certificate drivers valid driving license etc. It is contractor responsibility to timely renew all the certificate required as per RTO rule.

(x) DO's and Don'ts formulated will be handed over by the Contract Operation officer for strict compliance by the CHT contractor/driver such as dress of driver, name plate for driver, wearing of shoes, minimum five years driving experience and with adequate manners and attitude to greet the VIP etc.

(xi) Department will not be responsible for any damage to vehicle or manpower in case of any accident, mechanical failure or due to any fault of the driver or contractor when vehicles is on duty. In case of any breakdown of vehicle, contractor shall provide the other vehicle as per specification as mentioned in Schedule immediately without any extra cost.

(xii) No payment for night halt and any halt will be applicable other fit vehicle will be provided immediately to avoid of important duties.

(xii) Contractor shall detail CHT with vehicle of manufacturing year 2022 and later with BS-VI norms compliance with good condition and white color for duty.

(xiv) In case of requirement of vehicle on Sunday/holiday due to any inspection/official visit or any official requirement, contractor shall provide the CHT with out any extra cost and the same should be adjusted by giving off to the vehicle on any other working day.

Further, GeM reserves the right, at its sole discretion, to cancel the bid forthwith, without issuance of any prior notice or intimation :-

2. Mandating procurement of / from specific Brand / Make / Model / Manufacturer / Dealer except in case of Single Bid / Proprietary Article Certificate (PAC) Buying.

12. Buyer added ATC Clauses which are in contravention of clauses defined in bid detail section, including specifications, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by the applicable GeM GTC.
13. Any ATC clause in contravention with GeM GTC Clause 4 (xiii) (h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
14. In a category based bid, adding additional items, through buyer added, additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogues or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.
