If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price. 2. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price.

3. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

Dear Bidders, May please note that:-

1. This is case is on OEM/OES basis. Hence following shall be noted:-
 - i. Only OEM or authorised vendor of OEM with Tender specific authorisation is allowed to participate in the Bid. Others bid if any submitted shall be considered as non responsive and shall be summarily rejected.
 - ii. Subject GeM Bid has been floated on Original Equipment Manufacturer (OEM)/Original Equipment Supplier (OES) who has handled the Project Package of APCPL.
 - iii. OEM/OES for this GeM Bid are as below accordingly, OEM/ OES only are eligible to participate in this Bid.

- i. OEM is preferably requested to participate in the Bid directly without Channel Partner/ Dealer.
 - ii. - In case, OEM intends to participate through their authorized Dealer, then OEM shall issue a **Bid specific authorization in favour of authorized Dealer. General Authorisation letter is not acceptable.**
 - iii. - OEM shall nominate **only one dealer** against this GeM Bid. Multiple Dealer authorizations is strictly not permitted.
 - iv. - OEM authorized Dealer shall ensure to submit the Bid specific Authorization letter issued by OEM, along with their Bid documents.
 - v. - Bid Documents received without Bid specific Authorization letter shall be rejected. Further, if bid is received with general authorization letter, the same shall not be considered and their Bid summarily rejected. No claim, of whatsoever kind, shall be entertained later in this regard.

If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
