Note to Seller: Installation and Commissioning shall involve all the interconnections, any cabling between power source, switch boards within 3 metre range for input power and connecting Output power in the Scope of seller.

Note to Buyer: Buyer will ensure well ventilated/covered site/room having requisite power points/distribution board to provide input power to UPS as well as to take out power from UPS within 3 metre of the location of UPS placement.

Note: The above is indicative and any incidental requirement related to above responsibilities shall also be considered in the responsibilities of Buyer and Seller as applicable.

- 2.** The type of battery shall comply with the relevant BIS/IEC standard. ( IS 15549/IS 13369 for Lead Acid Batteries and IS 16046 (Part 2)/IEC 62133-2 for Lithium-Ion Batteries.)

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original

delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be  $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$ , subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

The bidder hereby submits the **attached PDF document** as an integral part of this bid. The document contains the **Buyback List of existing Batteries and Online UPS systems**, duly itemized for reference and evaluation by the competent authority.

# 2. Scope of Purchase Approval

The attached document also includes **purchase approval details for Online UPS systems and batteries**, clearly defined **branch-wise / location-wise**, as per the operational requirements and approvals accorded by the competent authority.

The procurement shall be limited strictly to the approved quantities and locations as mentioned in the enclosed document.

# 3. Technical Specifications

The **technical specifications** of the Online UPS systems along with the corresponding battery configurations are provided in the attached PDF and form an integral part of this tender. The specifications include, but are not limited to, the following capacities:

- **5 KVA Online UPS** with batteries, as per site-specific requirements
- **3 KVA Online UPS** with batteries, as per site-specific requirements

The bidder shall ensure that the offered equipment strictly conforms to the specifications mentioned. Any deviation may render the bid liable for rejection.

# 4. Buyback Terms

The buyback of existing UPS systems and batteries shall be carried out strictly in accordance with the **Buyback List** provided in the attached document. The bidder shall factor the buyback value as per the terms and conditions specified in the tender.

# 5. Compliance

The bidder is required to submit the bid with **full compliance** to the specifications, scope, and terms and conditions mentioned herein and in the attached document. Non-compliance with any clause of the tender may result in rejection of the bid without further correspondence.

# 6. Warranty Clause

The bidder shall provide a **minimum comprehensive on-site warranty of twenty-four (24) months** for both the **Online UPS systems and the associated batteries**, effective from the date of successful installation and commissioning at the respective locations.

The warranty shall cover all parts, labor, repairs, replacements, and corrective maintenance, without any additional cost to the purchaser, during the warranty period.

## 7. Exclusion of CAMC

It is expressly clarified that **Comprehensive Annual Maintenance Contract (CAMC) terms are excluded** from the scope of this tender. No CAMC obligations shall be implied or applicable beyond the warranty period unless explicitly agreed upon through a separate contract.

## 8. Terms and Conditions of the Bid

All **terms and conditions related to supply, installation, testing, commissioning, buyback, warranty, AM C (if applicable), and after-sales support** are detailed in the attached PDF. These terms and conditions shall be binding on the successful bidder and shall form an integral part of the contract.

5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
16. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or
