1. If the bidder is a Micro or Small Enterprise (MSE) as per latest orders issued by Ministry of MSME, the bidder shall be relaxed from the eligibility criteria of "Bidder Turnover" as defined above subject to meeting of quality and technical specifications. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$, subject to minimum of 30 days. 9) Loading/Unloading: Offer should be for Ordnance Factory Bhusawal. Unloading of Goods at OFBH premises will be done by the supplier.

10) Product Delivery: a) Each package/bags shall be suitable marked with identification marking to enable satisfactory reference with the corresponding Invoice and GeM contract number. Marking on Each package/bags must contain reference Invoice number. GeM contract number, Qty, Item description, Outer dimension, volume and gross weight in Units should as per contract. If identification marking on each package/bags is not available or not matching with reference Invoice Qty then firm is responsible delay to acceptance of material or for any short supply. b) Supplier must generate Physical Invoice Qty as per Lot wise Qty of stagger delivery period mention in respective contract. GeM invoice to be generated at time of delivery as per physical invoice Qty within delivery period. 11) Guarantee/Warranty: The stores supplied against the order shall be deemed to have been warranted by the contractor against deterioration/defective material and workmanship and performance for a period of 12 months from the date of receipt of stores at our end and any material found rejected/defective during the Guarantee/Warranty period, the same should be replaced free of cost.

12) Payment Terms: Payment terms shall be 100% payment through NEFT/RTGS only for accepted material within 30 days for the date of receipt of material or submission of bills/documents whichever is later.

13) Quantity Tolerance: Excess/short supplies not exceeding five percent of the original value of the contract.
