### 2. Service & Support

AVAILABILITY OF OFFICE OF SERVICE PROVIDER: An office of the Service Provider must be located in the state of Consignee. DOCUMENTARY EVIDENCE TO BE SUBMITTED.

### 3. **Generic**

**Bidder financial standing:** The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.

### 4. **Service & Support**

Dedicated /toll Free Telephone No. for Service Support : BIDDER/OEM must have Dedicated/toll Free Telephone No. for Service Support.

### 5. **Generic**

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 50 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 50 percent. Bidders are bound to accept the revised quantity or duration.

### 6. **Payment**

**PAYMENT OF SALARIES AND WAGES:** Service Provider is required to pay Salaries / wages of contracted staff deployed at buyer location first i.e. on their own and then claim payment from Buyer alongwith all statutory documents like, PF, ESIC etc. as well as the bank statement of payment done to staff.

### 7. **Certificates**

Additional terms and conditions for hiring of manpower

1. The bidder should have one office in Bhopal (M.P.) (Proof submitted)
2. The bidder should have solely in the business of supply of manpower.
3. Clearance of bills can be delayed for 3-4 months due to non-availability of funds. the bidder should be financially strong to pay the monthly wages to their employees in time (within 7th day of subsequent month) . Declaration of the same must be submitted by the vendor.
4. While generating invoice in GeM Portal, the seller must upload scanned copy of GST invoice and the screenshot of GST Portal confirming payment of GST portal.
5. The bidder must have ISO CERTIFICATE 9001.
6. The bidder must be registered with GST, EPFO, and ESIC Documentary evidence must be uploaded.
7. Successful bidder will provide uniform to once in a year at his own cost.
8. Successful bidder will provide the Identity Cards to the deployed personnel.
9. Successful bidder will provide Police Verification report of required personnel before deployment.
10. TDS and GST deducted at the rate applicable.
11. Bidder quoting Administrative/Service charges below 5% will not be entertained and summarily rejected.
