as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. **E. Conflict of interest among bidders: (Bidder shall submit self-declaration in the ANNEXURE - D enclosed)**

A bidder shall not have a conflict of interest with other bidders. Such conflict of interest can lead to anti-competitive practices to the detriment of Procuring Entity's interests. **The bidder found to have a conflict of interest shall be disqualified.** A bidder may be considered to have a conflict of interest with one or more parties in this bidding process, if:

- i. they have controlling partner (s) in common; **or**
- ii. they receive or have received any direct or indirect subsidy/ financial stake from any of them; **or**
- iii. they have the same legal representative/agent for purposes of this bid; **or**
- iv. they have relationship with each other, directly or through common third parties, that puts them in a position to have access to information about or influence on the bid of another Bidder; **or**
- v. Bidder participates in more than one bid in this bidding process. Participation by a Bidder in more than one Bid will result in the disqualification of all bids in which the parties are involved. However, this does not limit the inclusion of the components/ sub-assembly/ Assemblies from one bidding manufacturer in more than one bid; **or**
- vi. In cases of agents quoting in offshore procurements, on behalf of their principal manufacturers, one agent cannot represent two manufacturers or quote on their behalf in a particular tender enquiry. One manufacturer can also authorise only one agent/dealer. There can be only one bid from the following:
  1. The principal manufacturer directly or through one Indian agent on his behalf; **and**
  2. Indian/foreign agent on behalf of only one principal; **or**
- vii. A Bidder or any of its affiliates participated as a consultant in the preparation of the design or technical specifications of the contract that is the subject of the Bid; **or**
- viii. In case of a holding company having more than one independently manufacturing units, or more than one unit having common business ownership/management, only one unit should quote. Similar restrictions would apply to closely related sister companies. Bidders must proactively declare such sister/ common business/ management units in same/ similar line of business

**F. Samples:**

In case of bagging orders, new Suppliers (those not supplied the items covered in this tender to BHEL, Trichy against material group "CPFOF" shall necessarily submit **10 Nos. of each item** ordered as sample(s) from the ordered PO quantities along with required quality documents within **8 weeks** from date of PO for clearance. Bulk dispatches shall be done only after sample clearance. Due delivery date extensions, to extent of time taken for clearance, shall be provided for bulk quantities only if samples are submitted within the stipulated period.

**G. On-site assessment:**

BHEL reserves the right to conduct an on-site/ remote assessment (if required) for evaluation of qualified bidder after due intimation.

#### **H. Intimation of changes:**

Supplier shall duly inform BHEL about any changes to already existing location, company's constitution, ownership etc., and request BHEL along with applicable documents and/ or records for updating records after due review and evaluation (if necessary) for continuation of enlistment status with BHEL.

#### **I. Validity of certificates:**

As vendor registration requires QMS certification as minimum, the vendor/ bidder must ensure that their certifications remain valid throughout the contract duration or until they cease being a PMD vendor. Any changes, including renewals, loss of certifications, or modifications to qualifications, must be promptly notified to BHEL within 3 days, accompanied by the latest supporting documentation.

#### **J. Scheduled Delivery date:**

In general, the scheduled delivery date will be same in GeM contract and corresponding BHEL PO. Beyond the scheduled delivery date, even if the delivery date in GeM contract is extended for reasons pertaining to GeM portal, only the delivery date mentioned in BHEL PO will stand valid for all reasons including calculation of LD, unless notified otherwise

#### **K. Collection of rejected items:**

Items rejected during receipt/ usage shall be collected by the supplier from time to time by producing applicable credit note at BHEL Stores. Subsequently, replacements for rejected items and quantities shall be supplied.

#### **L. Invoice submission:**
