4. The Bidder is required to quote their total Contract Price (Inclusive of all taxes & duties & including GST) as per the price break up sheet attached on lump-sum basis on GeM portal for entire scope of work. **The price break-up sheet to be attached with price bid only and not along with technical bid documents.**
5. Bidder has to mandatorily indicate GST (%) and associated HSN/SAC as applicable seven (7) days prior to last date of Bid Submission in the Price break up sheet **along with Price bid**.
6. Submission of bid on GeM Portal shall be deemed as bidder's unconditional acceptance to all the following Attributes:
 - i. 8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
