### **1. Submission of Relevant Documents**

The bidder shall upload only those documents which are relevant to the bid requirements. Submission of any irrelevant or extraneous document during technical evaluation shall be at the sole risk and responsibility of the bidder and such bid shall be liable for rejection.

### **2. Notarized Affidavit**

The bidder shall submit a single notarized affidavit on Non-Judicial e-Stamp Paper of ₹100/- containing the following declarations:

- a) The bidder is neither under liquidation nor has been blacklisted by any Central Government / State Government / PSU / Autonomous Body / Government Organization.
- b) All documents uploaded by the bidder in support of this bid are true, correct and genuine. The bidder shall be solely responsible for any incorrect, misleading or false information submitted.
- c) The bid has been submitted without any deviation and not as a part of any consortium or joint venture.

### **3. Debarment Clause**

In case any bidder resorts to frivolous, malicious or baseless complaints/allegations with an intent to hamper or delay the bidding process or attempts to canvass or influence the evaluation process, the Department reserves the right to debar such bidder from participation in the present and future bids of CGHS Bhopal for a period of one (01) year.

### **4. Corrigendum**

OEM Warranty certificates must be submitted by Successful Bidder at the time of delivery of Goods. The seller should guarantee the rectification of goods in case of any break down during the guarantee period. Seller should have well established Installation, Commissioning, Training, Troubleshooting and Maintenance Service group in INDIA for attending the after sales service. Details of Service Centres near consignee destinations are to be uploaded along with the bid.

**The Seller/ Service Providers shall, therefore, be responsible for ensuring compliance under:**

- **All notified and enforceable provisions of the new Labour Codes as mentioned hereinabove; and**
- **All operative provisions of the erstwhile Labour Laws until their complete substitution.**

**All obligations relating to wages, social security, safety, working conditions, industrial relations etc. and any other statutory requirements shall be strictly met by the Seller/ Service Provider. Any non-compliance shall constitute a breach of the contract and shall entitle the Buyer to take appropriate action in accordance with the contract and applicable law.**

While participating in bid, Bidder has to undertake compliance of this and any false declaration and non-compliance of this would be a ground for immediate termination of the contract and further legal action in accordance with the laws.
