1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

2. Payment

PAYMENT OF SALARIES AND WAGES: Service Provider is required to pay Salaries / wages of contracted staff deployed at buyer location first i.e. on their own and then claim payment from Buyer alongwith all statutory documents like, PF, ESIC etc. as well as the bank statement of payment done to staff.

3. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

4. Generic

1. The Seller shall not assign the Contract in whole or part without obtaining the prior written consent of buyer.
2. The Seller shall not sub-contract the Contract in whole or part to any entity without obtaining the prior written consent of buyer.
3. The Seller shall, notwithstanding the consent and assignment/sub-contract, remain jointly and severally liable and responsible to buyer together with the assignee/ sub-contractor, for and in respect of the due performance of the Contract and the Sellers obligations there under.

1. Qualification Requirement attached in ATC file of GeM bidding document.
2. Bidders should go through the bidding document to ascertain their scope of work and quote their prices accordingly.
3. Qualification of bidder will be based on meeting the minimum pass/fail criteria specified below regarding the Bidder's technical experience and financial position as demonstrated by the Bidder's responses in the corresponding Bid.

Qualifying Requirements

Technical experience and financial resources of any proposed subcontractor shall not be taken into account in determining the Bidder's compliance with the qualifying criteria.

The Employer may assess the capacity and capability of the bidder to successfully execute the scope of work covered under the package within the stipulated completion period. This assessment shall inter-alia include (i) document verification; (ii) details of works executed, works in hand, anticipated in future & the balance capacity available for the present scope of work; (iii) Past experience and performance: (iv) customer feedback; (v) Banker's feedback, etc.

1.0) Technical Experience:

The bidder must have successfully executed the '**Similar works**'# in PSUs/Government Departments/Government Autonomous bodies or any Public / Private sector unit as a prime Contractor * during last 07 years from the original date of bid opening.

Three Similar Works, each of not less than **Rs. 18.07 Lakh**

or

Two Similar Works, each of not less than **Rs. 22.59 Lakh**

or

One Similar Work of not less than **Rs. 36.14 Lakh**

Similar Work Shall mean "Housekeeping Services / Building Management Related Services (BMS) / Asset Management Services / Manpower Supply for Office Support function."

* In case of works executed under a contract that had been awarded on a Joint Venture, the experience of individual Joint Venture partner shall be considered limited to the scope of that partner under the said contract.

2.0) Financial Position:

The bidder must meet the following minimum criteria:

Minimum Average Annual Turnover* (MAAT) for best three years i.e., 36 months out of last five financial years (i.e. 2019-20, 2020-21, 2021-22, 2022-23 & 2023-24) of the bidder should be at least **Rs. 12.05 Lakh.**

*Note-1: Annual gross revenue from operations/gross operating income as incorporated in the profit & loss account excluding other operative income/other income.

Note-2: In case the bidder is a holding company, the financial position criteria referred to in clause above shall be of that holding company only (i.e., excluding its subsidiary/ group companies). Note-3: Relaxation For Start-ups^/MSE's

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
16. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
