If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. 9. **1. Generic**

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be  $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$ , subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

**2. Generic**

10. The furniture OEM shall have own research & design capabilities and must have achieved India Design Mark for at least 5 products designed by them in Tables, Chairs & Desk Category.

11. The furniture OEM shall have state of the art manufacturing plant having latest machinery to produce high quality products maintaining consistency. Proof of manufacturing plant to be attached.

12. All the certifications attached with technical bid shall be current & date of validity shall be mentioned clearly else it shall not be accepted.

13. The OEM shall be engaged in sustainable manufacturing practices like use of renewable energy sources & reduction of GHG (Greenhouse Gas) emissions. (GHG) emission report link of website to be submitted.

Immediately after receipt of PO, valid upto 60 days beyond warranty period The SD cum PBG is to be executed through Demand Draft/ Fixed Deposit Receipts or Bank

Guarantee (In the Name ACCOUNTS OFFICER, LEOS) issued by a Nationalized Bank/Scheduled Bank/any International Reputed Bank approved by Reserve Bank of India, Govt. of India as per our specimen. The SD cum PBG shall be executed on a Non-Judicial Stamp paper of appropriate value not less than Rs. 300/- In the case the supplier fails to furnish the SD cum PBG within 20 days or any extension thereof, the Purchase Order shall be cancelled or terminated and appropriate penal action shall be initiated.
