1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

2. Generic

- The Seller shall not assign the Contract in whole or part without obtaining the prior written consent of buyer.
- The Seller shall not sub-contract the Contract in whole or part to any entity without obtaining the prior

written consent of buyer.

3. The Seller shall, notwithstanding the consent and assignment/sub-contract, remain jointly and severally liable and responsible to buyer together with the assignee/ sub-contractor, for and in respect of the due performance of the Contract and the Sellers obligations there under.

3. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

SCOPE OF WORK

1. SERVICE: To execute printing, DTP works, design, layout, proof-reading and formatting of Achi evement Booklet of the Government of Assam along with logistical support for delivery of the Booklet as per specifications laid below and in stipulated time. The printed books will have to be supplied within 2 (two) days from issue of Work Order.

2. SPECIFICATION AND QUALITY: The printing materials to be supplied by the successful Bidder shall be of the best quality and shall comply with specifications and conditions specified below.

4. DELIVERY SCHEDULE: The items should be delivered within 2 (two) days from the date of issue of the Work Order.

1. The Bidder must be a reputed and registered 'A' category Printing Press based in Guwahati, Assam having minimum 5 (five) years of existence and experience and must possess a valid Registration Certificate under the Printing & Stationery department of the Government of Assam. *Copy to be enclosed.*
2. The bidder should have an average annual turnover of at least Rs. 80.00 lakhs in the last three financial years (i.e. 2022-23, 2023-24 and 2024-25) and must submit proof of same duly certified by CA in his letter pad.
3. The bidder must have a valid Permanent Account Number (PAN). *Copy to be enclosed.*
4. The bidder must be registered under GST and shall submit a copy of the GST Registration Certificate along with up-to-date GST return.
5. The bidder should have executed at least 1 (one) single printing work in Government / PS

U Sector in the last 3 (three) Financial Years for a minimum value of Rs 80 lakh. *Work orders and completion certificates to be enclosed.*

6. The bidder should have prior experience of executing at least one single bulk paper-based printing works of at least 10 lakh copies. *Work orders and completion certificates to be enclosed.*
7. The Bidder should have own creative professionals consisting of Graphic Designer, Layout Designer and Proof Reader working with them. *CVs/resumes along with official ID cards to be enclosed.*
8. The bidder should submit valid Trade License, PAN Card and GST Registration Certificate.
9. Proof of filing of Income Tax Returns for the last three (03) financial years must be furnished.
10. The bidder must have prior experience of working under DIPR, Assam in the last 5 years and supporting documents shall be submitted as proof.
11. Bidders shall have to upload previous experience of executing paper-based printing works along with Work Order and completion certificate.
12. An Affidavit in original (in non-judicial stamp paper of Rs. 100/-) that, the bidder is not under a declaration of Ineligibility/ Blacklisting by Govt of Assam, Govt of India or any other States for corrupt and fraudulent practices or for any other causes.
13. In absence of any of the above documents/ information, the Buyer may reject the bid without assigning any reason thereof.

Additional Documents

1. The Bidder shall have to mandatorily furnish, as part of this bid, an EMD of INR Rs. 4,20,000.00/- (Rupees Four Lakh Twenty Thousand only) along with the bid. The EMD to be submitted in the form of Demand Draft (DD)/ Fixed Deposit (FD) in favor of "DIPR, Assam" from Nationalized or commercial bank payable at Guwahati. *Non-submission of EMD will lead to rejection of bids.*
2. The bidder must submit proof of having minimum turnover of at least Rs. 80.00 lakh and above in each of the three financial years (2022-23, 2023-24 and 2024-25) duly certified by CA in his letter pad with valid UDIN.

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.

terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
