OPTION CLAUSE 50% : The buyer can increase or decrease the contract quantity or contract duration up to 50 percent at the time of issue of the contract. However, once the contract is issued, the contract quantity or contract duration can only be increased up to 50 percent. Bidders are bound to accept the revised quantity or duration.

For lumpsum-based service contracts, the buyer may increase the scope of work and contract value up to 50 percent with the consent of the service provider

BUYER'S ADDITIONAL TERMS AND CONDITIONS OF BID

(To be uploaded by bidder with proper sign and seal)

1. Bidders are advised to ensure that all the uploaded documents are clearly visible, readable and duly numbered failing which their technical/financial bid may be rejected;

i. Firm should have executed at least three Government work orders. Completion certificates issued by a competent authority shall be submitted by the bidder.

ii. The bidder shall upload the Average Annual Turnover certificate for the last three financial years issued by a certified Chartered Accountant or statutory authority along with PAN and GST clearance certificates of the firm.

iii. If the bidder submits any fake or forged documents, the department shall take legal action against the bidder or firm as per applicable Government rules. Undertaking as per GeM GFR Rule 149 must be submitted.

iv. The minimum turnover of the bidder for the last three financial years. The CA turnover certificate must contain a valid UDIN, failing which the bid shall be treated as non-compliant.

- v. Bid Security Declaration must be attached with the technical bid.
- vi. It is mandatory to submit an undertaking on the firm's letterhead for Liquidated Damages charges in case of delay in supply after award of contract.
- vii. The buyer reserves the right to accept or reject any or all bids without assigning any reason. All documents submitted must be latest and must clearly mention the bid number, bid date, bid title, and shall be duly signed and sealed on every page by the bidder.
- viii. The bidder must upload a valid and active OEM Authorization Letter, OEM turnover certificate/details, and catalogue/brochure clearly indicating compliance with the required technical parameters of the quoted item, including make, model, and product image.
- ix. Submission of EMD is mandatory. The bidder shall upload EMD details in the technical bid and submit the hard copy of EMD to the department before technical evaluation of the bid.
- x. It is mandatory for the bidder to have a service support office in Madhya Pradesh. Documentary evidence in this regard must be uploaded in the technical bid along with all mandatory documents.
- xi. The bidder shall provide OEM warranty of minimum 01 year on manufacturing defects, motor, gearbox, and electrical components from the date of installation/commissioning.
- xii. The bidder/OEM must provide installation, testing, commissioning, and operational training at consignee location without any extra cost.
- xiii. Only OEM or OEM-authorized bidders shall participate. Valid OEM Authorization Certificate specific to the bid/tender must be uploaded.
- xiv. Experience in similar items must be submitted by the firm along with all supporting documents. Failure to submit any required document shall result in rejection of the bid without assigning any reason.
- xv. The bidder must submit all documents and undertakings in all tenders as specified in the bid conditions.
- xvi. The bidder shall provide supporting documents demonstrating compliance with the BOQ specifications.
- xvii. A declaration regarding the financial standing of the bidder must be submitted on the firm's letterhead.
- xviii. Experience criteria require submission of three years of similar work experience. Copies of purchase orders received from the same Government Department during the last three financial years must be enclosed along with other required bid documents.
- xix. Bidder shall mandatorily inspect the installation site before submission of bid. A duly signed Site Visit Confirmation Certificate from the concerned departmental officer shall be uploaded with the technical bid. No claim regarding site conditions, logistics, or installation requirements shall be entertained later. Non-submission may lead to rejection of bid.
- xx. MSME registration certificate shall be submitted, if applicable.
- xxi. The bidder shall submit a notarized affidavit on Non-Judicial Stamp Paper of ₹100/ duly signed by the authorized signatory, stating that:
- a. The bidder has never been blacklisted/debarred by any Central Government/State Government Department, PSU, Autonomous Body, or Local Authority;
  - b. The bidder/OEM shall provide genuine and original products only;
  - c. The bidder shall provide after-sales service, installation, commissioning, and warranty support;
  - d. All information/documents submitted in the bid are true and authentic;
  - e. In case any information is found false, the buyer shall have the right to reject the bid and forfeit EMD/security deposit.
- xxii. The OEM shall submit a self-certification/manufacturing declaration on company letterhead confirming that the offered product is manufactured/assembled by the OEM and spare parts/service support shall remain available for minimum 05 years.

xxiii. The bidder/OEM shall submit an undertaking on company letterhead confirming availability of service engineer and complaint resolution within 48 hours of complaint during warranty period.

The Buyer, is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any restriction arising in the bidding process due to these ATCs and including the modification of technical specifications and / or terms and conditions governing the bid. All representations / grievances pertaining to the ATC clauses shall be raised with the buyer organization directly and not with GeM. If any of the clause(s) is/are incorporated by the Buyer regarding the following, the bid & resultant contract shall be treated as null & void. Further, GeM reserves the right, at its sole discretion, to cancel the bid forthwith, without issuance of any prior notice or intimation :-

1. Publishing Custom / BOQ bids for items for which regular GeM categories are available (unless such Custom / BOQ item is bunched with the major regular product Category Item).
2. Mandating procurement of / from specific Brand / Make / Model / Manufacturer / Dealer except in case of Single Bid / Proprietary Article Certificate (PAC) Buying.
3. Inclusion of disqualification criteria related to suspension of seller / service provider, where such suspension period has already expired.
4. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.

14. In a category based bid, adding additional items, through buyer added, additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogues or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
