Safety Glass for Road Transport Marked to IS 2553 (Part 2)

Note to Buyers:

1. This category is designated for the procurement of "Safety Glass for Road Transport as per IS 2553 (Part 2) category is "BID ONLY" and procurement will occur exclusively through the bidding process as key technical specifications like dimensions (length, width, thickness), the type of vehicle, model of vehicle, etc are to be de the buyer in the bid as per his operational requirements. The IS 2553 (Part 2) does not prescribe fixed dimens safety glass as these vary depending on the vehicle type. The buyer shall refer the IS for performance require and tolerances.

2. The Central Ministries/ Departments and other government buyers, as applicable, shall note that this categ covered under Scheme - I (ISI Mark Scheme) of BIS (Bureau of Indian Standards).

Compulsory use of Standard Mark - Goods or articles shall conform to the corresponding Indian Standard and the Standard Mark under a license from the Bureau as per Scheme-1 of Schedule-II of the Bureau of Indian St (Conformity Assessment) Regulations, 2018:

Buyer shall verify and confirm compliance with the applicable BIS order during the procurement and fulfillmer

Note to Sellers:

1. Sellers shall offer and supply products conforming to the corresponding Indian Standard and bear the Stanc under a license from the Bureau as per Scheme-1.

12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be
