Buyer Added text based ATC clauses

1. Site inspection is mandatory for this bid and shall be permitted only on working days during the institute 's working hours (9:30 AM to 5:30 PM). The institute will remain closed on public holidays, Saturdays, and Sundays.

2. The bidder visiting IIIT Nagpur for the site inspection of this GeM bid shall present undertaking document for site inspection (as per format Annexure - V attached in the bid) on their official letterhead, including valid contact details such as email, mobile/phone number, and address. The document must be duly signed with proper Seal by the authorized signatory.

3. Uploading the Site Visit Certification, duly sealed and signed by IIIT Nagpur's authorized signatory, is mandatory. Non-compliance with this requirement shall lead to the outright rejection of the bid.

4. Bidder shall require to provide complete One (1) Year Comprehensive maintenance of the above-mentioned Alkaline RO Water purification system including complete work.

5. The one (1) year comprehensive maintenance period shall commence only upon obtaining the successful installation and commissioning certificate of the system from the competent authority of IIIT Nagpur.

6. During the Comprehensive Maintenance Contract (CMC) period of one (1) year, the successful bidder shall ensure uninterrupted operation of the complete Alkaline RO Water Purification System, including RO plants, storage tanks, pumps, pipelines, sensors, communication modules, web dashboard, electrical systems, valves, and all associated accessories supplied under the contract.

- a. The contractor shall attend all complaints within 4 hours from the time of reporting by the Institute.
- b. Any breakdown affecting water supply shall be rectified within 8 hours from the time of complaint registration.
- c. In case the fault is not rectified within 8 hours, a penalty of Rs. 1,000/- per hour shall be levied, subject to a maximum of 5% of the total contract value.
- d. Any major component requiring replacement during the CMC period shall be replaced within four (4) calendar days from the date of reporting by IIIT Nagpur.

Failure to replace the component within the stipulated period shall attract a penalty of Rs. 5,000/- per day until the system is restored to normal operation.

The service provider shall make suitable temporary arrangements, at no additional cost to IIIT Nagpur, to ensure uninterrupted supply of potable drinking water during the replacement period. Failure to do so shall also attract the above penalty.

- e. Water quality parameters such as TDS, pH, and microbiological safety shall be maintained as per applicable BIS drinking water standards. In case the supplied water is found unsuitable for drinking due to negligence of maintenance, the Institute may impose a penalty up to Rs. 10,000/- per insta

nce, in addition to directing immediate corrective action.

- f. All consumables, spare parts, membranes, filters, UV lamps, sensors, dosing systems, communication modules, and accessories required for maintaining the system in satisfactory working condition during the CMC period shall be provided by the contractor at no additional cost to the Institute.
- g. The decision of the Director, IIT Nagpur regarding assessment and recovery of penalties shall be final and binding on the contractor.

13. Any ATC clause in contravention with GeM GTC Clause 4 (xiii) (h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
14. In a category based bid, adding additional items, through buyer added, additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogues or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller.
