Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

### 1. Generic

OPTION CLAUSE 50% : The buyer can increase or decrease the contract quantity or contract duration up to 50 percent at the time of issue of the contract. However, once the contract is issued, the contract quantity or contract duration can only be increased up to 50 percent. Bidders are bound to accept the revised quantity or duration.

For lumpsum-based service contracts, the buyer may increase the scope of work and contract value up to 50 percent with the consent of the service provider

2. Provisions for workmen compensation, insurance, public liability, property damage, insurance etc. to be ensured by the contractor. Also, safety measures prescribed for working in Extra High Voltage & use of personnel protective equipment must be adhered to.

3. **Buyer Added Bid Specific ATC**

1. Bid Contract Period : Three years. Initial contract will be awarded for one year. However, the contract will be extended on the yearly basis subject to satisfactory report and mutual consent.

2. The buyer can terminate the contract at any point of time during the contract period without as signing any reason and the bidder has to accept the same without raising any query.

3. Turnover : The Average Annual Turnover of the bidder should not be less than Rs. 130.00 lakhs . Only CA (Chartered Accountant) certificate will be considered. No extra documents required to upload.
